THE FEDERAL MILITARY GOVERNMENT hereby decrees as follows:—

- 1. Section 3 of the Customs Tariff Act 1965 is amended by renumbering the section as subsection (1) and by inserting thereafter as subsections (2)
 - "(2) In addition to import duty where shown to be chargeable under subsection (1) above, there shall unless exempted under the next succeeding subsection, be payable a reconstruction surcharge at the rate of five per centum.
 - (3) The provisions of subsection (2) above shall not apply—
 (a) to goods imported at specially reduced rates by approved manufacturers and users, or
 - (b) to the following tariff items in schedule 1 to this Act that is to say-
