UNIVERSITY OF LAGOS DECREE 1967 (1967 No. 3)

INSTRUMENT OF APPOINTMENT

OF DR SABURI OLADENI BIOBAKU, C.M.G., M.A. (CANTAB), Ph.D. (LONDON)



By His Excellency Major-General YAKUBU GOWON, Head of the Federal Military Government, Commander-in-Chief of the Armed Forces of the Federal Republic of Nigeria.

WHEREAS by paragraph 4 (1) of Schedule 1 to the University of Lagos Decree 1967, it is provided that the first Vice-Chancellor of the University as reconstituted by the Decree shall be SABURI OLADENI BIOBAKU, Companion of the Distinguished Order of St. Michael and St. George, Master of Arts and Doctor of Philosophy:

AND WHEREAS it is expedient that provisions should be made for his tenure of office and for terms as to the emoluments of his office and otherwise:

NOW THEREFORE, it is provided that the said Saburi Oladeni Biobaku (hereinafter referred to as "the Appointee") shall hold the office of the Vice-Chancellor of the University of Lagos upon the following terms and conditions:—

1. The Appointee will be responsible to the Council of the University of Lagos (hereinafter referred to as "the Council") or its successor for the performance of his duties.

2. The appointment will be a whole time appointment and the Appointee shall reside in a house provided by the University rent free, all furnishings, linen, crockery, cutlery, domestic staff, etc., provided by the University. The electricity accounts shall be paid by the University.

3. The appointment shall be for five years with effect from 1st April, 1967, being the commencement date of the University of Lagos Decree 1967.

4. The Appointee's salary shall be at the rate of £4,250 per annum.

5. The Appointee shall be entitled to the benefits of any scheme for allowances including children's allowance for up to 3 children normally not more than 16 years old, at the rate of £50 a year for each child resident in Nigeria or £100 a year for each child resident elsewhere.

6. The Appointee shall be entitled to an entertainment allowance of £500 per annum, payable monthly, tax free; and shall be free to claim in addition under the University's 'Official Hospitality' vote for special dinners, cocktail parties, etc., at a rate of £0-10s-6d per head for a cocktail party, and one guinea per head for a special dinner.

7. The Appointee shall be entitled to have official transport.

8. The conditions as to Superannuation will be those from time to time prevailing in a scheme approved by the University of which the Appointee will be required to be a member.

9. A first class air or first class sea passage will be provided on first appointment for the Appointee, his wife and up to 5 children if then resident outside Nigeria, subject to the regulations made from time to time by the Council of the University with regard to passage on appointment.

10. When proceeding on and returning from leave, first class air or first class sea passage will be provided for the Appointee, his wife and up to five children, subject to the regulations made from time to time by the Council of the University with regard to leave passages.

11. The Appointee shall not terminate his appointment without having given to the Council six months' notice in writing of his intention to do so, unless the consent of the Council be otherwise obtained.

12. Subject to the provisions of paragraph 13 below, the Council shall not terminate the appointment of the Appointee without having given him six months' notice in writing of its intention to do so, or having tendered to the Appointee payment of six months' salary in lieu of notice. In the case of notice already given, the Council may tender payment of the amount of salary applicable to the period of notice unexpired and, upon its doing so, the appointment of the Appointee shall determine immediately.

13. Should the Appointee be convicted of a criminal offence involving moral turpitude or, in relation to his duties to the University, be found guilty of misconduct, gross inefficiency, or wilful refusal to fulfil his duties, or become incapable, by reason of general inefficiency and any infirmity of mind or body, thus rendering it impracticable for him to continue in office, then the Council may remove the Appointee from office and the period of notice necessary to terminate the appointment shall be at the discretion of the Council.

14. Before any removal of the Appointee is made as provided in paragraph 13, the Senate of the University shall be consulted by the Council and the Appointee shall have an opportunity of replying to the grounds alleged against him.

15. While in Nigeria free medical attention will be provided for the Appointee and his family (*i.e.*, his wife and children) and hospital accommodation will be provided at a reduced charge.

NOTICE BY THE BOARD OF CUSTOMS AND EXCISE

Customs and Excise Notice No. 7

TRANSIT TRADE

Commencement : 18th November, 1968

In exercise of the power conferred upon the Board of Customs and Excise, and without prejudice to the Niger Transit Act and any regulations made thereunder, the following directions are issued in respect of goods and vessels in transit through Nigeria in accordance with the provisions of sections 23, 25, 39, 48 and 55 of the Customs and Excise Management Act, No. 55 of 1958.

I.—GOODS IN TRANSIT

(a) *Definition.*—Imported goods which are reported in transit at an approved port or place and which are entered by the owner or his agent as in transit through Nigeria by an approved route prior to their release from Customs control, shall be deemed to be goods in transit.

(b) *Approved Ports and Places.*—The following are approved ports and places for entry of goods in transit :—

(i) *Customs Port* : Burutu, Calabar, Lagos, Port Harcourt and Warri.

(ii) *Customs Stations* : Ekang, Idiroko, Ikang, Kano, Maiduguri, Mfum and Yola.

(iii) Any other place, Customs port or Customs station which the Board may generally or in any particular case approve.

(c) *Approved Routes.*—The following are approved routes through which goods may be entered and carried in transit :—

(i) *To and from Dahomey*—

(1) by inland waters via Lagos and the Customs craft moored in the Porto Novo Creek near the boundary ;

(2) by road via Lagos and the Customs station at Idiroko.

(ii) *To and from Niger Republic.*—by the Nigerian Railway via Lagos or Port Harcourt and Kano or Maiduguri and thence by road through one of the following Customs stations at Babban Mutum, Jibiya and Kongolam.

(iii) *To and from Tchad Republic.*—

(1) by the Nigerian Railway via Lagos or Port Harcourt to Maiduguri and thence by road through the Customs station at Gambaru ;

(2) by the Nigerian Railway via Lagos or Port Harcourt and Jos, and thence by road through Maiduguri and the Customs station at Gambaru ;

(3) by road from Lagos or Port Harcourt through Maiduguri and the Customs station at Gambaru ;

(4) by River Niger from Burutu to Makurdi and by the Nigerian Railway via Jos to Maiduguri and thence by road through the Customs station at Gambaru.

(iv) *To and from Cameroun Republic.*—

(1) by inland waterways from Calabar through the Cross River to the Customs Station at Mfum ;

(2) by inland waterways from Calabar through the Customs station at Ikang ;

(3) by road from Calabar by the most direct route to the Customs station at Ekang ;

(4) by rail from Port Harcourt to Enugu and thence by the most direct route by road through the Customs station at Mfum;

(5) by the River Niger from Burutu (via Onitsha) to Yola and by the most direct route by road through Dalmare to Garoua;

(6) by road from Garoua through Dalmare and Yola to Onitsha and thence by the River Niger to Burutu or by road to Port Harcourt.

(v) *To and from other Foreign Territories.*—

(1) by the River Niger which term shall include all its affluents, branches and outlets in Nigeria;

(2) partly by the River Niger and partly by the Nigerian Railway;

(3) in the particular case of groundnuts moved in transit via Kano, the road routes—Kano to Lagos or Kano to Port Harcourt;

(4) by such other routes which the Board may generally or in any particular case approve.

3. *Pre-Entry.*—Goods in transit may be entered seven days prior to importation thereof or such lesser period as the Board may allow at any particular port or place by submission to the proper officer of an entry in the Form Sale 102—Transit Entry—in sextuplicate at Lagos and Port Harcourt and in quintuplicate at other approved ports and places. The quadruplicate copy of the transit entry duly endorsed with the particulars of release of the goods, will be returned to the owner or his agent for production with the goods to the officer at the station of exit in Nigeria.

4. *Goods not reported in transit may be so entered.*—At the discretion of the proper officer goods not reported as being in transit may be allowed to be entered in transit within one week of their arrival at one of the approved ports or places provided they have not been taken from Customs control.

5. Goods in transit shall not be entered for conveyance by inland waters in ships of less than one hundred tons register except with the written permission of the Board.

6. *Security.*—At the time of making entry for transit goods, the owner or his agent shall, except in the case of goods the property of the government of the territory to which the goods are consigned, give security either by deposit of the sum equal to the duties due or by bond in the Form Sale 26—Bond for Goods entered in Transit—or in the Form Sale 27—General Bond for goods entered in Transit—for the due exportation of the goods or their disposal otherwise to the satisfaction of the Board. In the case of goods not liable to import duty, security in a nominal sum sufficient to secure compliance with Customs requirements, will be required either by deposit or by bond.

7. *Carriage of Goods by Inland Waters.*—When goods are sent in transit by inland navigation via the River Niger or the Cross River the owner or his agent shall submit in duplicate to the proper officer at the place of entry a manifest in the Form C.45—Manifest of Goods in transit by Inland Navigation—and where the goods are sent via Porto Novo Creek a transire in the Form C.43—Coast-wise Transire—shall be submitted in duplicate. In both cases the proper officer will sign the original document and return it to the owner or his agent to accompany the goods and to be delivered to the officer at the place of exit.

8. *Carriage of Goods by Road.*—Where goods are carried in transit by road, such goods must be carried in special container type vans having fastenings which are capable of being officially wired and plumbed. Vans which have been loaded, locked and sealed are not to be opened at any place between the port or place of entry or loading and the place of exit except in case of accident or other emergency where a report is to be made to the proper officer at the earliest opportunity and a full account of the goods taken and thereafter the goods are transferred to another van which must also be sealed by the officer.

9. *Licensing and Exchange Control.*—Import and Export licences and form N.C.D.3 are not required for goods in transit. In the case of goods in transit from any part of the Scheduled Territories, however, documentary evidence must be produced showing that the exchange control Authority in the country of origin has approved shipment to the country of final destination.

10. *Administrative Fees.*—The following fees shall be paid on transit goods to cover administrative expenses:—

(a) *General Goods.*—two pence per package or three shillings and four pence per ton whichever is the less.

(b) *Agricultural Products outward bound from a place in West Africa to a place outside West Africa.*—One penny per package or one shilling and eight pence per ton whichever is the less.

Administrative fees are not payable in respect of Government goods.

11. *Examination of Goods.*—Transit goods are subject to the normal provisions relating to examination warehousing, appraisal and assessment of duty under the Customs Laws, and are to be produced to the proper officer at the port or place of importation and of exportation and at any point during the transit journey where this may be necessary, for such examination and verification as the officer may require.

12. *Securing of Goods and/or Locks.*—The Board may require goods in transit to be conveyed under Customs Lock or seal from the port or place of entry. Such goods shall be so stored in the conveying vehicles and vessels as to permit easy and complete inspection at any state of the transit journey, and the locks and seals are not to be broken by anyone except at the direction of an officer. If the locks or keys are accidentally broken a report of the fact shall be made to an officer of Customs and Excise at the earliest opportunity. Goods not subject to Customs control shall not be stored with transit goods.

13. *Repacking and Remarking.*—If it is necessary to repack or remark any goods in transit so that the original weight, amount, shape, size, numbering or marking is altered, the owner or his agent shall apply in writing to the proper officer of Customs at the nearest Customs port or station specifying the importation particulars of goods and a full description of the proposed repacking and remarking to be done. The officer, if satisfied, may grant the application and endorse all documents accompanying the goods accordingly.

14. *Diversion of Goods for Home Use.*—(a) Goods entered in transit may be allowed to be re-entered for home use or warehousing at any port of entry provided—

- (i) they are not prohibited under the Imports Prohibition Order, 1959 ;
- (ii) valid import licences are produced where goods are subject to licences ;
- and (iii) the goods are produced for examination by the proper officer.

(b) The owner or his agent shall pay the duty on the difference between the quantity acknowledged to the proper officer as removed in transit and the quantity produced to the proper officer at the place of exit.

15. *Proof of Exportation.*—The owner or his agent shall, within twelve months from the date of entry of any goods in transit, or such further time as the Board in any special case may allow, produce a certificate of landing signed by the Customs Authorities in the country to which the goods were consigned. Goods in respect of which no satisfactory proof of exportation is produced shall be deemed to have been consumed in Nigeria and the person who entered into bond in respect of such goods shall pay the duty as assessed by the officer. Where the duties on such goods were secured by a deposit, the deposit shall be taken as the duties of Customs.

Provided that satisfactory evidence of shipment on board an ocean-going vessel may, at the discretion of the Board, be deemed sufficient proof of exportation.

16. *Discharge of Bond or Refund of Deposit.*—The owner or his agent shall be released from any obligation entered into under bond, or be granted a refund of any deposit made, as the case may be, in respect of any goods for which satisfactory proof of exportation has been produced in accordance with paragraph 15.

II.—SHIPS IN TRANSIT

17. *Report on Arrival from Foreign.*—Ships arriving direct from foreign and proceeding to neighbouring territories via Porto Novo Creek, the River Niger-Benue or via Cross River shall report in the Form C.5—Ship's Inward Report—at

- (a) Lagos, in the case of traffic via Porto Novo Creek ;
- (b) at Burutu or Warri for traffic via Niger-Benue ; and
- (c) Calabar for traffic via the Cross River.

18. *Clearance.*—Whether in ballast or carrying any cargo, ships in transit shall be cleared in the Form C.46—Certificate of Clearance for a Vessel in Transit through Nigeria by Inland Navigation—at the port of report inwards and the directions contained in the preceding paragraphs of this Notice shall apply to them and to any goods carried.
