

## SURVEY CO-ORDINATION (AMENDMENT) DECREE 1968



## Decree No. 42

[ 16th August 1968 ]

THE FEDERAL MILITARY GOVERNMENT hereby decrees as follows :—

1. Section 1 of the Survey Co-ordination Act (which provides for the furnishing of certain information relating to survey work and, among other things, for the carrying out of certain additional operations) is hereby amended as follows, that is—

(a) in subsection (1), for the words beginning with “, not later” to the end of the words in bracket, there shall be substituted the following—

“given to the Director of Federal Surveys (hereafter in this Act referred to as “the Director”), not less than three months then next preceding the day on which the work commences, or such shorter period as the Director may allow,”

(b) in subsection (3), immediately after paragraph (a), there shall be inserted the following new paragraph—

“(aa) to process all aerial films in connection with the survey work in question in Nigeria, and submit them for examination before prints are made from them or before they are used for any purposes whatsoever;”

(c) in subsection (7)—

(i) in paragraphs (a) and (b), the words “with a length of ten miles or more” are respectively hereby repealed;

(ii) in paragraph (c), for the words “or any electronic means” to the end thereof, there shall be substituted the words “, any electronic or electromagnetic means;”;

(iii) for paragraph (d) thereof, there shall be substituted the following—

“(d) topographical or hydrographic surveys, triangulation and trilateration;”;

(iv) for paragraph (g) thereof there shall be substituted the following paragraph—

“(g) heighting of points by aneroid barometer, altimeter, hypsometer, airborne profile recorder or any airborne auxiliary equipment ;”.

2. This Decree may be cited as the Survey Co-ordination (Amendment) Decree 1968 and shall apply throughout the Federation.

THE FEDERAL MILITARY GOVERNMENT hereby decrees as follows :—

1. The Investigation of Assets (Public Officers and Other Persons) Decree 1968 is amended with effect from its commencement—

(a) in section 12 by omitting all words from “or under any enactment” up to and including the words “whatsoever done,” ;

(b) in section 14 (2) by inserting in paragraph (a) after the word “Decree” where it secondly occurs, the words “so however that the effect of this provision shall not affect any cause or matter pending before a court at the time of such repeal”.

2. This Decree may be cited as the Investigation of Assets (Public Officers and Other Persons) (Amendment) Decree 1968 and shall have effect as hereinbefore provided and apply throughout the Federation.
