## CUSTOMS TARIFF ACT 1965

(1965 No. 3)

## Customs Tariff (Duties and Exemptions) (No. 4) Order 1969

Commencement : 8th May 1969

In exercise of the powers conferred by section 7 of the Customs Tariff Act 1965, and of all other powers enabling it in that behalf, the Federal Executive Council hereby makes the following Order :—

1. Schedule 1 to the Customs Tariff Act 1965, as substituted by the Customs Tariff (Amendment) (No. 2) Decree 1968 (which Schedule *inter alia* prescribes a tariff description of goods imported and rate of import duty) and as thereafter amended, is hereby further amended to the extent set out in the Schedule to this Order.
