NOTICE BY THE BOARD OF CUSTOMS AND EXCISE

Customs and Excise Notice No. 13

THE ENTRY EX-SHIP OR EX-AIRCRAFT OF IMPORTED GOODS FOR HOME USE

Commencement 1st April, 1970

Note.—This Notice does not cover the following transactions each of which is covered by a separate Customs and Excise Notice—

- (a) delivery ex-warehouse (other than a Government Warehouse) for home use ;—(Customs and Excise Notice No. 10, G.N. 699/59).
- (b) importation by parcel post ;—(Customs and Excise Notice No. 20, G.N. 1173/60).
- (c) passengers' baggage ;—(Customs and Excise Notice No. 12, G.N. 701/59).
- (d) transit ;—(Customs and Excise Notice No. 7, G.N. 1603/68).
- (e) transshipment ;—(Customs and Excise Notice No. 6, G.N. 659/59).
- (f) Specimens of Forms mentioned in this Notice may be seen at any Custom House. Sale Forms are to be printed privately and are to conform with the specimens in size, colour and ink impression.

GENERAL

1. *Law.*—The Law governing the Entry Ex-ship or Ex-Aircraft of Imported Goods for Home Use is contained in sections 25 to 28 and sections 35 to 42 of the Customs and Excise Management Act No. 55 of 1958. The attention of importers and their agents and all others concerned is also drawn to section 142 of the same Act which prescribes penalties for false declarations on Entries.

2. *Purpose.*—This Notice contains the requirements of the Board of Customs and Excise in respect of the entry of goods ex-ship or ex-aircraft for home use, and is published under the authority of the Board for the information of importers, shipping companies and others concerned. Nothing appearing in this Notice is, in any way, to be presumed to amend the law.

3. *Definitions :*

(a) *Importer.*—An "importer" means any person to whom goods are consigned in Nigeria. In this Notice, any reference to the importer includes the agents ;

(b) *Overseas Buying Agent.*—An "overseas buying agent" includes a commission agent, a confirming house or any person or firm who executes orders on another person or firm overseas on behalf of an importer in Nigeria and includes persons employed by or in any way associated with the importer in Nigeria ;

(c) *Exporter.*—An "exporter" means a person or firm consigning the goods to the importer in Nigeria ;

(d) *Supplier.*—A "supplier" means the person or firm who supplies the goods to the foreign exporter ;

(e) *Associated Firms.*—An Importer and an overseas exporter are deemed to be associated if, whether directly or indirectly, either of them has any interest in the business or property of the other or both have a common interest in any business or property, or some third person has any interest in the business or property of both of them, and includes cases where :—

- (i) they are under common management ;
- (ii) one is a branch of the other ;
- (iii) one is a subsidiary of the other ;
- (iv) one is an overseas buying agent of the other ;
- (v) one or more directors are common to both ;
- (vi) the owners of the two businesses are members of the same family.

4. *Goods which may be entered on Air Consignment Note.*—Goods imported by air on which the assessed duty does not exceed £1 or whose C.I.F. and C value, if they are exempt from duty, does not exceed £60 per consignment, may normally be entered on a copy of the relevant air consignment note on which the importer or his agent has declared, and certified correct by his signature and the date, the following particulars :

- (a) C.I.F. and C value ;
- (b) Quantity (if goods are liable at specific rate only) ;
- (c) The tariff item number ;
- (d) Rate of duty ;
- (e) Amount of duty (if any).

5. *Form of entry.*—(a) Goods imported ex-ship or ex-aircraft for home use, except as in paragraph 4 above, are to be entered on Form Sale 42—Entry for Goods For Home Use.

(b) Where the importer is unable, by reason of insufficient documentary evidence, to deliver a perfect Entry, he may submit application in Form Sale 103—Bill of Sight—for physical examination of the goods before lodging Entry in Form Sale 42. (See also paragraph 32 and Annex "E").

6. *Number of Copies of Forms of Entry.*—(a) Entry is to be submitted in seven, eight, or nine copies as applicable. The particulars required on an Entry must be clearly, indelibly and fully completed on every copy, and any Entry which is not so prepared will be rejected.

(b) The 4th copy, which will be machine stamped, must be boldly marked diagonally across, in red, by the proprietor, either :—

(i) "For Exchange Control Purposes Only" where the transaction involves foreign exchange ; or

(ii) "Not valid for Foreign Exchange" where foreign exchange is not involved.

In the case of sub-paragraph (i) the copy will be handed over to the proprietor on production of documentary evidence from the port or airport authority that the goods have been delivered to the proprietor. In the case of sub-paragraph (ii), the copy will not be returned to the proprietor.

(c) The 5th copy, which will be machine-stamped, is the proprietor's official receipt and must be boldly marked diagonally across in red, by the proprietor "NOT FOR EXCHANGE CONTROL". Where the 5th copy is not so marked the whole set of Entry will be rejected.

(d) With the exception of the following :—

Goods consigned to Government Departments, Marketing Boards, Statutory Corporations and Diplomatic and other privileged persons and bodies ; a 6th copy of the Entry, conspicuously marked "For Inland Revenue", which will not be returned to the proprietor, is to be submitted.

(e) The 8th copy must be endorsed in red ink, by the proprietor "For Drawback Purposes Only" in the case of goods which are to be used for the manufacture of goods in Nigeria and re-exported.

(f) The 9th copy, to be returned to the proprietor, endorsed in red ink "For Import Duty Relief Purposes Only," is required for materials which are to be used in accordance with the Industrial Development (Import Duties Relief) Act, 1957 (No. 27 of 1957), and on which a refund will eventually be claimed.

(g) At ports, airports and stations where cash receipting machines are not in use, a receipt in Book C.305—Entry Receipt Books, is also issued.

7. *Value for duty.*—(a) The value for duty purposes is defined in the Second Schedule to the Customs and Excise Management Act, 1958 (No. 55 of 1958).

(b) Where no insurance has been taken out in respect of an importation, $1\frac{1}{2}$ per cent of the invoiced value is to be added in the case of importation by sea, and $\frac{1}{2}$ per cent in the case of importation by air.

8. *Free goods invoiced with dutiable goods.*—Where free goods appear on the same invoice as dutiable goods, they may be entered on the same form as, and beneath, the dutiable goods, provided they are clearly declared as free on the Entry.

9. *Conditionally Free Goods.*—In cases where exemption from duty is claimed under any paragraph of the Customs Tariff Act, 1965, No. 3, a declaration, signed by the declarant to the Entry, must be made in the form shown below.

"I hereby claim exemption from duty under the provisions of Paragraph..... of Schedule..... to the Customs Tariff Act on the goods covered by this Entry on the grounds that....." The grounds on which exemption is claimed must be clearly stated.

10. *Buying Commission.*—In calculating the value for purposes of duty, a buying commission of not less than 4 per cent of the f.o.b. (free on board) value must be included.

Note.—(1) This note to paragraph 10 is intended to be of assistance to Nigerian importers and overseas suppliers.

(2) Paragraph 10 prescribes the rate of buying commission to be included in the normal price for duty purposes of all goods imported into Nigeria which are liable to an *ad valorem* duty.

(3) The paragraph requires action more of the Nigerian importer than of the overseas supplier and it is warned that invoices prepared by overseas suppliers must not contain, as a result of this paragraph, any untrue or false statement which would constitute a contravention of the Customs and Excise Management Act, No. 55 of 1958.

(4) The effect of the paragraph is that :—

(a) Where no buying commission is charged by an overseas supplier or no such commission is shown on the relevant invoice, the importer is required, in preparing his Entry, to add four per cent buying commission (based on the f.o.b. value) to the dutiable value of the goods ;

(b) Where the buying commission charged by an overseas supplier or shown on the relevant invoices is less than four per cent of the f.o.b. value, the Nigerian importer is required to add, to the dutiable value declared on the Entry, an amount equal to the difference between the buying commission charged by the overseas supplier or shown on the relevant invoice and four per cent buying commission based on the f.o.b. value of the goods ;

(c) Where the buying commission charged by an overseas supplier or shown on the relevant invoice exceeds four per cent of the f.o.b. value, the Nigerian importer is required to include in the dutiable value on the Entry the whole of the buying commission so charged or shown.

11. *Trade Goods.*—are deemed to be goods imported by way of trade and include those goods which are :

(i) imported in pursuance of a contract of sale ;

(ii) imported on consignment ;

(iii) purchased by a private individual ; or

(iv) supplied by a parent company or associated firm for use by the importing firm.

(b) The following are, for the purpose of this Notice, excluded from the category of trade goods :—

- (i) passengers' baggage accepted as such by the Board ;
- (ii) bona fide gifts ;
- (iii) government and quasi-government importations ;
- (iv) small quantities of goods imported for personal use.

12. *Discounts which are not allowable.*—Discounts which are not allowable as deductions from value for duty purposes include :—

- (a) sample discount ;
- (b) pattern discount ;
- (c) discounts given for a special consideration (e.g., as a condition of there being no claim for breakages) ;
- (d) agency discounts ;
- (e) contingency discounts (e.g., dependent upon the turnover reached) ;
- (f) contingent freight rebate ;
- (g) unspecified discounts ;
- (h) discounts not freely available ;
- (i) buying commission.

13. *Allowable discounts.*—Below are enumerated the discounts which are normally allowable deductions in computing the statutory value for the purpose of assessing *ad valorem* duties :—

- (a) trade discount ;
- (b) quantity discount—if freely available ;
- (c) cash discount—if freely available ;
- (d) quality discount, e.g., for goods described as 'seconds' ;
- (e) Bank Commission ;
- (f) Export Discount ;
- (g) Non-assembly discount in respect of a motor vehicle imported in a completely knocked down condition and for assembly locally.

14. *Completion of forms of Entry.*—(a) All copies of Entries must be completed carefully, legibly and indelibly in type or manuscript in the English Language and as required by the various headings and columns on the forms, including, when necessary, the rent certificate on the reverse.

(b) The goods must be accurately described in accordance with the invoice description, amplified where necessary to make it clear what the goods are. The Import List item number must appear above the description of the goods, and be underlined.

(c) When the unit of quantity in the Import List differs from that on which duty is chargeable, the quantity of the goods must be declared separately in both units.

(d) The value, in legal currency of Nigeria and the amount of duty chargeable on each item on an Entry must be declared separately. Where goods are liable to alternative rates of duty, the Entry relating thereto shall show on the face thereof the amount of effective duty chargeable at the rate to which such goods are liable and the amount of duty chargeable at the ineffective alternative rate under the Heading "Alternative Calculation (No charge)" followed by a declaration by the importer as to the correctness thereof as follows :—

"I/We declare that the value, in Legal currency of Nigeria and the amount of duty chargeable at the higher rate to which the goods are liable have been shown on the face of the Entry."

(e) Erasures may not be made on an Entry, and any necessary correction is to be initialled and dated by the signatory to the Entry.

15. *Declaration on Entry.*—(a) The declaration on an Entry must be signed in full by :—

(i) if an individual

- (1) the actual importer ; or
- (2) a clerk exclusively in his employment if duly authorised in writing ;

(ii) If a private company or partnership

- (1) one of the partners ; or
- (2) a clerk solely in its employment if duly authorised in writing ;

(iii) if a limited company

- (1) any director or the secretary ; or
- (2) any other officer of the company if duly authorised in writing by a director or by the secretary ;
- (3) where the secretary and directors are resident abroad, the accredited head of the company's branch in Nigeria or any officer of the company duly authorised in writing by him ;

(iv) a licensed Customs Agent to whom the importer has given the necessary authority in writing to act as his agent for customs purposes or his duly authorised clerk. The signatory will designate himself accordingly on the Entry. A Licensed Customs Agent must also quote his current licence number and date.

(b) The authorities mentioned above are required under the provisions of Customs and Excise Notice No. 4—Licensing of Customs and Excise Agents and Authorisation of Agents—to complete Forms C.30—Authority for an employee to act as Agent or C.31—Authority for Customs Agent to Act, as appropriate and deliver them to the proper officer in the Custom House at the Port of importation. Any change in authorised signatories must be advised immediately to the port concerned.

(c) Copies of Entries may be initialled, or bear the facsimile stamp of the signature of the declarant.

16. Documents to be produced with Entry :

(a) *Invoices.*—With each set of import Entries are to be presented original and duplicate invoices covering all the goods contained in the Entry, and with each invoice a certificate of value and origin in the Form C. 16—"Certificate of Value and of Origin." The certificate of value may be a separate document or may be combined with the relevant invoice. Invoices are to show full details of:—

- (i) the unit and total prices of the goods consigned ;
- (ii) packing ;
- (iii) freight ;
- (iv) insurance ;
- (v) commissions (including head office, confirming house and buying commissions) ; and
- (vi) other charges.

Where the invoices do not show packing details, a packing list is also to be presented. Invoices are to be in the English Language or a translation in the English Language is to be provided and attached to the relevant invoices. All certificates of value and origin are to indicate clearly whether the exporter is the manufacturer or the supplier of the goods, and whether or not he is in any way associated with the importer. The original invoice is to be attached to the original Entry and the duplicate to the duplicate Entry.

(b) *Release Notes.*—A form of release note—Form Sale 12—Customs Release Note, is also to be attached to the Entry at the ports of Lagos (including Apapa), Port Harcourt and Koko and the Lagos and Kano Airports.

Note.—Port Harcourt Port is in the meantime not to be used by ships arriving direct from or bound direct for places outside Nigeria (see L.N. 49 of 1967).

17. *Additional Documentation for trade goods liable to Ad Valorem duty.*—(a) The following documents are to be presented in support of each Entry for trade goods:—

(i) For trade goods liable to *ad valorem* duty—two sets of each invoice necessary to trace the transaction back to the actual manufacturer of the goods ;

(ii) In addition to the foregoing, for all trade goods whether or not liable to duty—two sets of invoices from the exporter, accompanied as hitherto, by the normal Certificate of Value and Origin (*i.e.*, attested invoices), are to be produced.

(b) The importer is also required to certify the invoices or any evidence of value presented with the Entry. This certificate is to be given on one of the following forms as applicable—

(i) Form Sale 123—Declaration Regarding Goods Liable to *Ad Valorem* Duty—Certificate "A".

(ii) Form Sale 124—Declaration Regarding Goods Liable to *Ad Valorem* Duty—Certificate "B".

(iii) Form Sale 125—Declaration Regarding Goods Liable to *Ad Valorem* Duty—Certificate "C".

(c) The Certificate will vary in character, according to the type of importation as indicated below:—

Type of Importation	Type of Certificate
(i) Goods imported by an independent importer, <i>i.e.</i> , importer who is neither an agent, broker, distributor or concessionaire for the seller nor associated in business with him.	Form Sale 123—Certificate "A" (Annex B)
(ii) Goods imported by an importer who is either an agent, broker, distributor or concessionaire for the consignor, or is associated in business with him.	Form Sale 124—Certificate "B" (Annex C)
(iii) Goods for which a fixed value per unit has been notified to the importer by the Department of Customs and Excise.	Form Sale 125—Certificate "C" (Annex D)

18. *By whom declaration on Form Sale 123, 124 and 125 to be made.*—It is to be particularly noted that these declarations are to be made by either—

(a) the actual importer if an individual or by a person exclusively in the employment of the importer authorised in writing by him for the purpose ; or

(b) a partner in the case of partnership ; or

(c) a Director or the Secretary in the case of an incorporated company. Declarations are not to be made by a forwarding agent or a person merely authorised to make Entry of the goods on behalf of the importer. Authorisations by importers empowering employees to make declarations in Forms Sale 123, 124 and 125 are to be filed and retained by the proper Collector. A separate letter of authority is required from an importer for each port of importation.

19. *Use of Form Sale 123 for special importations.*—Where an Entry covers goods imported by an independent importer on purchase out-right from various consignors, and the particulars required in paragraphs 2 to 6 of the appropriate Form Sale 123—Declaration Regarding Goods Liable to *Ad Valorem* Duty (Certificate "A")—are the same for each consignment, a single Form Sale 123 may be accepted covering all the relative invoices, the form being completed in paragraph 3 to read "from the persons named on the invoices for the total amount.....". In all other cases, separate declarations are to be given in respect of each consignment.

20. *Deletions to be initialled.*—Every deletion of an item on any of the Forms is to be separately initialled by the declarant, but deletion of successive portions of the forms may be made by a single line in the shape of the letter "Z" initialled by the declarant at each end of the line.

21. *Goods from Hong Kong.*—Goods originating in Hong Kong are to be accompanied by a Certificate issued only by persons authorised by the Director, Commerce and Industry, Hong Kong. In the case of goods of Hong Kong origin re-exported to Nigeria from countries other than Hong Kong, a Certificate of Origin issued by a Bank or Chamber of Commerce in the country of re-export approved by the Director, Commerce and Industry, Hong Kong, may be accepted except for goods in transit or transhipment in the country of re-export for which the proper Certificate of Origin must be produced.

22. *Photostatic copies of invoices.*—Photostatic copies of invoices and certificates of value and origin will be accepted as 'duplicates', and photostatic copies may also be used in lieu of original manufacturers' or suppliers' invoices where such invoices are required as supporting documents under the provisions of paragraphs 16 and 17 above.

23. *Facsimile signatures.*—Facsimile signatures are acceptable on all invoices other than original exporters' invoices.

24. *Goods prohibited from importation except under licence.*—In addition to the documents specified in paragraphs 16 and 17 above, Entries for goods not specified in the Third Schedule to the Import Prohibitions Order, 1959, must be accompanied by the appropriate licences issued by the Import Licensing Authority, the identifying numbers of the licences being clearly endorsed beneath the relevant items on the Entries. (See also paragraph 21).

25. *Import Licence Control.*—Reference should be made to the current Legal Notice appearing in the Official Gazette for full information as to licensing requirements. In the case of goods covered by an Open General Licence, the letters, "O.G.L." and the number of the relevant licence must be declared beneath the item on the Entry. In the case of goods not covered by an O.G.L. a separate licence is required, the number and date being declared beneath the item on the Entry as for O.G.L.'s and, in addition, the licence itself must be produced with the Entry. Specific licences dated subsequent to the date of importation of the relevant goods may be rejected and the goods seized. Detailed information regarding the licensing of imports can be obtained from the Import Licensing Authority, Ministry of Trade.

26. *Presentation of Entries.*—Entries must be presented to the cashier at the Custom House at the port or place of final importation, together with all charges payable. A batch of Entries must be accompanied by a schedule, in duplicate, of the amount of money due on each Entry and the total amount tendered. One copy of the schedule will be stamped with the Entry numbers, signed by the cashier, and returned to the importer.

27. *Customs duty rates.*—Detailed information as to duty rates and exemptions will be found in the Customs Tariff Act 1965 obtainable from the Federal Government Printer. The rate of duty payable is that in force when the goods are entered and the duty paid. The amount of duty payable must be calculated to the penny, fractions of a penny being ignored.

28. *Payment of duty.*—Duties, rents and other charges due to Government in respect of imported goods must be paid to the cashier in notes or coins of legal tender in Nigeria, by cash or postal order, or by a satisfactorily guaranteed cheque drawn on a bank in Nigeria, unless special arrangements have been made for payment direct to a bank and production to Customs of the banker's receipt.

29. *Passed Entries.*—When an importer receives his own copy of an Entry it may be assumed that the original Entry has been passed, and that examination of the goods may now proceed.

30. *Queried Entries.*—Where an Entry is thought to have been incorrectly prepared, an Incorrect Entry Form will be issued by Customs to the importer. The Entry itself will not be returned. The importer is advised in his own interest to attend to such queries promptly to avoid delay in clearing his goods.

31. *Amount of duty in doubt.*—Where entered goods are detained pending a decision as to the rate and/or amount of duty payable, delivery may be effected by depositing with the cashier such sum of money as the proper officer may determine. The authority for the cashier to accept this deposit will be issued by the proper officer in writing and a Customs Receipt will be issued by the cashier.

32. *Bill of sight—Form Sale 103 (Annex "E")*

General.—(a) If the importer of any goods is, by reason of the absence of any or of sufficient documentary evidence concerning them, unable to deliver a perfect Entry to the Customs, he may deliver to the proper officer, in duplicate, a Bill of Sight—Form Sale 103—(see Annex 'E') which the proper officer may accept.

(b) A Bill of Sight will not be accepted by the proper officer, unless satisfactory documentary evidence of value such as order forms, price lists, *pro forma* invoices, sight draft, letter of credit and evidence of origin of the goods are produced to the proper officer.

(c) If a Bill of Sight is acceptable, the importer will be allowed to examine his goods in the presence of the proper officer who will endorse the result of his examination in the appropriate column on the Bill of Sight.

(d) After the endorsement of the Bill of Sight by the proper officer subsequent action will be as indicated below.

33. *Exempt goods and goods liable to specific rates of duty.*—Where the goods are found upon examination to be either exempt or liable at a specific rate of duty (not being merely an alternative rate), the original copy of the Bill of Sight will be returned to the importer who may then prepare and lodge a perfect Entry, duly supported by the Bill of Sight, with the cashier in the normal manner.

34. *Ad Valorem duty goods.*—Where the goods are found upon examination to be liable at an *ad valorem* rate of duty, the proper officer will assess the amount, for provisional payment of duty and return the Bill of Sight to the importer who will then prepare and lodge a perfect Entry in Form Sale 42—Import Entry for Home Use, endorsed as follows :

"I/We request delivery against provisional payment of duty under section 27 of the Customs and Excise Management Act number 55 of 1958."

The Entry is to be supported by the Bill of Sight.

35. *Adjustment of provisional payment.*—Adjustment of any payment made under the provisions of paragraph 34 will not be made unless the importer, within three months of making such payment, presents to the proper officer a properly completed Form C.57—Application for a Refund of Duty and Certificate of Over Entry—in triplicate, supported by such documentary evidence as may be required.

36. *Rent.*—(a) *Customs area rent* is payable at the rates shown below on all goods imported by sea for home use and deposited in any of the following Custom Areas :—

Government Wharf, Sapele
Government Wharf, Degema (suspended by L.N. 49/67)
Government Wharf, Koko.

For rent purposes :—

- (i) a ton is reckoned at 40 cubic feet ;
- (ii) fractions of a ton must be rounded up to the next tenth of a ton and charged proportionately ;
- (iii) measurements are to be taken to the nearest foot, six inches and over being taken as a foot ;
- (iv) goods of a like kind in similar packages and forming part of one consignment may be assessed for rent on the cubic capacity of the packages as a whole.

MISCELLANEOUS

37. *Post entry.*—A post Entry must be submitted in respect of all underpayments exceeding £5. Such post Entry must be prepared in all respects in accordance with the direction in the previous paragraphs, so far as applicable, and, in addition, must :—

- (a) bear a cross-reference to the original Entry upon which duty was paid ; and
- (b) be supported by the relevant notice of underpayment, Form C.119 ; and
- (c) bear a recapitulation account giving details of the actual goods landed, the quantity or amount entered, and the extent to which the goods had been under-declared and the amount of duty underpaid.

Post Entries are not required in respect of underpayments of £5 or less which may be adjusted upon payment of the duty due and for which a Customs Receipt will be issued.

38. *Certified Entry.*—A certified Entry may be submitted for goods previously entered but short-landed from one ship or aircraft and subsequently landed from another. Such certified Entry must, as far as possible, be prepared in accordance with the directions for a perfect Entry, except that the invoice required by paragraph 16 may be a certified copy, and all copies of the Entry must be clearly marked in red ink across the face with the words "Certified Entry". Each Entry to be certified must bear on the face a signed declaration in one of the following forms, as may be appropriate :—

"I declare that duty amounting to.....
(in words and figures)

has been paid as per duty Entry No.....

per.....
(name of ship or aircraft)

no refund of the duty paid has been or will be claimed by, or paid to me or on my behalf" ; or

"I declare that the goods covered by this Entry were previously entered to Entry No.....

dated.....per.....
(name of ship or aircraft)

but were not imported thereon".

39. *Presentation of Entry prior to Importation of Goods.*—(a) Entries will be accepted by the cashier up to a maximum period of seven days prior to the estimated date of arrival of the importing ship or aircraft in respect of the class of imported goods listed in paragraph 40.

(b) The actual period of the concession will be that allowed by the Board for the particular place concerned.

40. *Direct Discharge of Special Goods into Lorries and Wagons.*—(a) In order to relieve congestion at Ports, the goods listed below may be discharged direct into lorries or wagons—

- (i) Animals and birds—live
 - (ii) Arms, ammunition, explosives, etc. (Entry must be lodged before discharge from vessels)
 - (iii) Salt
 - (iv) Sugar (in bags or cartons)
 - (v) Milk
 - (vi) Stockfish
 - (vii) Gypsum
 - (viii) Cement and Cement Clinker
 - (ix) Wheat Flour
 - (x) Cereals
 - (xi) Jute bags
 - (xii) Fertilizers
 - (xiii) Malt
 - (xiv) Nescafe
 - (xv) Bulk iron and steel products
 - (xvi) Bank and other currency notes (under strict security arrangements by the Police)
 - (xvii) Corpse (an application in form of a letter is sufficient)
 - (xviii) Frozen food including fish
 - (xix) Radio-active materials
 - (xx) Strategic Importations.
- (b) This concession is subject to the following conditions—that
- (i) The importer applies for the concession ;
 - (ii) The goods are pre-entered as required by paragraph 41 ; and
 - (iii) Import Licence is produced, where applicable.

Where the concession is granted the Nigerian Ports Authority must produce 10 per cent of the consignment for normal physical examination and other formalities.

41. *Board may withdraw concession.*—The Board reserves the right to withdraw the concessions in paragraphs 39 and 40 at any time and without notice.

42. *Further information.*—Notes on the special requirements in respect of Entries for particular kinds of goods are as at Annex "A".

43. *Warning.*—A CUSTOMS ENTRY IS A LEGAL DOCUMENT, AND HEAVY PENALTIES MAY BE INFLICTED IF ANY ENTRY OR SUPPORTING DOCUMENT IS FOUND TO BE FALSE OR INCORRECT IN ANY MATERIAL PARTICULAR.

44. *THIS NOTICE.*—(a) On commencement replaces Government Notice No. 702 of 1st April, 1959 and Government Notice No. 1467 of 1958 ;

(b) Introduces, in place of certification on invoices by Approved Banks and Chambers of Commerce new certificates of values—Forms Sale 123, 124, 125 to be completed by the importer or his authorised employee (not agent) in support of invoiced values.

ANNEX "A"

NOTES ON THE PREPARATION OF ENTRIES FOR PARTICULAR TYPES OF GOODS

1. *Live animals (except dogs and cats).*—Entries for horses, mules, donkeys, cattle, sheep, goats and swine must be accompanied by a valid permit issued by the Director of Veterinary Services.

2. *Arms and Ammunition.*—Proper Entry must be made before discharge from the importing vessel can be allowed. Such Entry must be supported by:

(a) a licence issued by the Import Licensing Authority; and

(b) a licence in form 15 issued in accordance with the Firearms Act and Regulations and signed by an authorised police officer.

3. *Beer.*—Entries for beer must contain a declaration of original gravity of brewing, and in the case of blended beer, the calculated original gravity. Supporting invoices should also give this information.

4. *Auto Gas Oil.*—Under the provisions of the Revenue Allocation (Motor Spirit and Diesel Oil Returns) Reg., 1959 (Legal Notice No. 116 of 1959), registered importers are required to render returns in accordance with Government Notice No. 1281 (Customs and Excise Notice No. 19) of 1959. Entry for this commodity may not contain particulars of goods of any other description.

5. *Live Birds.*—Entries for domestic fowl, duck, turkey and guinea fowl must be accompanied by a certificate signed by a veterinary surgeon stating that the birds concerned come from healthy stock, free of bacillary white diarrhoea, fowl typhoid and avian tuberculosis. The eggs of these birds also require similar certificates if imported for hatching.

6. *Diesel Oil.*—Under the provisions of the Revenue Allocation (Motor Spirit and Diesel Oil Returns) Reg., 1959 (Legal Notice No. 116 of 1959), registered importers are required to render returns in accordance with Government Notice No. 1281 (Customs and Excise Notice No. 19) of 1959. Entry for this commodity may not contain particulars of goods of any other description.

7. *Dogs and Cats.*—A valid certificate, signed by a veterinary officer in the country of origin to the effect that the animal is healthy and has not within the six months prior to importation been exposed to infection by rabies, is necessary except in the case of imports from the British Isles.

8. *Dangerous Drugs.*—Entries must be accompanied by a valid import authorization signed by the Chief Medical Adviser to the Federal Government of Nigeria.

9. *Explosives, including Fireworks.*—Entry must be made before discharge from the importing vessel.

10. *Gold (Raw).*—Entry must be supported by a declaration in form B as specified in the schedule to the Gold Trading Act.

11. *Medical Preparations, Anaesthetics, Dressings, Medicines and Drugs.*—(a) Exemption from import duty of the above goods is limited to importation by the Government of the Federation which is to be interpreted to include:

(i) The State Governments

(ii) Statutory Corporations

(iii) Local Councils

(iv) University Teaching Hospitals.

(b) The goods are to be entered by the consignee itself (i.e., as shown in sub-paragraph (a) (i) to (iv)), and the Entry signed by an employee of the consignee. The goods may also be entered by the Government Coastal Agency where appropriate or by a licensed Customs Agents duly authorised by the consignee, or, in special circumstances to be approved by the proper Chief Collector, by a Chemist and Druggist holding a current Government licence for the practice of his profession provided that he is acting as an agent of the Government as defined above.

12. *Motor Spirits.*—Importers are required to be registered under the provisions of the Motor Spirit (Returns) Act No. 5, 1952 and, under the provisions of the Revenue Allocation (Motor Spirit and Diesel Oil Returns) Reg. 1959 (Legal Notice No. 116 of 1959); registered importers are required to render returns in accordance with Government Notice No. 1281 (Customs and Excise Notice No. 19) of 1959. Entries for this commodity may not contain particulars of goods of any other description.

13. *Plants and seeds.*—For the various types of plants and seeds and the conditions under which their importations into this country are allowed, see AGRICULTURE (Control of Importation) Act, No. 28/1959.

14. *Poisons.*—(a) The importation of any poison, drug or substance specified in the First Schedule of the Pharmacy Act (Cap 152), whether such poison, etc. is in a patent or proprietary medicine or preparation, or not, is subject to the production of a Licence or Permit, issued by the Pharmacy Board unless such importations are made by—

(i) a selling dispenser on the production of "Form F".

(ii) a registered chemist or druggist whose name appears in the annual list published in the Gazette under the provisions of section 17.

- (iii) a missionary on the production of 'Form H'.
- (iv) a licence holder on the production of 'Form L'.
- (v) the holder of a Permit issued by the Pharmaceutical Board of Nigeria authorising the importation of industrial and laboratory chemicals. The eligible holders of such permits are :—the Agricultural or Veterinary department, the Government Analyst, any other Government department or any person engaged in scientific or industrial research) ; or
- (vi) certain organizations designated by the Board.

(b) Entries for any poison, drug or substance under sub-paragraph (a) must contain a declaration of the name of the person qualified to import the specified poison, drug or substance, and his authority.

15. *Spirits*.—(a) Brandy, whisky, rum and gin (other than miniature bottles imported as samples, at the discretion of the Board) may be imported only in cases containing 12 bottles known as reputed quarts or 24 bottles known as reputed pints or 48 bottles known as reputed half pints or 96 bottles known as reputed quarter pints or 192 bottles known as reputed one-eighth pints and measuring not less than 1.78 nor more than 2 liquid gallons per case.

(b) Spirit preparations unfit for use as potable spirits are prohibited at the discretion of the Board.

(c) The quantity of pure alcohol contained in importations of distilled, potable alcoholic beverages must be shown on the Entry.

(d) The following certificates must be presented with Entries for the kinds of potable spirits shown. Specimens of these certificates are at—Annexes "F", "G", "H", "I".

(i) Brandy : Certificate of Age and Origin in form C.S.1 issued by the competent Government Authority in the country of production or shipment.

(ii) Rum : Certificate of Age and Origin in form C.S.2 issued by the competent Government Authority in the country of production or shipment.

(iii) Whisky : A certificate of Age and Origin in form C.S.3 issued by the competent Government Authority in the country of production for each consignment.

(iv) Pot-still Gin : A certificate in form C.S.4 issued by the Government Authority in the country of production.

(v) Gin : Only formal approval of the Board and publication of the approved brands in the *Official Gazette* is required for exportation to this country.

(vi) In lieu of the Certificates required under sub-paragraph (d) (i) to (v), the Board may accept from such blender and exporter and in respect of such brands as it may approve, a sworn declaration in such form as it may require, to the effect that the consignment of brandy, rum, whisky or gin to which the declaration refers, complies with the requirements of sub-paragraphs 18 (a) (ii), (iv), (vii) and (x) and 18 (b) of the First Schedule to the Imports Prohibition Order Legal Notice No. 81 of 1959 as are applicable and provided that all shipments to the Federal Republic of Nigeria of such brands of brandy, rum and whisky by the blender or exporter will be subject to annual approval by the Board (but see sub-paragraph (e) for special requirement on gin).

(e) Brands of gin conforming to the requirements of sub-paragraphs 18 (a) (iv) and 18 (b) of the First Schedule to the Imports Prohibition Order, L.N. No. 81 of 1959, may be imported without formality provided that such brands have been approved by the Board and notified in the *Official Gazette* as approved brands and are in containers labelled with the names and addresses of the owners of the brands.

(f) Spirits imported in cask or drum : Such importations must be covered by a licence issued by the Board. Fees payable are prescribed in the Second Schedule to the Imports Prohibition Order, 1959.

(g) Mineralised and Industrial methylated Spirit : (i) Are admissible at importation provided they conform to the specification shown in the First Schedule to the Imports Prohibition Order, 1959, and a certificate to this effect appears on the invoice and is endorsed on the Entry.

(ii) Importations of industrial methylated spirit must be supported by a licence issued by the Board.

(h) Drugs and Medicines containing spirit : May be imported at the discretion of the Board.

(i) Denatured Spirit : Spirits denatured for a particular purpose may be imported provided they are denatured in a manner approved by the Board.

(j) Spirits imported for scientific purposes : Subject to such conditions as the Board may prescribe.

16. *Goods Imported by Educational Establishments and Solely for Educational Purposes*.—(a) Any educational establishment which desires to claim exemption from duty as provided for in schedule 2 to the Customs Tariff Act 1965 is required to submit with the relevant Entry a certificate under the hand of an approved signatory as evidence that the goods concerned are for use solely for educational purposes in such establishments (see sub-paragraph (b)).

- a series of tests and interviews conducted by the Public Service Selection Board;
- an interview by the Public Service Commission.

Only candidates who attain the qualifying standard in the written examination will be invited for the tests and interviews by the Public Service Selection Board. The Public Service Commissioners will subsequently select, in the light of the records and performances of such candidates those who will be interviewed by the Commission.

3. To be eligible to enter for the competition, a candidate who is not already in the public service of Mid-Western Nigeria must either possess the following qualifications or intend to sit in 1970 for the final examinations leading to them:—

- For the post of Administrative Officer, Class IV: A degree, preferably in Arts or Economics, from a recognised university.
- For the post of Auditor or Inspector of Taxes: A degree from a recognised university preferably in Accountancy, Arts, Commerce or Economics.
- For the post of Produce Officer: A recognised degree in Agriculture or other suitable degree, preferably in Commerce or Economics.
- For the post of Assistant Registrar of Co-operative Societies:

A recognised degree, preferably in Economics. "Recognised" in the above context means "Recognised by the Government of Mid-Western Nigeria".

4. The purpose of the written examination is not to test the candidates in the subjects which they studied for their degree but to test their ability to think clearly, to understand and write English as well as their knowledge of current affairs, particularly West African Affairs. Notes for the guidance of candidates drawn up by the West African Examinations Council will be issued to all candidates by the Council in due course. The examination will comprise the following papers:—

- English (Precis and Critical Appreciation).**—This will consist of a fairly long and complex passage which the candidates will be required to summarize in their own words supplemented by a question asking them to comment critically on the central idea of the passage;
- Current Affairs.**—This will comprise two separate papers, one of which will consist of three compulsory questions of the traditional essay type and the other will be a 50-question objective test paper. The questions are designed to test the candidates' intelligent awareness of current affairs which any educated person may be presumed to possess;
- General.**—This will consist of two questions. The first, known as the Logical Force passage, will test the candidates' ability to detect dubious thinking and the second, known as Statistical Inference question, will test their ability to draw correct inferences from a table of numerical data.

5. The written examination will be held on Friday, 17th April, 1970, in Lagos, Ibadan, Enugu, Benin City, Zaria, Accra, Freetown, London, Washington and at such other centres as may be determined later. The dates and centres of the sitting of the Public Service Selection Board will be announced later.

6. Candidates will be responsible for arranging and meeting the cost of their accommodation and transport.

7. Each candidate will be required to pay a fee of £5-5s-0d and fees are not refundable. No responsibility will be accepted for money sent in any other manner than that prescribed in paragraph 8 below.

8. Serving Officers will be informed of the special arrangements affecting them. Other candidates who have already applied for appointment to any of the
