NOTICE BY THE BOARD OF CUSTOMS AND EXCISE

Customs and Excise Notice No. 13

THE ENTRY EX-SHIP, EX-AIRCRAFT OR EX-MOTOR VEHICLE OF IMPORTED GOODS FOR HOME USE

Commencement : 1st March, 1971

Notes : (i) This Notice cancels Government Notices Nos. 1467 of 1958, 702 of 1959 and 132 of 1970 and covers all transactions with regard to imported goods other than the following :—

(a) delivery ex-warehouse (other than a Government Warehouse) for home use—Customs and Excise Notice No. 10, Government Notice 699 of 1959 ;

(b) importation by parcel post—Customs and Excise Notice No. 20, Government Notice 1173 of 1960 ;

(c) passengers' baggage—Customs and Excise Notice No. 12, Government Notice 701 of 1959 ;

(d) transit—Customs and Excise Notice No. 7, Government Notice 1603 of 1968 ;

(e) transshipment—Customs and Excise Notice No. 6, Government Notice 659 of 1959.

(ii) The Notice replaces Government Notice No. 1467 of 1958, and introduces, in place of certification on invoices by Approved Banks and Chambers of Commerce, new certificates of values—Forms Sale 123, 124 to be completed by the importer or his authorised employee (not agent) in support of invoiced values ;

(iii) This Notice abolishes the use of Post and Certified Entries.

(iv) Wherever the requirements of this Notice conflict with the requirements of other Customs and Excise Notices, the requirements set out hereunder take precedence ;

(v) Specimens of Forms mentioned in this Notice may be seen at any Custom House. Sale forms are to be printed privately and are to conform with the specimens in size, colour and ink impression.

GENERAL

1. **Law :** The law governing the Entry Ex-ship, Ex-Aircraft or Ex-Motor Vehicle of imported goods for Home Use is contained in Sections 25 to 28 and 35 to 42 of the Customs and Excise Management Act No. 55 of 1958. The attention of importers and their agents and all others concerned is also drawn to Section 142 of the same Act which prescribes penalties for false declarations on Entries.

2. **Purpose :** This Notice contains the requirements of the Board of Customs and Excise in respect of the Entry for Home Use of goods ex-ship, ex-aircraft, ex-motor vehicle or carried by a person or animal. Nothing in this Notice is, in any way, to be presumed to amend the law.

DEFINITIONS

3. (a) **Associated Firms :** An importer and an overseas exporter are deemed to be associated if, whether directly or indirectly, either of them has any interest in the business or property of the other or both have a common interest in any business or property, or some third person has any interest in the business or property of both of them, and includes cases where :—

(i) they are under common management ;

(ii) one is a branch of the other ;

(iii) one is a subsidiary of the other ;

(iv) one is an overseas buying agent of the other ;

(v) one or more directors are common to both ;

(vi) the owners of the two businesses are members of the same family.

(b) **Exporter,** in relation to goods for exportation or for use as stores, includes the shipper of the goods and any person performing, in the case of an aircraft or a motor vehicle, functions corresponding to those of a shipper.

(c) **Importer,** in relation to any goods at anytime between their importation and the time when they are cleared, includes any owner or other person for the time being possessed of or beneficially interested in the goods.

(d) **Overseas Buying Agent :** An "Overseas Buying Agent" includes commission agent, a confirming house or any person or firm who executes orders on another person or firm overseas on behalf of an importer in Nigeria and includes persons employed by or in any way associated with the Importer in Nigeria.

(e) **Supplier :** A "Supplier" means the person or firm who supplies the goods to the foreign exporter.

(f) **Trade Goods :** (1) Are deemed to be goods imported by way of trade and include those goods which are :—

(i) imported in pursuance of a contract of sale ;

(ii) imported on consignment ;

(iii) purchased by a private individual ; or

(iv) supplied by a parent company or associated firm for use by the importing firm.

- (2) The following are, for the purpose of this Notice, excluded from the category of trade goods :—
- (i) passengers' baggage accepted as such by the Board ;
 - (ii) bona fide gifts ;
 - (iii) government and quasi-government importations ;
 - (iv) small quantities of goods imported for personal use.

ENTRY OF GOODS

4. *Form of Entry* : (a) *Form Sale 42*—Goods imported ex-ship, ex-aircraft or ex-motor vehicle for home use, except as in sub-paragraph (c) below, are to be entered on Form Sale 42—Entry for Goods for Home Use (see specimen in Customs and Excise Notice No. 27 published as Government Notice No. 1928 of 1970).

(b) *Form Sale 42A*—Goods imported by air on which the assessed duty does not exceed £2 or goods, if they are exempt from payment of duty, whose C.I.F. value does not exceed £60 per consignment note may be entered on a single Form Sale 42A—Concessional Entry, Air Freight (see specimen in Customs and Excise Notice No. 27) supported by the relevant consignment note.

(c) *Goods entered, released but short delivered and subsequently landed*.—Proprietors are immediately to apply in writing for release of such goods to the Collector in-charge of the shed into which the goods are landed, giving full details of the carrying vessel and particulars of the Entry to which the goods were entered previously.

(d) *Prohibited Goods*.—Prohibited goods consigned to an importer in Nigeria will not be accepted as for Transit through Nigeria. Such goods will be seized unless covered by appropriate licence.

5. Numbers of Copies :

(a) Entry is to be submitted in four copies which will be machine stamped.

(b) The fourth copy which is the proprietor's official receipt and the only copy acceptable for exchange control purposes, will be available for collection by the proprietor soon after receipt by the cashier. This copy must on no account be endorsed by the Proprietor "FOR EXCHANGE CONTROL PURPOSE". Copies so endorsed will be rejected.

(c) The fourth copy of any Entry supported by a bill of sight is not valid for exchange control purposes.

6. Completion of Form of Entry :

(a) Details on an Entry form must be fully and legibly completed in the English Language and must be type-written. Entry which is not type-written will be rejected.

(b) Goods must be accurately described in accordance with the invoice description, amplified where necessary to make it clear what the goods are.

(c) When the unit of quantity in the Import List differs from that on which duty is chargeable, the quantity of the goods must be declared separately in both units.

(d) The value, in legal currency in Nigeria and the amount of duty chargeable on each item on an Entry must be declared separately. Where goods are liable to alternative rates of duty, the Entry relating thereto shall show on the face thereof the amount of effective duty chargeable at the rate to which such goods are liable and on the reverse the amount of duty chargeable at the ineffective alternative rate under the Heading "Alternative Calculation (no charge)" followed by a declaration by the importer or his agent as to the correctness thereof as follows :—

"I/We declare that the value, in Legal currency of Nigeria and the amount of duty chargeable at the higher rate to which the goods are liable have been shown on the face of the Entry".

(e) Erasures may not be made on Entry. Every cancellation or alteration on an Entry must be initialled by the declarant.

(f) Every deletion of an item on any of the Forms is to be separately initialled by the declarant, but deletion of successive portions of the forms may be made by a single line in the shape of the letter "Z" initialled by the declarant at each end of the line.

(g) Where free goods appear on the same invoice as dutiable goods, they may be entered on the same form as, and beneath, the dutiable goods, provided they are clearly declared as free on the entry.

(h) In cases where exemption from duty is claimed under any paragraph of the Customs Tariff Act, No. 3 of 1965, a declaration, signed by the declarant to the entry, must be made in the Form shown below.

"I hereby claim exemption from duty under the provisions of paragraph.....of Schedule.....to the Customs Tariff Act on the goods covered by this Entry on the grounds that....."

The grounds on which exemption is claimed must be clearly stated.

(i) Where an Entry is thought to have been incorrectly prepared, an Incorrect Entry Form—Form C.101, will be issued by Customs to the importer. The Entry will be returned to the importer for necessary corrections and re-submission. The importer is advised in his own interest to attend to such queries promptly to avoid delay in clearing his goods.

(k) Notes on the special requirements in respect of Entries for particular kinds of goods are as at Annex "A".

7. By whom declaration on Entry to be made :

(a) The declaration on an Entry must be signed in full by :—

(i) if an individual

(1) the actual importer ; or

(2) a clerk exclusively in his employment if duly authorised in writing ;

(ii) If a private company or partnership

(1) one of the partners ; or

(2) a clerk solely in its employment if duly authorised in writing ;

(iii) If a limited company

(1) any director or the secretary ; or

(2) any other officer of the company if duly authorised in writing by a director or by the secretary ;

(3) where the secretary and directors are resident abroad the accredited head of the company's branch in Nigeria or any officer of the company duly authorised in writing by him ;

(iv) a licensed Customs Agent to whom the importer has given the necessary authority in writing to act as his agent for customs purposes or his duly authorised clerk. The signatory will designate himself accordingly on the Entry. A licensed Customs Agent must also quote his current licence number and date.

(b) The authorisation mentioned above, required under the provisions of Customs and Excise Notice No. 4—Licensing of Customs and Excise Agents and Authorisation of Agents, —is to be on Form C. 30—Authority for an employee to act as Agent or Form C.31—Authority for Customs Agent to Act, as appropriate and to be delivered to the officer in the Custom House at the port/place of importation. Any change in authorised signatories must be advised on the prescribed authorisation forms immediately to the port/place concerned.

(c) Copies of Entries may be initialled, or bear the facsimile stamp of the signature of the declarant.

DOCUMENTS TO BE PRODUCED WITH ENTRY

8. (a) Invoices :

(i) *Size*.—Invoices attached to Entries must be 11½" x 8" in dimensions and must contain such goods as can be conveniently declared in the space provided in the Entry form.

(ii) *Number of copies*.—Two sets of invoices, original and duplicate, duly signed by the manufacturer, supplier or exporter, are to be submitted for all goods by the importer or his agent.

(iii) *Details required* : Invoices are to give—

(1) Full name and address of manufacturer, supplier or exporter as applicable ;

(2) Full name of business and address (NOT P.O. Box or Private Mail Bag) of the importer ;

(3) Importer's Order Number ;

(4) Certificate of Value by manufacturer, supplier or exporter as at Annex "B" on the reverse of the invoice form. The certificate is to clearly indicate whether the exporter is the manufacturer or supplier of the goods, and whether or not he is in anyway connected with the importer ;

(5) Certificate of Origin as at Annex "C" is to be given on the reverse of the invoice form.

(6) Specific descriptions of the goods consigned ;

(7) The unit and total price of each type of goods on the invoice ;

(8) Cost of packing ;

(9) Freight ;

(10) Insurance ;

(11) Commissions (including head office) ; confirming house and buying commission ;

(12) Other charges ;

(13) The total price of all the goods on the invoice, indicating clearly the F.O.B. (for licensing purposes) and the C.I.F. price.

(b) *Packing List* : Where an invoice does not show packing details, a packing list is to be presented.

(c) *Certificate of Value by Importer* : The importer is required to certify the invoice or any evidence of value presented with the Entry on one of the following forms as applicable—

(i) Form Sale 123—Declaration Regarding Imported goods for Home Use—Certificate 'A' and 'B' (see Annex 'D').

(ii) Form Sale 124—Declaration Regarding Imported Goods for Home Use where a fixed value per unit has been notified by the Customs to the Importer (see Annex 'E').

(iii) The certificate will vary in character according to the type of importation as indicated below—

Type of Importation :

Type of Certificate :

(1) Goods imported by an independent importer, i.e. importer who is neither an agent, broker, distributor or concessionaire for the seller nor associated in business with him.

Form Sale 123—
Certificate 'A'

(2) Goods imported by an importer who is either an agent, broker, distributor or concessionaire for the consignor or is associated in business with him.

Form Sale 123—
Certificate 'B'

(3) Goods for which a fixed value per unit has been notified by the Customs to the importer.

Form Sale 124.

(d) *Release Note* : Customs Release Note—Form Sale 12 is to be submitted with every set of Entry.

(c) *Goods from Hong Kong* : Goods originating in Hong Kong are to be accompanied by a Certificate of Origin issued only by persons authorised by the Director, Commerce and Industry, Hong Kong. In the case of goods of Hong Kong origin re-exported to Nigeria from countries other than Hong Kong, a Certificate of Origin issued by a Bank or Chamber of Commerce and Industry, Hong Kong, may be accepted except for goods in transit or transshipment in the country of re-export for which the proper Certificate of Origin must be produced.

9. *By whom declaration on form sale 123 and 124 to be made :*

(i) It is to be particularly noted that these declarations are to be made by either—

(a) the actual importer if an individual ; or

(b) a partner in the case of partnership ; or

(c) a Director or the Secretary in the case of an incorporated Company.

(ii) The declaration ARE NOT to be made by an Agent.

PRESENTATION OF ENTRIES

10. (a) As from the date of commencement of this Notice, checking of Entries in the Long Room will be completed before submission of Entries to the Cashier.

(b) Entries will therefore be submitted in the first instance, to the Licensing Unit in the Custom House for control of prohibitions and debiting of licences.

(c) To ensure facilitation of documentation, proprietors are advised in their own interests to ensure that:—

(i) instructions contained in this Notice are complied with without variation ;

(ii) Entries under Open General Licence and Specific Licences are submitted in different batches and relevant specific licences declared on the Entries are attached after being debited with the F.O.B. value for each Entry separately.

(iii) pre-checked Entries are covered by payment Schedules in duplicate before submission to the Cashier ;

(iv) pre-checked Entries for which importing vessel is not in port are NOT to be submitted to the Cashier, as proprietors are required to declare the rotation number and date of arrival of importing vessel on Entries before payment of duty ; and

(v) on receipt of his numbered copy of Entry, the number and date of the relevant Entry are inserted against the items debited on the reverse of his specific licence before re-submission of the licence for subsequent transaction.

VALUE OF IMPORTED GOODS

11. (a) The value of any imported goods is defined in the Second Schedule to the Customs and Excise Management Act, No. 55 of 1958.

(b) Where no insurance has been taken out in respect of an importation, $1\frac{1}{2}$ per cent of the invoiced value is to be added in the case of importation by sea, and $\frac{1}{2}$ per cent in the case of importation by air.

(c) Where the value is shown in foreign currency, such value is to be converted to equivalent Nigerian currency at the rate in force at the time of making Entry. The current rates of exchange are published at the Custom House.

12. *Buying commission*.—In calculating the value of imported goods, a buying commission of not less than four per cent of the f.o.b. (free on board) value must be included. The notes below are meant to amplify this paragraph to Nigerian importers and overseas suppliers.

Notes.—1. Paragraph 12 prescribes the rate of buying commission to be included in the normal price of all goods imported into Nigeria.

2. The paragraph requires action more of the Nigerian importer than of the overseas supplier and it is warned that invoices prepared by overseas suppliers must not contain, as a result of this paragraph, any untrue or false statement which would constitute a contravention of the Customs and Excise Management Act, No. 55 of 1958.

3. The effect of the paragraph is that :—

(a) Where no buying commission is charged by an overseas supplier or no such commission is shown on the relevant invoice, the importer is required, in preparing his Entry, to add four per cent buying commission (based on the f.o.b. value) to the value of the goods ;

(b) Where the buying commission charged by an overseas supplier or shown on the relevant invoices is less than four per cent of the f.o.b. value, the Nigerian importer is required to add, to the value declared on the Entry, an amount equal to the difference between the buying commission charged by the overseas supplier or shown on the relevant invoice and four per cent buying commission based on the f.o.b. value of the goods ;

(c) Where the buying commission charged by an overseas supplier or shown on the relevant invoice exceeds four per cent of the f.o.b. value, the Nigerian importer is required to include in the value on the Entry the whole of the buying commission so charged or shown.

13. *Discounts which are not allowable.*—Discounts which are not allowable as deductions from value of imported goods include :—

- (a) sample discount ;
- (b) pattern discount ;
- (c) discount given for a special consideration (e.g., as a condition of there being no claim for breakages) ;
- (d) agency discount ;
- (e) contingency discount (e.g., dependent upon the turnover reached) ;
- (f) contingent freight rebate ;
- (g) unspecified discount ;
- (h) discount not freely available ;
- (i) buying commission.

14. *Allowable discounts.*—Below are enumerated the discounts which are normally allowable deductions in computing the statutory value of imported goods :—

- (a) trade discount ;
- (b) quantity discount—if freely available ;
- (c) cash discount—if freely available ;
- (d) quality discount, e.g. for goods described as 'seconds' ;
- (e) Bank Commission ;
- (f) Export Discount ;
- (g) Non-assembly discount in respect of a motor vehicle imported in a completely knocked down condition and for assembly locally.

DUTY ON IMPORTED GOODS

15. *Customs duty rates.*—Detailed information as to duty rates and exemptions will be found in the Schedules to the Customs Tariff Act No. 3 of 1965 obtainable from the Federal Government Printer. The rate of duty payable is that in force when the goods are entered and the duty paid. The amount of duty payable must be calculated to the penny, fractions of a penny being disregarded.

16. *Payment of duty.*—Duties in respect of imported goods must be paid to the Cashier in notes or coins of legal tender in Nigeria or postal order, or by a satisfactorily guaranteed cheque drawn on a bank in Nigeria, unless special arrangement has been made for payment direct to a bank and production to Customs of the Banker's Receipt.

17. *Amount of duty in doubt.*—Where entered goods are detained pending a decision as to the rate and/or amount of duty payable delivery may be effected by depositing with the Cashier such sum of money as the proper officer may determine. The authority for the Cashier to accept this deposit will be issued by the proper officer in writing and a Customs Receipt will be issued by the Cashier.

BILL OF SIGHT

18. *General :*

(a) If the importer of any trade goods is, by reason of the absence of any or of sufficient documentary evidence concerning them, unable to deliver a perfect Entry to the Customs, he may deliver to the proper officer, in triplicate, a Bill of Sight (size 9" x 10")—Form Sale 103—(see Annex "F") which the proper officer may or may not accept.

(b) A Bill of Sight will not be accepted by the proper officer, unless satisfactory documentary evidence of origin and evidence of value such as order forms, price lists, *proforma* invoices, sight draft, letter of credit of the goods are submitted with the Sight to the proper officer.

(c) If a Bill of Sight is acceptable, the importer will be allowed to examine his goods in the presence of the proper officer, and endorse the results of his examination in the appropriate column on the Bill of Sight.

19.—(a) *Exempt Goods and Goods liable to specific Rates of Duty.*—Where the goods are exempt or liable at a specific rate of duty not being merely an alternative rate, the importer is to prepare a perfect Entry in Form Sale 42 duly supported by the Bill of Sight and lodge with the Customs in the normal manner.

(b) *Ad Valorem Duty Goods.*—Where the goods are liable at an ad valorem rate of duty, importer will prepare and lodge a perfect Entry in Form Sale 42. The Entry is to be supported by the Bill of Sight and endorsed as follows :—

"I/We request delivery against provisional payment of duty under section 27 of the Customs and Excise Management Act No. 55 of 1958."

(c) *Adjustment of Provisional Payment.*—Adjustment of any payment made under the provisions of paragraph 19 (b) will not be made unless the importer, within three months of making such payment, presents to the proper officer a properly completed Form Sale 116—Application for Refund of Duty and Certificate of Over Entry—in triplicate, supported by proper invoice and "Certificate of Value by Importer"—see paragraph 8 (c).

CONCESSIONS

20. *Direct Delivery of Special Goods.*—(a) The goods listed in sub-paragraph (b) may be discharged direct into lighters, lorries or wagons for direct delivery provided :—

- (i) the importer applies for the concession ;
- (ii) the goods are pre-entered ;
- (iii) import licence is produced where applicable ;
- (iv) the Nigerian Ports Authority produces 10 per cent of the consignment for normal physical examination and other formalities.

(b) *List of Goods :*

- (i) Animal and birds—live ;
- (ii) Bank and other currency notes (under strict arrangements by the Police) ;
- (iii) Bulk iron and steel products ;
- (iv) Cement and Cement Clinker ;
- (v) Cereals ;
- (vi) Fertilizers ;
- (vii) Frozen foods including fish ;
- (viii) Gypsum ;
- (ix) Jute bags ;
- (x) Malt ;
- (xi) Milk ;
- (xii) Nescafe ;
- (xiii) Salt ;
- (xiv) Stockfish ;
- (xv) Sugar (in bags or cartons) ;
- (xvi) Wheat flour ;
- (xvii) Such other low duty bulk consignment which the responsible Collector may from time to time approve.

(c) In addition to the conditions in sub-paragraph (a) the following goods are to be supervised immediately on arrival of the carrying vessel as indicated.

<i>Goods</i>	<i>Responsibility</i>
(i) Arms and ammunition	Police or members of the Armed Forces.
(ii) Corpse	Family of the deceased who is to submit application for delivery. No Entry is required.
(iii) Radio-active material	Expert from responsible Ministry.
(iv) Strategic Importation	Responsible Ministry.

WARNING

(i) A Customs Entry is a legal document and the attention of proprietors and others concerned is invited to sections 142 and 143 of the Customs and Excise Management Act No. 55 of 1958 which read as follows :—
“Section 142—

(1) If any person—

(a) makes or signs, or causes to be made or signed, or delivers or causes to be delivered, to the Board or an officer, any declaration, notice, certificate or other document whatsoever ; or

(b) makes any statement in answer to any question put to him by an officer which he is required by or under this Act to answer, being a document or statement produced or made for any purpose of customs or excise, which is untrue in any material particular, he shall be guilty of an offence under this section.

(2) Where by reason of any such document or statement as aforesaid the full amount of any duty payable is not paid or any overpayments is made in respect of any drawback or repayment of duty, the amount of the duty unpaid or the overpayment shall be recoverable as a debt due to the Government.

(3) Without prejudice to subsection (2), where any person who commits an offence under this section does so either knowingly or recklessly, he shall be liable to a fine of five hundred pounds or to imprisonment for two years or to both ; and any goods in relation to which the document or statement was made shall be liable to forfeiture.

(4) Without prejudice to subsection (2) where any person commits an offence under this section in such circumstances that he is not liable under subsection (3) he shall be liable to a fine of three hundred pounds.

Section 143—

If any person—

(a) counterfeits or falsifies any document which is required by or under the customs or excise laws or which is used for the transaction of any business relating to customs or excise ; or

(b) knowingly accepts, receives or uses any such document so counterfeited or falsified ; or

(c) alters any such document after it is officially issued ; or

(d) counterfeits any seal, signature, initials, or other mark of, or used by, any officer for the verification of such a document or for the security of goods or for any other purpose relating to customs or excise, he shall be liable to a fine of five hundred pounds or to imprisonment for two years, or to both.”

(ii) Proprietors are requested in their own interest to clear their goods promptly from the Port Area within 21 days of the completion of discharge under section 29 of the Customs and Excise Management Act No. 55 of 1958, failing which immediate arrangement will be made to dispose of the goods by public auction sale under the aforementioned section of the Customs and Excise Management Act No. 55 of 1958.

ANNEX 'A'

NOTES ON THE PREPARATION OF ENTRIES FOR PARTICULAR TYPES OF GOODS

1. *Live Animals and Birds except Dogs*.—Valid certificate and permit as provided for in the Diseases of Animals Acts of 1917 and 1962 are to be attached to Entries covering the importation of live animals and birds.

2. *Dogs*.—All importations are to be covered by :

(i) valid certificates signed by a veterinary officer in the country of origin to the effect that the dogs are healthy and have not within the six months prior to importation been exposed to infection by rabies ; and

(ii) import permits issued by the Director of Federal Department of Veterinary Research or the Chief Veterinary Officer of any of the States of Nigeria.

3. *Plants and Seeds*.—For the various types of plants and seeds the conditions laid down in AGRICULTURE (Control of Importation) Act, No. 28 of 1959 and Plants, etc. (Control of Importation) Regulations 1970 are to be fully complied with.

4. *Arms and Ammunitions*.—Proper Entry must be made before discharge from the importing vessel can be allowed. Such Entry must be supported by :

(a) a licence issued by the Import Licensing Authority ; and

(b) a licence in Form 15 issued in accordance with the Firearms Act and Regulations and signed by an authorised police officer.

5. *Explosive, including Fire Works*.—Importation must comply strictly with the Explosive Regulations, 1967 made under the Explosives Act Cap. 64. Entry, supported by Form 9—Permit to Import Explosives, must be passed before discharge from the importing vessel.

6. *Poison, Drugs and other Medicinal Preparation*.—Importation must comply strictly with the provisions of the Pharmacy Act and Regulations made thereunder. Entries for such importations must first be certified by an approved Government Pharmacist before acceptance by Customs.

7. *Petroleum Products*.—Entry for this type of goods must not contain particular of goods of any other description.

8. *Gold (Raw)*.—Entry must be supported by a declaration in Form B as specified in the Schedule to the Gold Trading Act.

9. *Beer*.—Entries for beer must contain a declaration of original gravity of brewing, and in the case of blended beer, the calculated original gravity. Supporting invoices should also give this information.

10. *Spirits* :

(a) (i) Brandy, rum and gin (other than miniature bottles imported as samples, at the discretion of the Board) may be imported only in cases containing 12 bottles known as reputed quarts or 24 bottles known as reputed pints or 48 bottles known as reputed half pints or 96 bottles known as reputed one-quarter pints or 192 bottles known as reputed one-eighth pints and measuring not less than 1.78 nor more than 2 liquid gallons per case.

(ii) Distillers and exporters are advised in their own interest to obtain prior approval of the Board for any brand of spirit they intend to export to Nigeria.

(iii) Spirit preparations unfit for use as potable spirits are prohibited at the discretion of the Board.

(iv) The quantity of pure alcohol contained in importations of distilled, potable alcoholic beverages must be shown on the Entry.

(b) The following certificates must be presented with Entries for the kinds of potable spirits shown :—

(i) *Brandy*.—Certificate of Age and Origin in Form Sale 141 issued by the Customs Authority in the Country of Production or shipment (see Annex "G").

(ii) *Rum*.—Certificate of Age and Origin in Form Sale 143 issued by the Customs Authority in the Country of Production or shipment (see Annex "H").

(iii) *Whisky*.—A Certificate of Age and Origin in Form Sale 144 issued by the Customs Authority in the Country of Production for each consignment (see Annex "I").

(iv) *Gin*.—Only formal approval of the Board and publication of the approved brands in the *Official Gazette* are required for exportation to this Country. Importers are therefore to submit, prior to importation, Certificate of Purity for each brand of gin they intended to import in Form Sale 142 (see Annex "J").

(v) In lieu of the certificates required under sub-paragraph (b) (i)-(iv), the Board may accept from such blender and exporter and in respect of such brands as it may approve a Sworn Declaration, valid for five years (see Annexes "K"-"N") to the effect that the consignment of brandy, rum, whisky or gin to which the declaration refers complies with the requirement of sub-paragraphs 37 (1) (b), (d), (g) and (j) of the First Schedule to the Imports Prohibition Order, Legal Notice No. 43 of 1970 as applicable.

(c) *Spirits imported in cask or drum*.—Such importations must be covered by a licence issued by the Board. Fees payable are prescribed in the Second Schedule to the Imports Prohibition Order, 1970.

(d) *Mineralised and Industrial Methylated Spirits* :

(i) Are admissible at importation provided they conform to the specification shown in the First Schedule to the Import Prohibition Order, 1970, and a certificate to this effect appears on the invoice and is endorsed on the Entry.

(ii) Importations of industrial methylated spirit must be supported by a licence issued by the Board.

(e) *Denatured Spirit*.—Spirits denatured for a particular purpose may be imported provided they are denatured in a manner approved by the Board.

(f) *Spirits imported for medicinal or scientific purposes*.—Subject to such conditions as the Board may prescribe.

11. *Potable Spirits other than Brandy, Gin, Rum and Whisky*.—Intending foreign exporters of alcoholic bitters, liquors, cordials, and mixtures other than brandy, gin, rum and whisky are to make prior application in Form Sale 145—Application for the Admission of Potable Spirits (Annex "O")—to the Board. When the application is approved, the Board will notify the exporter on Form Sale 146—Notification of Admission of Potable Spirits (Annex "P"). Importations of potable spirits which do not receive the Board's approval are inadmissible.

12. *Goods imported by Educational Establishments*.—(a) Any educational establishment which desires to claim exemption from duty as provided for in Schedule 2 to the Customs Tariff Act No. 3 of 1965 is required to submit with the relevant Entry Certificate as evidence that the goods concerned are for use solely for educational purposes in such an establishment. Such certificates are to be signed by, in the case of :—

(b) Persons holding the above mentioned offices are to forward specimens of their signatures to the Comptroller's Office, Customs Headquarters, Lagos for record purposes. Any time there is change in personnel, specimen signature of the new occupant of the post is to be forwarded immediately.

13. *Tobacco Goods*.—(a) This includes unmanufactured tobacco, manufactured tobacco, cigarettes, cigars and snuff, and may be imported only by holders of a licence issued by the Board of Customs and Excise under the Tobacco (Invoices and Returns) Act No. 1 of 1952 except where otherwise allowed under the Act.

(b) Entry for tobacco goods may not contain particulars of goods of any other description and must be supported by Specific Import Licence issued by the Import Licensing Authority.

(c) Unless shown on the invoice or other supporting documents, the gross, tare and net weights of each package of unmanufactured tobacco must be declared on the relevant Entry. A number of packages having the same gross and net weights may be grouped together.

14. *Trophies*.—Trophies consisting of live or dead protected animals or the eggs, eggshells, nests, plumage or protected birds or anything part of, or produced from such animals or birds which have not, by a process of manufacture, lost their original identity, must be accompanied by a certificate of lawful export issued by the government of the exporting country. A list of protected animals and birds appears in the Wild Animals Preservation Act and subsidiary legislation.

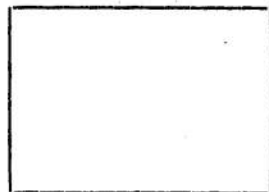

IMPROVEMENT OF CARIBBEAN METEOROLOGICAL
SERVICES

The project is designed to assist the Government of Barbados, Jamaica, Trinidad and Tobago, British Caribbean Territories and Guyana, in strengthening and improving their meteorological services to meet the particular needs of the region. The project will have the following three related elements:

(1) A weather radar network is being set up consisting of five units, located strategically in Trinidad and Tobago, Barbados, Antigua, Jamaica and Guyana; these units will form a continuous "radar fence" and provide an essential facility for the study of hurricanes and for the development of effective warning techniques. The network will work in close co-operation and co-ordination with similar installations which exist in neighbouring areas, in order to increase the knowledge of severe weather conditions and to perfect a warning system. The radar units will also provide badly needed information on the precipitation patterns which are indispensable for the improvement and expansion of agriculture. The first radar has already been installed in the Institute, the next four will be added by the end of this year.

(2) A network of seventeen agrometeorological stations has been created, distributed over the participating countries, which will provide not only meteorological information essential to agriculture, but also basic climatic data for other development purposes.

(3) A regional meteorological institute is being established in Barbados, with the following units:

(a) A training unit which, during the four years of the project duration, will train approximately 160 meteorological personnel at different levels and in different specialized skills;

(b) An equipment calibration, repair and maintenance unit;

(c) A research unit, to carry out applied research on hurricane tracking and warning, hydrometeorology and agrometeorology, including the necessary basic research on the upper atmosphere; this unit of the Institute will also

serve as a focal point for various foreign universities and other organizations interested in carrying out research programmes in tropical meteorology in the Caribbean area ; and

(d) A data processing unit which is receiving, processing and publishing tabulations, maps and other relevant information based upon the data collected in the participating countries.

The objectives of the project are to assist the governments in the collection and analysis of hydrometeorological data on the catchments of Lakes Victoria, Kyoga and Albert in order to study the water balance of the Upper-Nile, as a basis for planning water conservation and development, and laying the basis for inter-governmental co-operation in the regulation of the Nile. The participating governments are: Kenya, Sudan, Uganda, the United Arab Republic and the United Republic of Tanzania.
