He may also be required to act as Secretary to any of the following National Committees when set up :

(i) National Electricity Development and Planning Committee ;

(ii) National Fuel Policy Committee ;

(iii) National Tariffs Commission

or he may be required to act as Secretary to the joint National Committee embracing the three Committees Listed above.

The Electricity Licences, Contractors Licensing and Inspections Control Section will be required in accordance with Section 3 of the Electricity Act Chapter 57 and Legal Notice No. 76 of 1965 to process applications for electricity licences in respect of private installations (Section 3A of the Act) and in respect of installations established expressly to sell electricity to consumers (Section 3B of the Act). Upon approval of electricity licences by the Commissioner, this Section after collecting the prescribed licence fees in accordance with Legal Notice No. 187 of 1962 will issue the licences signed by the Chief Inspecting Engineer or by his accredited representative.

(i) that all electrical installations whether licensed or not, are inspected, tested and certified as complying with the Supply or Wiring Regulations or both or to any other Regulations as considered appropriate ;

(ii) that the inspection fees as appropriate are paid in accordance with regulations in force or in accordance with Section 36 of the Electricity Act Chapter 57 as amended by Legal Notice No. 62 of 1961 ;

(iii) that annual fees in respect of licensed installations are paid in accordance with Legal Notice No. 187 of 1962.

In respect of installations at Petrol Stations, inspections are to ensure compliance with the British Standard Code of Practice CP 1003 referred to as Institute of Petroleum Safety Code. In respect of installations at Cinemas and Theatres, inspections are to ensure compliance with the Cinematograph Act Chapter 32 (Legal Notice No. 79 of 1954). In respect of installations in Public Buildings, Offices and residential quarters, inspections are also to ensure compliance with the Regulations for the Electrical Equipment of Buildings issued by the Institution of Electrical Engineers. In respect of inspections of installations, machines, equipment, materials and accessories not within the scope of Regulations already mentioned, British Standard Specifications and Codes of Practice will apply. This Section will run the Division's Demonstration Laboratory and ensure implementation of testing methods newly adopted.
