

WHEREAS it is necessary and expedient to fill the vacancy of Deputy-Governor of the Central Bank of Nigeria:

NOW THEREFORE in exercise of the powers conferred by section 9 (1) of the Central Bank of Nigeria Act as modified by the Constitution (Suspension and Modification) Decree 1966 and the Constitution (Miscellaneous Provisions) (No. 2) Decree 1967, and of all other powers enabling me in that behalf, I, Major-General YAKUBU GOWON, Head of the Federal Military Government and Commander-in-Chief of the Armed Forces of the Federal Republic of Nigeria hereby appoint SAMUEL OYEWOLE ASABIA as Deputy Governor of the Central Bank of Nigeria with effect from 2nd March 1970 upon and subject to the terms and conditions set out in a letter of appointment dated 2nd February 1970.

TRAINING OF STENOGRAPHERS AT THE FEDERAL TRAINING CENTRE, LAGOS

Applications are invited from qualified persons of Nigerian origin who wish to train as Stenographers at the Federal Training Centre, Lagos.

2. *Course description.*—The subjects of the course which will last 15 months beginning from 1st July, 1971, are :

(a) *Compulsory* : Typewriting (35 words per minute), Shorthand (80 words per minute), English, Secretarial Practice, Office Routine ; and

(b) *Optional* : Government Regulations, French, Elementary Economics, Book-keeping and Accountancy.

On completion of the course, trainees will be required to sit for the Federal Training Centre End-of-Course examination in the compulsory subjects and in, at least, one of the optional subjects. Successful trainees will be awarded the Federal Government Certificate in Secretarial Studies.

3. *Qualification of applicants.*—Applicants must have either the West African School Certificate (with, at least, a "pass" in English language), or its equivalent. For holders of the West African School Certificate preference will be given to those with "Credit" in English language. Selected applicants will be required to take an aptitude test, the details of which will be forwarded to them.

4. *Sponsorship.*—While the course is mainly designed for training Stenographers for Federal and State government services, a limited number of places will be reserved for trainees sponsored by establishments in the private sector, statutory corporations and state-owned companies. A course fee of £60 is charged in respect of each non-government sponsored trainee. Customs and Excise Notice No. 4

LICENSING AND AUTHORISATION OF CUSTOMS AND EXCISE AGENTS

Commencement : 1st April, 1971

- Note.*—1. Sale Forms mentioned in this Notice may be printed privately provided that they conform in all respects with approved forms, specimens of which may be seen at any Custom House.
2. Customs and Excise forms may be obtained from any Customs House.

PART I—GENERAL

1. *Law.*—The attention of importers, exporters, shipping and airline operating companies, manufacturers and others concerned is drawn to sections 128 and 135-138 of the Customs and Excise Management Act No. 55 of 1958, and to Customs and Excise Agents (Licensing) Regulations 1968 (Legal Notice 95/1968) as amended.

PART II—LICENSING OF CUSTOMS OR EXCISE AGENTS

2. *Application for Licence :*

(a) Any person, firm or body corporate wishing to become a Customs or Excise Agent, at a particular port, airport, or station, and so to act on behalf of a principal must make written application on Forms Sale 133, 134 and 135 as appropriate (Annexes 'A', 'B' and 'C') supported by evidence of Registration of his business to the Board through the proper Collector in charge of the port, airport or station at which he proposes to operate. The application form must be completed in all required particulars and duly signed by the applicant as indicated in the notes in each application form.

(b) The application must state the Customs port(s), airport(s) or station(s) in which the applicant intends to carry on business, and must be submitted with an additional copy in respect of each port, airport and station covered by the application.

(c) The application is to name the person who is to represent the agent at each port, airport or station.

3. *Conditions for Granting Application.*—The applicant must satisfy the Board that his organisation is equipped to perform the full duties of a licensed Customs or Excise Agent namely that—

(i) he owns or occupies a suitable office from which to carry on his business 'at' each place mentioned in the application ;

(ii) he is experienced in Customs and Excise procedure ;

(iii) he understands and can apply the Customs Tariff based on the Brussels Nomenclature Tariff and the Excise Tariff ;

(iv) he has up-to-date copies of all the basic books for efficient performance of his Customs and Excise Agency duties including a complete set of the Brussels Nomenclature and the Explanatory Notes to the Brussels Nomenclature and the Index to these books ;

(v) he has completed a questionnaire aimed at ensuring that he does not and will not employ any revenue officer or any other employee who has been convicted or dismissed for misconduct ;

(vi) he nominates a competent representative of his organisation who must be literate in the official language to attend an interview (which may be oral and written) to be held in such places as the Board may direct. The Managing Director of the Company, if he is not the person nominated, is also to attend the interview as an observer.

4. *Additional Requirements in the case of suitable Applicants :*

(a) An applicant who, in the opinion of the Board, is suitable to be a Customs or Excise Agent will be required to—

(i) furnish security either in cash or a properly completed bond, in either case, in the sum of five hundred pounds (£500) in Form C. 163—in the case of a Customs Agent, and in Form C. 187—in the case of an Excise Agent (*see* Customs and Excise Notice No. 56) in respect of each port, airport or station in which he intends to carry on business ;

(ii) pay an annual licence fee of five pounds (£5) for every licence issued ;

(iii) submit to the Board two copies of a table of rates to be charged for services rendered ;

(b) (i) The bond required under sub-paragraph (a) (i) must be signed by both the applicant and his surety. The surety to the bond must be an approved Bank or Insurance Company incorporated under the Companies Decree 1968 or such other surety as may be acceptable to the Board from time to time (*see* Customs and Excise Notice No. 56). Any change in the name, status or circumstances of a surety must be notified in writing by the Customs or Excise Agent concerned to the proper Collector.

(ii) Where the applicant is a Bank or an Insurance Company, it may sign the bond as both applicant and surety.

5. Issue of Licence :

(a) Licence will be issued, on approval by the Board, by the local Collector in Form C. 63—Customs Agents' Licence or in Form Ex. 22—Excise Agents' Licence, as appropriate (see Annexes 'D' and 'E').

(b) Licence will be issued in respect of every port, airport or station in which the Agent intends to operate.

6. *Re-issue of Licence.*—A holder of a licence issued under paragraph 5 is :—

(i) to notify the Board within 30 days of any change of his business name and provide the evidence required in paragraph 4 ;

(ii) to apply for interview immediately when the representative under paragraph 3 (vi) is changed ;

(iii) in the circumstances of (i) and (ii) a new licence will be issued on payment of the prescribed fee of five pounds (£5).

7. Renewal of Licences :

(a) Application for the renewal of a licence must be made in writing to the Board through the proper local Collector not later than the 1st day of November of the current year.

(b) A licence will not be renewed unless the Board is satisfied that the applicant will continue to be a competent and acceptable Customs or Excise Agent.

(c) Renewal of a licence is subject to the payment of the prescribed fee of five pounds (£5).

8. *Correspondence with Customs or Excise Agents.*—Where a particular matter is being dealt with by a Customs or Excise Agent on behalf of his principal, all correspondence on the subject will be addressed to the Customs or Excise Agent.

9. *Refunds.*—When any money is paid by a Customs or Excise Agent on behalf of a principal, any refund authorised will be paid to that Agent and the principal notified.

10. Liability of Agents and Principals :

(a) *Agents.*—Any Customs or Excise Agent who is authorised by a proprietor of goods to act on his behalf is personally liable for the payment of any duties payable in respect of those goods and for the performance of all acts under the Customs and Excise laws in relation to those goods, but the proprietor is not thereby relieved of liability to prosecution for any offence under the Customs and Excise laws.

(b) *Principals.*—Any proprietor who authorises an Agent to act for him in relation to any goods or for any of the purposes of the Customs and Excise laws is liable for the acts and declarations of his Agent, but the Agent is not thereby relieved of liability to prosecution for any offence under the Customs and Excise laws.

PART III—EXEMPTIONS

11. *Proprietors.*—A proprietor may act in his own behalf without resort to a Customs or Excise Agent.

12. Government and Quasi-Government Departments :

(a) The following may act as Agents without the authority of a Customs or Excise Agent Licence :

(i) Government Coastal Agency ;

(ii) Nigerian Railway Corporation ;

(iii) Electricity Corporation of Nigeria ;

(iv) Nigerian Ports Authority ;

(v) Nigerian Airways ;

(vi) Post and Telegraphs Division of the Ministry of Communications ;

(vii) Any other Government Agency which the Board may from time to time approve.

(b) Importation and Exportations through Customs Stations for which a Customs Entry is not required from the proprietor are exempted from the provisions of these regulations.

PART IV—AUTHORISATION OF AGENTS

13. Authorisation of Agents :

(a) A proprietor who does not act on his own behalf may authorise one of the following to act for him :—

(i) his employee, in Form C.30—Authority for an Employee to act as Agent (Annex 'F') ;

(ii) a Customs or Excise Agent in Form C.31—Authority for a Customs/Excise Agent to act (Annex 'G')
An Agent may in turn authorise an employee.

(b) Any employee so authorised may transact any business relating to Customs and Excise on behalf of his employer provided that his employer lodges with the proper officer at the appropriate Customs port, airport or station a written authority as required by sub-paragraph (a) (i).

(c) A proprietor who personally subscribes to an Entry as an importer or exporter must also lodge, 2 passport photographs with his specimen signature with the proper Collector.


