WHEREAS by section 50 (2) of the Constitution of the former Northern Nigeria as modified by the Constitution (Suspension and Modification) Decree 1966, the States (Creation and Transitional Provisions) Decree 1967 and the Constitution (Northern States) (Amendment) Decree 1969 it is provided that the Judges of the High Court of each of the States created out of the former Northern Nigeria shall be the Chief Justice and such number of other Judges (not being less than two) as may be prescribed by law :

AND WHEREAS by section 51 (5) of the Constitution of the former Northern Nigeria as modified by the Constitution (Suspension and Modification) Decree 1966 and the States (Creation and Transitional Provisions) Decree 1967, it is provided that if the office of Chief Justice is vacant or if the person holding the office is for any reason unable to perform the functions of his office, then until a person has been appointed to and has assumed the functions of that office or until the person holding the office has resumed those functions, as the case may be, those functions shall be performed by such one of the other judges of the High Court as may from time to time be designated in that behalf by the Supreme Military Council, acting after consultation with the Advisory Judicial Committee :

NOW THEREFORE, THE SUPREME MILITARY COUNCIL, acting after consultation with the Advisory Judicial Committee, do hereby appoint MR JUSTICE MOHAMMED BELO to act as the Chief Justice of Northern States with effect from 22nd January 1972.

## AGREEMENT

CONCLUDED BETWEEN THE FEDERAL MILITARY GOVERNMENT OF THE FEDERAL REPUBLIC OF NIGERIA AND THE GOVERNMENT OF THE REPUBLIC OF EQUATORIAL GUINEA FOR THE RECRUITMENT IN NIGERIA OF NIGERIAN ADULT MALE WORKERS WITH THE OBJECT OF WORKING IN THE REPUBLIC OF EQUATORIAL GUINEA

## PREAMBLE

The Federal Military Government of the Federal Republic of Nigeria (hereinafter referred to as "The Government of Nigeria") and the Government of the Republic of Equatorial Guinea, (hereinafter referred to as "the Government of Equatorial Guinea").

Desiring to regulate and control in the common interest, the recruitment of Nigerian adult male workers for employment in the Republic of Equatorial Guinea and also the working conditions of such workers in that country.

Considering the desirability of concluding an Agreement to supersede and replace the Agreement dated the eighteenth day of May, 1963 between the Government of the Federation of Nigeria and the Government of the Spanish State relating to the Spanish Provinces of the Equatorial Region (now known as the "Republic of Equatorial Guinea").

Have agreed as follows :—

## DEFINITIONS

## Article 1

In this Agreement, unless the context otherwise requires

- (a) the term "Nigeria" means "the Federal Republic of Nigeria".
- (b) the expression "Equatorial Guinea" means "the Republic of Equatorial Guinea".
- (c) the expression "recruited workers", "Nigerian workers", "contracted workers" or the term "workers" means Nigerian workers recruited in accordance with the provisions of this Agreement.
- (d) the expression "the Ambassador" means "the Nigerian Ambassador to Equatorial Guinea".

## RECRUITMENT

## Article 2

The Government of Nigeria shall allow and facilitate the engagement in Nigeria of Nigerian adult male workers by recruiting agents authorised by that Government on the recommendation of the Government of Equatorial Guinea, provided the contract between each worker so engaged and his employer is made in accordance with this Agreement.

## Article 3

Every employer in Equatorial Guinea who wishes to employ any Nigerian worker in that country shall apply in writing to the Government of Equatorial Guinea stating the number of workers required whose conditions of employment shall be in accordance with this Agreement. The Government of Equatorial Guinea, having received the application, shall approve or reject it. If the application is approved, it shall be sent to a recruiting agent authorised in accordance with Article 2, who shall proceed to recruit on behalf of the employer the number of workers specified in the application or such smaller number of workers as may have been determined by the Government of Equatorial Guinea.

## Article 4

(1) On receiving the duly approved application, the recruiting agent shall make efforts to recruit the number of workers determined in the application in the State or States in which he is authorised so to do by the Government of Nigeria.

(2) The Government of Nigeria hereby reserves to itself the right to prohibit the engagement of workers by any recruiter or recruiting agent who had previously been penalised for serious or repeated infringement of any provisions of this Agreement or convicted for offences under the Nigerian Labour Code relating to recruitment for employment outside Nigeria.

(3) The Government of Nigeria also hereby reserves the right to withdraw any or all recruited workers from any employer. Provided that before the withdrawal the Government of Nigeria shall inform the Government of Equatorial Guinea of the circumstances and reasons for such withdrawal.

## MEDICAL EXAMINATION FOR FITNESS

## Article 5

(1) Before the contract is signed each recruited worker shall be brought before the authorised representative of the Government of Nigeria in the port from which he is to embark and shall be examined at the expense of the employer or his agent by a registered medical practitioner appointed as provided in Article 24 (3) of this Agreement.

(2) Where a contract is entered into in Equatorial Guinea, the worker shall be brought before the Nigerian Ambassador, or his representative acting on his behalf, and examined at the expense of the employer or his agent by a doctor of the medical service of the Government of Equatorial Guinea. If the worker on medical or other grounds outside his will is not suitable to be contracted, the employer or his agent shall pay the cost of the worker's return journey to the place where he was recruited in Equatorial Guinea.

**Article 6**

No worker shall be contracted whose apparent age is less than twenty-one years or who in the opinion of the Medical Officer is considered unfit or too old.

**TRANSPORTATION****Article 7**

(1) A worker may be accompanied to the place of employment by one wife and his children under the age of sixteen years. But under no circumstances shall a member of the worker's family be obliged to work for the employer.

(2) A worker who had arrived in Equatorial Guinea has a right to send for his family in Nigeria to join him through the Nigerian Embassy after informing his employer at the employer's expense; but under no circumstances shall a member of the worker's family be obliged to work for the employer. Any member of the worker's family who wishes to work in Equatorial Guinea shall pass through the normal process of recruitment in Nigeria.

**Article 8**

(1) The employer or the agent shall provide, and bear the expense of, the necessary means of transport for the workers and their families from the place of recruitment to the place of employment and provide adequate medical attention.

(2) Whenever the employer cannot provide food for the workers and their families between the period of embarkation and their arrival at the place of employment, the employer shall pay the workers a subsistence allowance of not less than 2s-6d each per day which shall be paid in the prevailing peseta rate.

**Article 9**

The Government of Equatorial Guinea shall adopt all necessary measures to ensure that the ships and vehicle of whatever type used for the conveyance of workers and their families are in good sanitary condition, and are not overloaded.

**Article 10**

A contract worker shall have the right of repatriation to Nigeria on the termination of the contract. The cost of the repatriation shall be borne by the employer.

Provided that where the contract by order of the Equatorial Guinean Minister of Labour and the Ambassador, or his representative acting on his behalf has been terminated solely on account of the fault or offence of the worker, the worker shall be required to bear the cost of repatriation of himself and his family out of the money deposited to his credit in accordance with Article 16 (1); in any case, where this money is insufficient to meet the cost of the repatriation, the difference shall be paid by the employer.

**Article 11**

A worker's family shall be repatriated at the employer's expense when the worker is repatriated. No matter the circumstance under which a Nigerian worker dies, the employer shall, at his own expense, repatriate the family of the deceased worker within 45 days and bear the cost of his burial.

**Article 12**

The Government of Equatorial Guinea shall repatriate workers and their families who have not been repatriated by the employer who is under obligation to do so.

**Article 13**

When a worker and his family are repatriated, the conditions relating to transport and subsistence shall be those set out in Articles 8, 9 and 26 of this Agreement.

**Article 14**

(1) The transport in canoes of Nigerian workers between the territories of Nigeria and Equatorial Guinea shall be forbidden, and the Governments of the two said territories shall adopt the necessary measures to make the prohibition effective.

(2) The Government of Equatorial Guinea shall order the return to Nigeria of any Nigerian worker who, whilst this Agreement is in force, enters into the said Country with the object of working for an employer therein without having previously entered into a labour contract in accordance with the provisions of this Agreement and the return to Nigeria of the said worker shall be at the expense of the Government of Nigeria.

**WAGES AND FRINGE BENEFITS****Article 15**

From the date of recruitment until the date of his embarkation in Nigeria, and also from the date of his disembarkation to the date of his arrival at the place where he was recruited, the worker shall receive from the employer a daily allowance of three shillings (3s.) for a period not exceeding fourteen days. He shall receive full rations during his stay in the transit camp.

**Article 16**

(1) A portion of every worker's wages consisting of his deferred wages of one pound and ten shillings (£1-10s) Nigerian currency and expatriation allowance of ten shillings (10s) Nigerian currency all amounting to two pounds (£2) Nigerian currency in respect of each completed month of his contract shall be remitted

to the Equatorial Guinean Minister of Labour for transmission to the Government of Nigeria for payment to the worker in Nigerian Currency on his return to Nigeria after the termination of his contract.

(2) The portion of the wages payable in accordance with sub-article (1) of this Article taken together with the portion payable in accordance with Article 17 of this Agreement shall constitute the whole of the wages due to a worker.

**Article 17**

The portion of the wages remaining due to the worker after the payment made in accordance with Article 16 (1) which consists of his wages of £5 (five pounds) Nigerian currency and expatriation allowance of one pound (£1) Nigerian currency the sum total of which shall be six pounds (£6) Nigerian currency per month shall be paid in Equatorial Guinea in pesetas at the prevailing rate of exchange.

Provided that the rate of wages shall be increased in proportion to any increase in the minimum rate of wages fixed by the Government of Equatorial Guinea for payment to the indigenous workers of Equatorial Guinea.

**Article 18**

Before his departure from Nigeria for employment in Equatorial Guinea the contracted worker shall receive a grant from the employer of a sum of ten shillings.

**Article 19**

(1) In addition to his wages, a worker shall receive the following daily rations of food from his employer free of charge, that is to say,  
 600 grammes of rice,  
 65 grammes of palm oil of 10% FFA quality,  
 250 grammes of fish or meat,  
 20 grammes of salt,  
 4 kilos of cocoyam per week and an adequate quantity of vegetables and edible fruits.

With the express approval of the Director of Medical Services of Equatorial Guinea and the Equatorial Guinean Minister of Labour given with the consent of the Ambassador, there may be substituted for these articles of food alternative ones of equal nutritive value.

(2) The employer shall place at the disposal of any worker, on the request of such worker, an area of 1-50 hectare in respect of the worker and each member of his family to be used for the production of native foodstuffs.

Provided that where the employer finds it not practicable to allocate land to the worker, the Ambassador and the Equatorial Guinean Minister of Labour shall jointly decide on the compensation to be given to such worker by way of increased daily ration or a fixed monthly allowance as the case may be.

(3) The worker shall have the right to collect firewood for his cooking free of cost.

(4) The employer shall provide adequate and hygienic quarters for the worker and his family. Each quarter shall be at least 10 square meters equivalent to 120 square feet and shall be occupied by not more than two single labourers or one married couple.

(5) The employer shall provide at his own expense medical and pharmaceutical aid and hospitalisation for the worker and his family. The Ambassador or his representative acting on his behalf shall also have the right to send a worker who in the Ambassador's or his representative's view, requires medical treatment, to the doctor retained by the employer or to the General Hospital at the expense of the employer. Where, however, the doctor certifies that the worker is fit to work, the worker shall bear the cost of the medical examination.

(6) No worker under medical treatment shall be declared a runaway. One month shall elapse before the contract of a worker who is declared a runaway is liquidated with the Equatorial Guinean Labour Officer.

**WORKING CONDITIONS****Article 20**

The nature of the work on which the workers shall be employed is sylvicultural, industrial, commercial or domestic service.

**Article 21**

The duration of the first contract entered into by the employer and the worker shall be for a period of three years only, and it shall be calculated from the date the contract is signed in Nigeria. In the case of a contract made in Equatorial Guinea the date of commencement shall be as stated in the contract. The contract shall include any period during which the worker is incapacitated by sickness or accident.

Provided that the worker may freely and spontaneously consent before the Ambassador, or the Labour Officer acting on his behalf, and the Equatorial Guinean Minister of Labour to serve the employer for an additional term not longer than the total of the periods spent serving a sentence or of incapacity.

#### Article 22

The contract between the worker and the employer or his authorised agent shall be made in writing in the form of the Schedule of this Agreement and shall be attested by an officer of the Government of Nigeria specially appointed for that purpose before the worker's embarkation. A worker shall not be employed by another employer while the worker's contract of employment subsists.

#### Article 23

The authorities of the Government of Equatorial Guinea of whatever rank or authority shall recognise the legal validity of any contracts or copies of contracts which are duly made in the form prescribed by this Agreement and the signature of the representative of the Government of Nigeria attesting any such contracts or copies shall have the effect of a certified public document and shall in every case be accepted as a proof of the authenticity and existence of the contract.

#### Article 24

(1) The contract shall be made out in quadruplicate at the expense of the employer. Two copies shall be in English and two in Spanish. One copy in English shall be delivered free of charge to the worker by the representative of the Government of Nigeria who shall also forward the other English copy to his Government to be filed and of the two Spanish copies one shall be sent to the Equatorial Guinean Minister of Labour who shall register it, and the other to the employer or his agent.

(2) The capitation fee payable by the employer to the Government of Nigeria for each first contract shall be ₦7 (seven pounds) Nigerian currency and for the second contract the pesetas equivalent of £3 (three pounds) Nigerian currency.

(3) The employer shall employ and pay the doctor approved by the Government of Nigeria for the medical examination of the recruited worker. Where, however, the Government of Nigeria provides a doctor, the charge payable by employer shall be five shillings in respect of each recruited worker.

#### Article 25

(1) The transfer of a contract from one employer shall not be effected unless the worker freely and spontaneously gives his consent before the Equatorial Guinean Minister of Labour and the Ambassador or his representative acting on his behalf, both of which officers must certify the transfer on the form of contract.

(2) On the joint application of the two parties to a contract, the Equatorial Guinean Minister of Labour shall institute action to effect the transfer of the contract from the employer to another employer.

(3) Any transfer made in pursuance of sub-article (2) shall be subject to the provisions of sub-article (1).

#### Article 26

Workers shall not be obliged to make long journeys on foot but where it is necessary to make such journeys, the distance to be covered in any working day shall not exceed five miles or approximately 8 kilometers.

### HOURS OF WORK, OVERTIME, HOLIDAYS AND SICK LEAVES

#### Article 27

(1) Where work is performed on a basis of time, the normal working day shall consist of eight (8) hours exclusive of intervals for meals or rest and shall not commence before 6 a.m. nor continue after 6 p.m. Equatorial Guinean time.

(2) Work shall be deemed to commence from the time of the roll call and every employer shall provide work in accordance with the provision of Article 20 of this Agreement on everyday on which the worker presents himself for work and is fit for work, and if the employer fails to provide work as aforesaid he shall pay to the worker in respect of everyday on which he shall so fail, wages at the same rate as if the worker had performed a day's work.

(3) In the case of task work it shall in any case of doubt or complaint be required that the Ambassador or the Labour Officer acting on his behalf, and the Equatorial Guinean Minister of Labour shall agree that the task can reasonably be performed in eight working hours.

(4) A worker who voluntarily works more than eight hours or performs more than one normal day's task on any day shall be remunerated in respect of this extra work at the rate of 100 per cent of the normal rates of each of the two portions of the wages due to him in accordance with Articles 16 and 17. Overtime shall not exceed two hours a day except in special circumstances.

Except that for the purposes of this sub-article remuneration shall be calculated and paid in pesetas in Equatorial Guinea.

#### Article 28

(1) A worker shall not be required to work on the days he is certified by a doctor to be unfit for work. A worker shall receive his full pay and full ration for any period which he is certified unfit for work or attends hospital for medical attention. Where a worker is hospitalised and fed by the Hospital authorities, he shall receive his full pay and shall be given full ration for his family.

(2) A worker shall not be required to work on Sundays or feast days save that on Sundays or feast days work which cannot be interrupted without serious loss shall be performed in shifts of eight-hour periods alternately of work and rest subject to the provisions of paragraph (1) of Article 27. A worker so employed shall be remunerated in respect of the work so performed on Sundays or feast days at the rate of twice the normal rates of each of the two portions of the wages due to him in accordance with Articles 16 and 17. Except that for the purpose of this sub-article remuneration shall be calculated and paid in pesetas in Equatorial Guinea.

(3) (i) A worker shall be given 14 days' holidays with full wages in respect of each completed period of twelve months in the continuous employment of an employer, and, in respect of any subsequent period of less than twelve months' continuous employment, he shall be given a proportionate holiday.

(ii) Where a worker is transferred from one employer to another, his earned leave shall be granted him prorata before the transfer is effected and shall not be commuted to money.

#### TERMINATION OF CONTRACTS

##### Article 29

(1) A contract shall be terminated by reason of one of the following causes:—

- (a) The completion of the term for which it was made;
- (b) The death of the worker before the expiration of the contract;
- (c) The physical inability, certified by a doctor, of the worker to fulfil the contract on account of illness or accident;
- (d) The joint order of the Equatorial Guinean Minister of Labour and the Ambassador, or his representative acting on his behalf, given on account of the inability, in the opinion of the Equatorial Guinean Minister of Labour and the Ambassador, or his representative acting on his behalf, of one or other of the contracting parties for any reason whatsoever to fulfil the contract.
- (e) The joint order of the Equatorial Guinean Minister of Labour and the Ambassador, or his representative acting on his behalf, given on account of the serious fault or repeated offence of either party to the contract.

(2) Notwithstanding the provisions of sub-article (1), where the termination of a contract is contemplated solely on account of the inability, fault or offence of the employer the joint order of the Equatorial Guinean Minister of Labour and the Ambassador, or his representative acting on his behalf, shall not be given until after the Equatorial Guinean Minister of Labour has instituted action to effect the transfer of the contract from the employer to another employer and the said action has failed.

(3) Any transfer effected in pursuance of sub-article (2) shall be subject to the provisions of sub-article (1) of article 25.

(4) The Government of Equatorial Guinea shall guarantee the payment of the deferred wages of a worker, all his unpaid wages and all rations that were not supplied to him prior to the declaration of bankruptcy of his employer. After declaration of bankruptcy of the employer, the worker shall be at liberty to seek employment with another employer through the Ambassador or his representative and with the knowledge and consent of the Equatorial Guinean Minister of Labour. If the worker fails to secure such employment within a period of one month he shall be entitled to be repatriated to Nigeria at the expense of the Government of Equatorial Guinea.

##### Article 30

(1) On the termination of a contract, a worker may:

- (i) return to Nigeria in exercise of the right provided for in Article 10; or
- (ii) enter into a second contract with the same employer or with another employer for a period not exceeding two years.

(2) A contract entered into under the provisions of sub-article (1) (ii) shall be made in Equatorial Guinea and attested by the Nigerian Ambassador or his representative acting on his behalf, and as far as may be and without prejudice to the other provisions of the Agreement, shall be subject to the provisions of Articles 21, 22, 23 and 24.

(3) A Nigerian worker, on the termination of a contract, entered into under the provisions of sub-article (1) (ii), shall not enter into a further contract under this Agreement unless he has first returned to Nigeria.

(4) A Nigerian worker who has returned to Nigeria in pursuance of sub-article (3) may be engaged in accordance with Article 2.

(5) Notwithstanding the provisions of sub-articles 1-4 of this Article, the Equatorial Guinean Minister of Labour and the Nigerian Ambassador may jointly decide to allow a worker whose contract was rescinded before it is due, through no fault of his, re-enter into subsequent contract to enable him to complete an aggregate working period of three years for the first contract and/or two years for the second contract.

#### Article 31

If, on the termination of a contract, a worker commences a new contract with the same or with another employer he shall have the right to receive from the employer a sum equal to the cost of his repatriation and that of his family (in case of their not returning to Nigeria), notwithstanding that by reason of the new contract he shall also receive from the new employer a similar sum as an award.

### WORKMEN'S COMPENSATION AND DISPOSAL OF PERSONAL EFFECTS OF DECEASED NIGERIAN WORKERS

#### Article 32

(1) In the event of a Nigerian worker suffering any incapacity or death as a result of an accident arising out of and in the course of his employment, he shall be entitled to adequate compensation under Nigerian or Equatorial Guinean Law, whichever confers greater benefits. Where, however, the Nigerian Law on compensation provides a higher rate, the difference shall be paid by the employer.

(2) In the case of death, the compensation payable under sub-article (1) above shall be deposited by the employer with the Equatorial Guinean Minister of Labour for transmission to the Ambassador for disposal in accordance with Nigerian law and custom.

(3) In any case of doubt as to whether the fatal accident arose out of the deceased worker's employment, the matter shall be discussed between the Ambassador or his representative acting on his behalf, and the Equatorial Guinean Minister of Labour, and if no agreement can be reached by these officers, the case shall be referred to the jurisdiction of the local courts.

#### Article 33

(1) The Equatorial Guinean Labour Officials shall notify as soon as possible all deaths and accidents affecting Nigerian workers to the Ambassador or his representatives.

(2) In all cases of fatal accidents or deaths by natural causes involving Nigerian workers, the Embassy shall have the right to claim all entitlements of such deceased workers where the dependants are not resident in Equatorial Guinea for disposal in accordance with Nigerian law and custom.

#### Article 34

The Ambassador or his representative shall collect from the employer any wages due to a Nigerian worker who has died in Equatorial Guinea. He may auction the personal effects of the deceased worker and pay the proceeds together with any wages due to the worker to the deceased worker's family for distribution in accordance with Nigerian law and custom. Where the deceased worker has no family in Equatorial Guinea, he shall auction the personal effects and pay the proceeds together with any wages due to the worker to the estate of the deceased worker for distribution in accordance with Nigerian law and custom.

### FREEDOM OF WORSHIP

#### Article 35

Nigerian workers employed in Equatorial Guinea shall be allowed freedom of conscience and to practise their religion. The spiritual needs of such workers shall be attended to by Christian Chaplains and Moslem Priests nominated with the consent of the Ambassador and the Equatorial Guinean Minister of Labour.

### PENAL SANCTIONS

#### Article 36

(1) A Nigerian worker accused of any offence against any law of Equatorial Guinea shall be brought before the appropriate authority and the Ambassador shall be so informed at the same time. The Ambassador or his representative acting on his behalf shall have free access at all times to any Nigerian worker detained. The Ambassador shall also be informed of the proceedings without delay and of the result thereof.

(2) Where a Nigerian worker is sentenced to a term of imprisonment for an offence under any law of Equatorial Guinea, which is not recognised as an offence under Nigerian Law, the Nigerian worker involved shall immediately be repatriated to Nigeria at his own expense.

(3) Whenever an employer or worker neglects or refuses to fulfil the contract under this Agreement or whenever any question, difference or dispute arises as to the rights or liabilities of either party or touching any misconduct, neglect or ill-treatment or any bodily harm or injury to the person or property of either of the parties to the contract, the party feeling aggrieved may make a complaint to the appropriate authority which shall hear the case.

Provided, however, that in accordance with Articles 21 and 23 of I.L.O. Convention No. 110 no worker shall be subjected to penal sanctions for :—

- (a) any refusal or failure of the worker to commence or perform the service stipulated in the contract ;
- (b) any neglect of duty or lack of diligence on the part of the worker ;
- (c) the absence of the worker without permission or valid reason ; and
- (d) the desertion of the worker.

(4) The worker's identity card or his copy of his contract of employment shall be accepted by the appropriate authorities in Equatorial Guinea as a pass for the purpose of lodging complaints with them.

#### Article 37

(1) A worker shall not be entitled to receive any wages with respect to periods during which he wilfully absents himself from his work or is serving a sentence.

(2) A worker shall be paid that portion of his wages calculated in accordance with Article 17 with respect to any period during which the worker is incapacitated by sickness or accident except in any case where the sickness or accident in the opinion of the doctor or in the light of other adequate evidence appears to have been due to the worker's negligence or wilful fault.

(3) Any deduction lawfully made from the wages of a worker shall be made from the portion of the wages paid in accordance with article 17.

Provided that if this portion is insufficient for the purpose and if in special circumstances the Ambassador or his representative, acting on his behalf, agrees, the deduction may be made in whole or in part from that portion of the worker's wages paid in accordance with Article 16 (1).

#### Article 38

(1) The sanction to be imposed on a worker for wilful and unauthorised absence from work shall be limited to an amount not exceeding the daily wage for every day of absence. The Equatorial Guinean Minister of Labour shall furnish the Ambassador with a monthly record of absence by and sanction imposed, on the worker.

(2) When a worker is sent away by the employer or his agent for no fault of his, the worker shall be paid full wages for the day.

(3) Where a worker is sent away by his employer or his agent from work on any day through his own fault he shall be paid for the period which he has worked.

Provided that no such payment shall be made to any worker sent away during the first hour of the working day.

#### Article 39

(1) A Nigerian worker contracted for employment in Equatorial Guinea under this Agreement shall enjoy the same guarantees, rights and privileges enjoyed by the Equatorial Guinean nationals in Equatorial Guinea in accordance with the Labour Legislation in force there.

(2) No Nigerian worker or any member of his family shall be subjected to any form of corporal punishment or arbitrary arrest. The Government of Equatorial Guinea shall guarantee the safety and protection of every recruited worker and any member of his family against deprivation of their liberty and any form of inhuman treatment. Unless there is a threat to the peace or breach of the peace, neither the Equatorial Guinean Police nor her armed forces shall interfere in any labour dispute.

#### Article 40

(1) The Government of Equatorial Guinea shall inform the Ambassador of any resolution made by Departments of the Government or the Courts of justice which affects Nigerian workers. The Ambassador or Labour Officers or other officers of the Federal Ministry of Labour shall have the right to obtain information about decisions made at the Equatorial Guinean Labour Office relative to complaints made before him and of such other decisions as may have an effect upon Nigerian workers.

(2) The Ambassador or such officers acting on his behalf, after giving prior notice to the Equatorial Guinean Minister of Labour of his intention to attend, shall be permitted to be so present at the hearing and the determination of labour disputes at the Equatorial Guinean Labour Office.

### MISCELLANEOUS PROVISIONS

#### Article 41

Workers shall not pay customs dues on entering Equatorial Guinea or on being repatriated to Nigeria in respect of their personal effects and tools and those of their families, neither shall they be liable to any direct taxation in Equatorial Guinea.

*Article 42*

(1) A recruited worker who wishes to settle in Equatorial Guinea must make an application to the Government of Equatorial Guinea through the Ambassador who shall forward it to the Equatorial Guinean Minister of Labour.

(2) The Equatorial Guinean Minister of Labour may exempt the employer from bearing the cost of the repatriation of the worker and his family when approval has been given to an application made in accordance with sub-article (1).

*Article 43*

(1) The Ambassador shall have the right to satisfy himself as to the well-being of Nigerian workers employed in Equatorial Guinea.

(2) The Government of Nigeria, with the consent of the Government of Equatorial Guinea may send to Equatorial Guinea such number of Labour Officers or other officers of the Federal Ministry of Labour who shall enjoy diplomatic status and assist the Ambassador in satisfying himself as to the well-being of Nigerian workers employed in that country.

*Article 44*

The Ambassador may appoint any member of his diplomatic staff as the representative of Nigerian workers in all relations between them and the Equatorial Guinean Minister of Labour. The Ambassador or any member of his staff acting on his behalf shall also have the right to make any claims which he may consider to be in the Nigerian workers' interest.

*Article 45*

(1) In the case of the Ambassador or such officers acting on his behalf, presenting a claim before the Equatorial Guinean Minister of Labour, the latter shall investigate the causes of it and shall inform the Ambassador, or such officers acting on his behalf, of the decision which has been taken.

(2) If the Ambassador or such officers acting on his behalf disagree with the decision which the Equatorial Guinean Minister of Labour has taken in any matter affecting the interests of Nigerian workers, the Government of Equatorial Guinea shall allow him, after due consultation, to make a visit accompanied by the Equatorial Guinean Minister of Labour or his representative, in order to examine the facts on which the decision was based and to bring them to the notice of the President of Equatorial Guinea if he considers them prejudicial to the interests of the Nigerian workers.

*Article 46*

(1) On notifying the Equatorial Guinean Minister of Labour of his intention, the Ambassador as well as the Nigerian Labour Officers or other officers shall be free to make visits to those places of work at which Nigerians are employed.

(2) The Nigerian Labour Inspection Staff shall have the right at all times to visit the places where Nigerians are employed for on-the-spot investigation.

Prior to any visit, the Nigerian Labour Inspection Staff shall inform the Equatorial Guinean Labour Staff of such visit and the latter may accompany the Nigerian Labour Inspection Staff.

*Article 47*

Any Nigerian worker detained by the Government of Equatorial Guinea or its Agent shall be brought to the law courts for trial within one month of such detention.

*Article 48*

Where any employer fails to fulfil his contractual obligation under this Agreement, the Government of Equatorial Guinea shall assume full responsibility for the discharge of the employer's obligation.

*Article 49*

The High Contracting Parties shall set up a Committee to investigate, report and recommend on complaints by workers or employers and on allegations of breaches of this Agreement. Each of the Contracting Parties shall nominate two representatives to serve on the Committee. The Committee shall meet in Equatorial Guinea at least once each quarter and as often as it may consider necessary. The Committee shall submit its report to the Equatorial Guinean Minister of Labour and the Commissioner of Labour for Nigeria for necessary action. The Committee shall regulate its procedure.

*Article 50*

Any doubts which may arise between the High Contracting Parties regarding the interpretation of this Agreement shall be resolved in discussion between representatives of the Governments of Nigeria and Equatorial Guinea.

*Article 51*

Subject to the provision of article 52 the present Agreement shall not be amended before the 1974 provided in exceptional circumstances either one of the High Contracting Parties may give to the other six months' notice in writing of an intention to propose an amendment.

*Article 52*

The present Agreement shall enter into force on the day of 30th December, 1971 from which date it shall abrogate the Agreement of the Eighteenth day of May, 1963. It shall remain in force indefinitely but may be terminated by either of the High Contracting Parties giving the other six months' notice in writing or such shorter period as may be mutually agreed upon between the High Contracting Parties.
