IN THE MATTER OF A TRADE DISPUTE BETWEEN THE JOINT ACTION COMMITTEE  
OF THE STAFF OF THE NIGERIAN EXTERNAL TELECOMMUNICATIONS LIMITED  
AND THE NIGERIAN EXTERNAL TELECOMMUNICATIONS LIMITED

WHEREAS a trade dispute between the Joint Action Committee of the Staff of the Nigerian External Telecommunications Limited and the Nigerian External Telecommunications Limited has been apprehended by me in accordance with the powers conferred upon me by section 5 (2) of the Trade Disputes (Emergency Provisions) Decree 1968 and a trade dispute now exists between the aforesaid parties;

AND WHEREAS both parties have been informed of my apprehension and of the steps which I propose to take for the purpose of resolving the dispute;

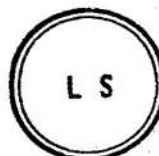

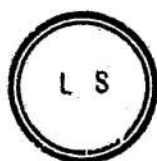
