APPROVAL OF GENERAL AND PRIVATE WAREHOUSE

AMENDMENT No. 2

Customs and Excise Notice No. 9 published as Government Notice No. 698 of 1959 in the Federation of Nigeria Official Gazette No. 21 of April 1959, is hereby amended as follows :—

By re-numbering paragraphs 9-32 as 10-33 and deleting paragraphs 5, 6, 7 and 8 and substituting the following :

"5. *Application*.—Any person wishing to obtain a licence for any building or proposing to erect such a building for use as a general or private Warehouse, should apply in writing to the Board through the Collector or Officer-in-Charge at the port or place in which the premises are situated, or are intended to be built. The application must give the following information :—

- (a) the type of warehouse, whether general or private warehouse ;
- (b) the purpose for which the licensed warehouse is required (e.g. ships' stores, etc.) ;
- (c) the name of the proposed warehouse keeper ;
- (d) the type of goods to be deposited ;
- (e) the situation and floor area of the premises to be licensed with a site plan showing the approach roads and surrounding buildings ;
- (f) the capacity (in metric) of such tank or vessel to be used for the storage of bulk liquid (where applicable) ;
- (g) the maximum amount of duty likely to be involved at any given time ;
- (h) evidence of financial capacity for (g) ;

6. *Provisional approval*.—The Board will grant provisional approval if the application is satisfactory to it.

7. *Plan and construction of the warehouse*.—On receipt of the provisional approval, the applicant is to submit to the Chief Collector/Principal Collector of the Area an approved detailed plan of the premises in triplicate. The plan is to indicate in particular the position of the proposed warehouse in relation to surrounding buildings, roadways, etc. and provide details of doors, windows and skylights.

8. *Building*.—The proposed warehouse must conform with the following :

- (i) the main door of the proposed licensed warehouse opens on to a public road or is so placed as to be capable of being under constant observation therefrom ;
- (ii) the building is well constructed of stone, brick or cement ;
- (iii) doors are strongly built of thick wood or metal, and if of the runner type, so constructed that they cannot be lifted off the runners ;
- (iv) doors must be fitted with at least one strong metal bar which is capable of taking two heavy padlocks ;
- (v) hinges must be securely bolted to the lintels on the inside, and the pins soldered over or otherwise fitted so that they may not be removed, nor the doors lifted therefrom ;
- (vi) nuts must be fitted to each bolt on the inside of the door, and soldered over or otherwise rendered incapable of being removed ;
- (vii) each window is secured by affixing, on the outside, vertical and horizontal metal bars at least 190.5 mm thick, which must be embedded in the surrounding masonry, and, if on the ground floor, additionally secured by affixing to the bars, expanded metal of small mesh ;
- (viii) each window is shuttered on the inside and may be locked and bolted from inside ;
- (ix) roofs are securely constructed and fixed to the tops of the walls, and, if spaces are left for ventilation purposes, such spaces are secured with expanded metal ;
- (x) where corrugated iron sheets are used for roofs they must be securely bolted together in such a manner that they cannot be separated ;
- (xi) the roof, if necessary, must be ceiled.

9. *Final approval* :

(a) When the premises and the building have been completed, the applicant is to invite the Area Chief Collector/Principal Collector in writing for inspection and final approval.

(b) If the building conforms with the details stated in paragraphs 7 and 8, licence will be issued—

(a) on payment of appropriate fees ; and

(b) on completion of bonds in Form C.169 (Bond for a Customs Warehouse) and Form C.170 (Bond for the Warehousing and removal of warehoused goods)."
