Carl L. Langford Deportation Order 1974

Commencement : 5th November 1974

I, the Federal Commissioner for Internal Affairs, being of the opinion that CARL L. LANGFORD at present in Nigeria ought to be classified as a prohibited immigrant and acting under the powers conferred upon me by section 18 (2) of the Immigration Act 1963 hereby order the said CARL L. LANGFORD to be deported from Nigeria by the first available means and direct that the said CARL L. LANGFORD shall thereafter remain out of Nigeria.

This order may be cited as the CARL L. LANGFORD Deportation Order 1974.
