(iii) Takes command of the entire state for the mobilisation of all appliances therein, on any out-break of fire ;

(iv) Maintains overall discipline, welfare of personnel, administration development of appliances ;

(v) Recruitment of personnel and arrange external training for senior officers ; and

(vi) Any other duties that may be assigned to him by the Chief Fire Officer.

(c) *Senior Divisional Fire Officer : (Former Higher Fire Officer)*—(i) Responsible for all matters concerning fire incident reports and statistics ;

(ii) Operational Orders and instructions ;

(iii) Personnel matters, and ascertaining the need for both local and external training ;

(iv) Preparation of syllabus and advising and training methods ; and

(v) Any other duties that may be assigned to him by the Chief Fire Officer.

4. *Conditions of Service.*—Appointment is either on permanent and pensionable terms or on Contract terms. New entrants, if appointed on permanent and pensionable terms, will be on probation for 2 years. A contract appointment which is renewable on mutual agreement may be negotiated.
