Decree (Extension of Operations) Notice 1978**

In exercise of the powers conferred by section 1 (3) of the Statutory Corporations etc. (Special Provisions) Decree 1969 and of all other powers enabling it in that behalf, the Federal Executive Council hereby gives the following Notice :—

1. Section 1 (2) of the Statutory Corporations, etc. (Special Provisions) Decree 1969 is hereby amended by the addition thereto of the following companies—
