INCOMES POLICY GUILDELINES 1979-80

The Federal Military Government has directed the implementation of the Guidelines on wages and salaries, fringe benefits, professional incomes, dividends and prices for the 1979-80 financial year. Accordingly, pursuant to Section 4 (5) of Decree No. 30 of 1977, the Productivity, Prices and Incomes Board hereby gives the following Public Notice :--

A. PROFESSIONAL INCOMES GUIDELINES :

(i) During the period 1st April, 1979 to 31st March, 1980, there should be no increase in the remunerations (i.e. fees, allowances and other perquisites whether in cash or kind) of non-executive members of Boards in both private and public sectors.

(ii) Remunerations paid to non-executive Board members whether in the public or private sector should be subject to with-holding tax.

(iii) The Government's rates for professional services such as 'those provided by Architects, Estate Managers, Locum Medical Doctors, Engineers—Civil, Mechanical and Electrical, Quantity Surveyors, etc. should not be exceeded throughout the economy i.e. in both public and private sectors.

(iv The fees, charges and retainers paid by public and private sector organisations, to professional firms and self-employed professionals or for rentals and maintenance of machines and equipment should not be higher than those of 1978-79 financial year.

(v) For the accounting and auditing sub-sectors, in no case should the scale rates for fees charged by accounting firms or auditing firms in the 1979-80 financial year be higher than in the preceding one.

(iv) The payment of fees, charges, retainers higher than those implied in (iii)-(v) above will not be accepted by Internal and Inland Revenue Departments as expenses for tax purposes.

B. DIVIDEND GUIDELINES :

(i) During the period 1st April, 1979 to 31st March, 1980 dividends up to 50 per cent of profit-after-tax may be declared/distributed.

(ii) The issue of scrips based on increase in reserves derived from a revaluation of assets is forbidden.

(iii) Companies should submit to the Chairman, Productivity, Prices and Incomes Board, Cabinet Office, the following items of information :

(a) Equity capital as at 30th September, 1976;

(c) Changes in Equity Capital since 30th September, 1976—give specific date of changes and indicate increases not due to scrip issues.

(d) Total dividends distributed in 1976-77, and 1977-78 and 1978-79.

(e) Reserves.

(f) Any other mater of relevance.

C. PRICE GUIDELINES :

(i) Importers of all heavy, industrial machinery for re-sale should not apply a mark-up of more than 25 per cent to the landed cost. Other local costs may be added as was the practice in 1978-79—further details will be supplied on application.

(ii) The rates charged for advertisement in the media as well as fees and commissions charged by Advertisement Agencies should not be increased during the period 1st April, 1979 to March 31, 1980.

(*iii*) Importers/dealers in motor spare parts should not apply a factor of more than 2.5 to the CIF. Other local costs—the details of which will be supplied on application—may be added to arrive at the selling price.

(iv) Increases in prices should be effected or allowed where it is shown that increases in costs cannot be absorbed by a company without undesirable consequences to it. Increases will be allowed only after it has been proved that establishments have not contravened the provisions of the 1978-79 and 1979-80 Incomes Policy Guidelines.

(v) Importers/Manufacturers of items under Resale Price Maintenancea rrangements must give eight weeks' notice of intention to increase prices to the Price Intelligence Agency.

(vi) Establishments that grant increases in wages, salaries or fringe benefits shall not pass on the increase to consumers in higher prices.

D. RENTS :

Rents on office and commercial accommodations must not be increased during the period April 1, 1979 to March 31, 1980.

E. WAGES, SALARIES AND FRINGE BENEFITS :

As far as senior employees on grade level 07 and above are concerned there will be no salary increase in the 1979-80 financial year. Furthermore, motor basic allowance has been abolished but 50 per cent of the annual basic allowance will be added to their salary on a once-and-for-all basis. The employees referred to above cover both the public and the private sector ones of equivalent grades. For other categories of employees, the permissible limits approved have been made known in briefings with employers' and workers' representatives. On no account should these limits be exceeded.

F. CERTIFICATION :

Auditors' reports on the accounts of companies and other institutions must contain statements as to whether or not the provisions of the Incomes Policy Guidelines as specified above, have been adhered to.

Penalty.—Failure to comply with the provisions of the guidelines will be punished under section 5 (2) of Decree No. 30 of 1977.
