

APPROPRIATION (1978-79) DECREE 1979



Decree No. 11

[1st April 1978]

Commence-
ment.

THE FEDERAL MILITARY GOVERNMENT hereby decrees as follows :—

1.—(1) The Accountant-General of the Federation may, when authorised to do so by warrants signed by the Federal Commissioner for Finance, pay out of the Consolidated Revenue Fund of the Federation during the year ending on 31st March 1979 the sums specified by the warrants, not exceeding in the aggregate six billion, eight-hundred and fifteen million, one hundred and ninety-eight thousand, eight hundred and ten naira.

Issue and appropriation of ₦6,815,198,810 from the Consolidated Revenue Fund for 1978-79.

(2) The amount mentioned in the foregoing subsection shall be appropriated to heads of expenditure as indicated in the Schedule to this Decree.

(3) No part of the amount aforesaid shall be issued out of the Consolidated Revenue Fund of the Federation after the end of the year mentioned in subsection (1) of this section.

2. This Decree may be cited as the Appropriation (1978-79) Decree 1979 and shall be deemed to have come into force on 1st April 1978.
