## The Election Tribunals (Appointments) Notice 1979

*Commencement : 2nd July 1979*

In exercise of the powers conferred on the Chief Justice of Nigeria by subsection (1) of section 108 of the Electoral Decree 1977, the following appointments are hereby made and the following Notice is accordingly issued :—

1. This Notice may be cited as the Election Tribunals (Appointments) Notice 1979, and shall come into force on the 2nd day of July 1979.

2. The persons named in the Second Column of the Schedule to this Notice opposite the particular State named in the First Column of the Schedule are hereby appointed, with effect from the 2nd day of July 1979, as chairmen and members respectively (as indicated in the Second Column) of the Election Tribunal for that State.
