The Election Tribunals (Appointments) (No. 4) Notice 1979

UNIVERSITY OF BENIN (TRANSITIONAL PROVISIONS)
DECREE 1975

(1975 No. 20)

University of Benin (Provisional Council) (Amendment)
Order 1979

Commencement : 26th June 1979

In exercise of the powers conferred by section 2 (2) of the University of Benin (Transitional Provisions) Decree 1975, and of all other powers enabling him in that behalf, the Head of the Federal Military Government hereby makes the following order :—

Amendment
of L.N. 66
of 1975.

1. Paragraph (h) of the University of Benin (Provisional Council) Order 1975 (which provides for representation in the Provisional Council of the Federal Ministry of Health and Social Welfare) shall cease to have effect and is hereby accordingly revoked.

2. This order may be cited as the University of Benin (Provisional Council) (Amendment) Order 1979.
