An Act to Amend the Nigerian Pilgrims Board Act 1975

(Presented by Representative Alhaji A. Tuggar)\*

## EXPLANATORY NOTE

(This note does not form part of the above Act but is intended to explain its purpose)

The Act amends the Pilgrims Board Act 1975 and provides for one body to look after all Nigerian Pilgrims who make Pilgrimages to any part of the world. It further provides for the enlargement of the board to accommodate representatives from all religious faiths.

2. The Act does not make it obligatory for the board to uplift passengers by the Nigeria Airways only.
