#### TERMS OF REFERENCE

To interprete the Award of the Industrial Arbitration Panel with regard to the following :-

(i) "That Traffic Assistants should not be promoted to the Inspectorate Cadre but that they should look for promotion in the Traffic and Commercial Officer Cadre.

(ii) That Commercial Supervisor, Train Supervisor and Traffic Supervisor should be redesignated "Traffic Inspector (Commercial)", "Traffic Inspector (Train)" and Traffic Inspector respectively and upgraded to Grade Level 09 with effect from 1-4-80 as contained in paragraph 13 at page 14 of the Award.
