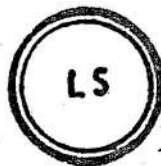

FEDERAL SECRETARIAT COMPLEX, IKOYI

The Federal Secretariat Complex consists of two main giant-twin-12 storey multi-dimensional buildings known as Block I and Block II. There are five other small buildings namely : Staff Canteen or Restaurant and Maintenance Workshop and three offices. The entire complex occupies an area of 48,169 square metres while the two main buildings occupy an area of 3,066 square metres each.

2. The area to be cleaned *internally*, consists of the foyers, corridors, lobbies, balconies, verandahs, stair-cases, etc. covering an area of 10,656 square metres in each Block.

3. The ground and premises to be cleaned, maintained and beautified with flowers, etc. cover an area of 10,405 square metres. For the purpose of single-block-quotation, the area covered by the premises and grounds of Block I is 24,119 square metres and 24,050 square metres for Block II.
