Now Therefore, I, Major-General Solomon Omojokun, Minister of Employment, Labour and Productivity in exercise of the powers conferred upon me by section 10 (1) of the Trade Disputes Act, 1976, refer the dispute to the National Industrial Court with the terms of reference indicated overleaf to make award, having regard to the circumstances of the dispute, and such other matters pertaining thereto or thereform as the National Industrial Court may deem necessary.
