

APPROPRIATION DECREE 1985



Decree No. 2

[20th February 1985]

Commence-
ment.

THE FEDERAL MILITARY GOVERNMENT hereby decrees as follows :—

1.—(1) The Accountant-General of the Federation may when authorised to do so by warrants signed by the *Minister of Finance* pay out of the Consolidated Revenue Fund of the Federation during the financial year ending 31st December 1985 the sums specified by the warrants, not exceeding in the aggregate Six Billion, Seven Hundred and Seventy-two Million, Three Hundred and Forty-two Thousand, Six Hundred and fifty-nine Naira.

Issue and appropriation of ₦6,772,342,659 from the Consolidated Revenue Fund for 1985.

(2) The amount mentioned in subsection (1) of this Decree shall be appropriated to heads of expenditure as indicated in the Schedule to this Decree.

(3) No part of the amount aforesaid shall be issued from the Consolidated Revenue Fund of the Federation after the end of the year mentioned in subsection (1) of this section.

2. This Decree may be cited as the Appropriation Decree 1985.

EXPLANATORY NOTE

*(This note does not form part of this Decree but is
only intended to explain its effect)*

The Appropriation Decree 1985 (for the period 1st January to 31st December, 1985) provides for the issue from the Consolidated Revenue Fund of the Federation of a total sum of ₦6,772,342,659 out of which the sum of ₦5,473,142,910 is for Recurrent Expenditure including Consolidated Revenue Fund Charges while the balance of ₦1,299,199,749 is the contribution to the Development Fund for Capital Projects.
