

To inquire into the trade dispute existing between the National Union of Banks, Insurance and Financial Institutions Employees and Nigeria Employers Association of Banks, Insurance and Allied Institutions on behalf of American International Insurance Company Limited over the following points :—

- (i) Illegal and unreasonable rationalisation ;
- (ii) Breach of the junior staff Collective Agreement in respect of Part I, Article 8 and Part II, Section 1, Article 5 ;
- (iii) Refusal to consult with the union ;
- (iv) Armed Police seige on the Premises of American International Insurance Company Limited'.

and to make such award, having regard to the circumstances of the dispute and such other matters pertaining thereto or arising therefrom as the Industrial Arbitration Panel may deem necessary.
