Non-Academic Staff Union of Educational and Association Institutions (NASU) and the Permanent Secretary, Edo State Universal Basic Education Board (EUBEB).	<p>Consequent upon the findings, the Tribunal make the following award in favour of the 1st Party.</p> <p>(a) A declaration that the 1st Party is the Union with the jurisdiction scope to unionise the non-academic staff of the 2nd Party.</p> <p>(b) A declaration that it is only the 1st Party and not any other trade union that is entitled to the remittance and payment of check-off dues deducted from the salaries of the non-academic staff of the 2nd Party.</p> <p>(c) An order mandating and compelling the 2nd Party to remit to the 1st Party the check-off dues deducted from the salaries of the non-academic staff in its employment since February, 2013.</p>
