Definitions **“2. In these Regulations, unless the context requires otherwise —**

(a) “Log Book” means a book to be used by a Deputy Electoral Officer for recording of events occurring within the voting facility which he has been appointed to supervise;

(b) “occurrence book” means a book to be used by an Electoral Officer at the polling station for which he has been appointed, and his determination of such events, and any action taken by him;

- (c) “voting facility” means a separate place, within a polling station, containing voting arrangements for the purpose of facilitating voting.”;
- (b) in regulation 3(3), by repealing paragraph (h) and substituting therefor, the following paragraph —

1. These regulations may be cited as the Elections (Conduct of Registered Political Parties and Candidates during Election) Regulations, 2020. Citation

2. These regulations shall apply — Application

(a) to every registered political party who have nominated candidates at an election and to every nominated candidate;

(b) from the date of publication of the list of candidates under paragraph 32 of Schedule 3 of the Elections Act (Cap 262) to the date of publication of notice of result of election in *Gazette* under section 38(2) of the Act.

3. Every registered political party and every candidate to an election shall — General Conduct

(a) support and promote the conduct of free and fair election, and in so doing shall maintain the public confidence in the electoral process and ensure that the democratic rights of the citizens of Seychelles are not compromised;

(b) conduct themselves in such manner so as to

uphold the integrity of the electoral process and public respect therefor;

- (c) not engage in any conduct that is unfair or unacceptable by reasonable, fair-minded and informed persons; and
- (d) not commit any action or omission which may compromise the secrecy of ballot.

4. Every registered political party and every candidate, during the electoral campaign, shall —

- (a) conduct their electoral campaigns in peaceful manner and shall not do any act or omission which creates tension or promotes violence;
- (b) not use improper or provocative innuendo or statement, whether written or verbal in respect of another registered political party or candidate;
- (c) not interfere with electoral campaign of other registered political party or candidate;
- (d) not use, or threaten to use any force, violence or restraint, or inflict or threaten to inflict, any form of injury, harm or loss to another candidate, whether directly or indirectly, in person or through another person;
- (e) report to the Electoral Commission and Police, the commission of any offence under the Elections Act (Cap 262) which comes to their notice;
- (f) persuade their supporters against playing of loud music around any polling station or causing any other form of disturbance;

- (g) not set up election camps or checkpoints or offer or give refreshment to voters.

5. Any agent of a registered political party or candidate transporting any incapacitated voter shall not enter the polling station with them or loiter them.

6.(1) Any notice, advertisement, announcement, or material affixed and displayed by a registered political party or candidate shall be only on billboard erected at a place authorised by the Road Transport Commissioner.

(2) Any notice, advertisement, announcement, or material shall not be pasted on any wall, building, road, pavement, telephone or electric poles, fence whether on public or private property.

(3) The maximum size of a billboard shall be 4ft. by 8ft. and a poster shall be of an A2 size glued on plywood or board of the same size to be affixed on a pole.

(4) Only one poster per candidate shall be affixed on a pole.

(5) The billboards erected by the Seychelles Land Transport Agency shall not be used.

(6) The billboards or posters —

(a) shall not be erected or pasted prior to acceptance of the nomination papers of the candidate; and

(b) may be erected or pasted only after 6pm in a day after the nomination paper of the candidate is accepted,

under section 15 of the Elections Act (Cap 262).

(7) All billboards and posters shall be removed, as soon as possible after an election, and in any case within

fourteen days of the close of the poll in an election or referendum in accordance with regulation 13(2)(b) of the Town and Country Planning (Control of Advertisements) Regulations (*S.I. 131 of 1971*) made under the Town and Country Planning Act (*Cap 237*).

2. In these regulations, unless the context otherwise requires — Interpretation

“designated email” means an email address designated by the Chief Valuation Officer in accordance with regulation 3(2);

“document” means a certified true copy of the original document or instrument and includes the copy of an agreement of sale, lease agreement or title deed;

“Minister” means the Minister responsible for finance;

“valuation form” or “form” means Form D in Schedule 1 to the Act;

“working day” means a day of week excluding Saturday, Sunday or a public holiday.

Valuation form may be submitted via electronic medium

3.(1) A taxpayer who is required to submit a valuation form to the Chief Valuation Officer may submit the valuation form by sending the form to the designated email or to such other electronic medium that the Chief Valuation Officer determines.

(2) The Chief Valuation Officer shall designate an email address or any other electronic medium, by notice published in the Gazette, where a taxpayer may submit a valuation pursuant to section 15(3) of the Act.

Lodging of documents electronically for the purpose of valuation of immovable property

4.(1) Subject to regulation 6, a taxpayer may submit a valuation form to the email address or electronic medium designated by the Chief Valuation Officer in order to obtain a notice of acceptance of valuation.

(2) The valuation form, set out in Form D in Schedule 1 to the Act, and any accompanying document submitted electronically to the Chief Valuation Officer shall have the same effect as if the application and any accompanying document were submitted to the Chief Valuation Officer in hardcopy.

(3) A taxpayer shall —

- (a) complete Form D and attach any relevant document;
- (b) sign Form D or any other document, if required;
- (c) affix any digital signature, where applicable; and
- (d) upload or scan and send Form D and other relevant document to the designated email address or electronic medium.

(4) The Chief Valuation Officer shall acknowledge the receipt of a valuation form submitted pursuant to subregulation (1) within 7 working days.

(5) Where a taxpayer has not received an acknowledgement from the Chief Valuation Officer pursuant to subregulation (4), it shall be the duty of that taxpayer to re-submit the valuation form to the Chief Valuation Officer.

5.(1) The Chief Valuation Officer may, for the purposes of assessing a valuation form, rely on any document or information available to the Chief Valuation Officer.

Procedure to be followed by the Chief Valuation Officer in assessing a valuation form

(2) Subject to any other written law, all valuation forms and accompanying documents submitted by a taxpayer to the Chief Valuation Officer shall be stored in such format as the Chief Valuation Officer may determine for future reference.

(3) On completion of the assessment of a valuation form, the Chief Valuation Officer may issue a notice of acceptance of valuation pursuant to section 15(5) of the Act by sending the notice of acceptance of valuation to the email address of the person who submitted the valuation form under regulation 4.

(4) Notwithstanding subregulation (3), a taxpayer may obtain a hardcopy of the notice of acceptance of valuation by making a request to the Chief Valuation Officer —

- (a) to collect the notice of acceptance of valuation from the office of the Chief Valuation Officer; or
- (b) to receive the notice of acceptance of valuation by post in Seychelles or any other country by paying such fees as determined by the Chief Valuation Officer.

Deadline to submit applications via email

6. A taxpayer may submit the valuation form to the designated email address or electronic medium any time before the end of the 30th day of November, 2020 (Seychelles time).

S.I. 141 of 2020**ELECTIONS ACT***(Cap 262)***Elections (Conduct of Registered Political Parties and Candidates during Election) Regulations, 2020**

In exercise of the powers conferred by section 99 of the Elections Act, the Electoral Commission hereby makes the following regulations —

1. These regulations may be cited as the Elections (Conduct of Registered Political Parties and Candidates during Election) Regulations, 2020. Citation

2. These regulations shall apply — Application
 - (a) to every registered political party who have nominated candidates at an election and to every nominated candidate;
 - (b) from the date of publication of the list of candidates under paragraph 32 of Schedule 3 of the Elections Act (Cap 262) to the date of publication of notice of result of election in *Gazette* under section 38(2) of the Act.

3. Every registered political party and every candidate to an election shall — General Conduct
 - (a) support and promote the conduct of free and fair election, and in so doing shall maintain the public confidence in the electoral process and ensure that the democratic rights of the citizens of Seychelles are not compromised;
 - (b) conduct themselves in such manner so as to

uphold the integrity of the electoral process and public respect therefor;

- (c) not engage in any conduct that is unfair or unacceptable by reasonable, fair-minded and informed persons; and
- (d) not commit any action or omission which may compromise the secrecy of ballot.

4. Every registered political party and every candidate, during the electoral campaign, shall —

- (a) conduct their electoral campaigns in peaceful manner and shall not do any act or omission which creates tension or promotes violence;
- (b) not use improper or provocative innuendo or statement, whether written or verbal in respect of another registered political party or candidate;
- (c) not interfere with electoral campaign of other registered political party or candidate;
- (d) not use, or threaten to use any force, violence or restraint, or inflict or threaten to inflict, any form of injury, harm or loss to another candidate, whether directly or indirectly, in person or through another person;
- (e) report to the Electoral Commission and Police, the commission of any offence under the Elections Act (Cap 262) which comes to their notice;
- (f) persuade their supporters against playing of loud music around any polling station or causing any other form of disturbance;

- (g) not set up election camps or checkpoints or offer or give refreshment to voters.

5. Any agent of a registered political party or candidate transporting any incapacitated voter shall not enter the polling station with them or loiter them.

6.(1) Any notice, advertisement, announcement, or material affixed and displayed by a registered political party or candidate shall be only on billboard erected at a place authorised by the Road Transport Commissioner.

(2) Any notice, advertisement, announcement, or material shall not be pasted on any wall, building, road, pavement, telephone or electric poles, fence whether on public or private property.

(3) The maximum size of a billboard shall be 4ft. by 8ft. and a poster shall be of an A2 size glued on plywood or board of the same size to be affixed on a pole.

(4) Only one poster per candidate shall be affixed on a pole.

(5) The billboards erected by the Seychelles Land Transport Agency shall not be used.

(6) The billboards or posters —

(a) shall not be erected or pasted prior to acceptance of the nomination papers of the candidate; and

(b) may be erected or pasted only after 6pm in a day after the nomination paper of the candidate is accepted,

under section 15 of the Elections Act (Cap 262).

(7) All billboards and posters shall be removed, as soon as possible after an election, and in any case within

fourteen days of the close of the poll in an election or referendum in accordance with regulation 13(2)(b) of the Town and Country Planning (Control of Advertisements) Regulations (*S.I. 131 of 1971*) made under the Town and Country Planning Act (*Cap 237*).

7.(1) Easily removable cloth banners shall be used as much as possible instead of pasted posters.

(2) Cloth banners shall be used only where necessary and they shall be displayed upon approval of the Seychelles Land Transport Authority and the Police (Traffic section).

(3) Subregulation (2) does not apply to temporary banners at rally sites.

(4) All cloth banners shall be removed as soon as possible, after an election, and in any case within fourteen days after the close of the poll in an election or referendum.

8.(1) Every candidate nominated under section 15 of the Elections Act (*Cap 262*) shall —

(a) in case of the Presidential Election, be provided with a certified copy of the register of voters of each electoral area; and

(b) in case of the National Assembly Election, be provided with a certified copy of the register of voters for the respective electoral area in which they are contesting.

(2) The copy of register of voters shall be provided by the Electoral Commission free of charge.

(3) Only one copy of the register of voters shall be provided to every candidate.

In exercise of the powers conferred by section 99(1) of the Elections Act, the Electoral Commission hereby makes the following regulations —

1. These regulations may be cited as the Elections (Procedures) (Amendment) Regulations, 2020.

Citation

2. The Elections (Procedures) Regulations, 2016 are hereby amended as follows —

Amendments of

(a) by repealing regulation 2 and substituting therefor, the following regulation —

Definitions **“2.** In these Regulations, unless the context requires otherwise —

(a) “Log Book” means a book to be used by a Deputy Electoral Officer for recording of events occurring within the voting facility which he has been appointed to supervise;

(b) “occurrence book” means a book to be used by an Electoral Officer at the polling station for which he has been appointed, and his determination of such events, and any action taken by him;

- (c) “voting facility” means a separate place, within a polling station, containing voting arrangements for the purpose of facilitating voting.”;
- (b) in regulation 3(3), by repealing paragraph (h) and substituting therefor, the following paragraph —
- “(h) the Electoral Officer shall place such number of ballot booklets as he deems fit, in numerical sequence, in the secured custody of the Deputy Electoral Officer, who shall return such ballot booklets to the Electoral Officer one by one, in numerical sequence, for issuing to an Assistant Electoral Officer for issuing of ballot papers to voters and upon each issuance, entries thereof shall be made in the Occurrence Book, specifying the serial number of each ballot booklet, time of issue and signed by the receiving Deputy Electoral Officer or Assistant Electoral Officer, as the case may be, whose name shall be recorded on the cover of each ballot booklet;”;
- (c) in regulation 9, by repealing paragraph (a);
- (d) by inserting after regulation 9, the following regulation —

“**9A.** A Deputy Electoral Officer shall provide assistance to the Electoral Officer and perform such functions as directed by the Electoral Officer, which may include —

- (a) supervising and coordinating voting and the work of Assistant Electoral Officers within one voting facility;
- (b) having custody over ballot papers once issued by the Electoral Officer and until issued to an Assistant Electoral Officer;
- (c) providing assistance to incapacitated voters in accordance with section 25(3) of the Elections Act;
- (d) setting up the polling station as per instructed lay-out and guidelines issued by the Electoral Commission;
- (e) providing assistance to the Electoral Officer in complying with section 29 of the Elections Act;
- (f) remaining present at the polling station for the entire hours of poll and ensuring that the respective voting facilities are opened and closed on time;
- (g) recording in the Log Book of any incidents occurring at the voting facility under his supervision.”;

- (e) in regulation 14 —
- (i) in subregulation (10), by repealing the words “Election Commission shall”, and substituting therefor the words “Chief Electoral Officer shall, in respect of electoral areas of Praslin and Inner Islands,”;
- (ii) by inserting after subregulation (10), the following subregulation —

“(11) The Chief Electoral Officer shall, in respect of electoral areas of Mahe, classify the envelopes and shall, prior to opening of poll, distribute them to the respective Electoral Officers appointed for each of the electoral areas for counting along with the counting of other votes for that electoral area.”.

S.I. 143 of 2020**IMMOVABLE PROPERTY TAX ACT***(2019)***Immovable Property Tax (Submission of Valuation Form) (Temporary Measures) Regulations, 2020**

In exercise of the powers conferred by section 28 of the Immovable Property Tax Act, the Minister responsible for finance makes the following regulations —

1. These regulations may be cited as the Immovable Property Tax (Submission of Valuation Form) (Temporary Measures) Regulations, 2020.

Citation

2. In these regulations, unless the context otherwise requires —

Interpretation

“designated email” means an email address designated by the Chief Valuation Officer in accordance with regulation 3(2);

“document” means a certified true copy of the original document or instrument and includes the copy of an agreement of sale, lease agreement or title deed;

“Minister” means the Minister responsible for finance;

“valuation form” or “form” means Form D in Schedule 1 to the Act;

“working day” means a day of week excluding Saturday, Sunday or a public holiday.

Valuation form may be submitted via electronic medium

3.(1) A taxpayer who is required to submit a valuation form to the Chief Valuation Officer may submit the valuation form by sending the form to the designated email or to such other electronic medium that the Chief Valuation Officer determines.

(2) The Chief Valuation Officer shall designate an email address or any other electronic medium, by notice published in the Gazette, where a taxpayer may submit a valuation pursuant to section 15(3) of the Act.

Lodging of documents electronically for the purpose of valuation of immovable property

4.(1) Subject to regulation 6, a taxpayer may submit a valuation form to the email address or electronic medium designated by the Chief Valuation Officer in order to obtain a notice of acceptance of valuation.

(2) The valuation form, set out in Form D in Schedule 1 to the Act, and any accompanying document submitted electronically to the Chief Valuation Officer shall have the same effect as if the application and any accompanying document were submitted to the Chief Valuation Officer in hardcopy.

(3) A taxpayer shall —

- (a) complete Form D and attach any relevant document;
- (b) sign Form D or any other document, if required;
- (c) affix any digital signature, where applicable; and
- (d) upload or scan and send Form D and other relevant document to the designated email address or electronic medium.

(4) The Chief Valuation Officer shall acknowledge the receipt of a valuation form submitted pursuant to subregulation (1) within 7 working days.

(5) Where a taxpayer has not received an acknowledgement from the Chief Valuation Officer pursuant to subregulation (4), it shall be the duty of that taxpayer to re-submit the valuation form to the Chief Valuation Officer.

5.(1) The Chief Valuation Officer may, for the purposes of assessing a valuation form, rely on any document or information available to the Chief Valuation Officer.

Procedure to be followed by the Chief Valuation Officer in assessing a valuation form

(2) Subject to any other written law, all valuation forms and accompanying documents submitted by a taxpayer to the Chief Valuation Officer shall be stored in such format as the Chief Valuation Officer may determine for future reference.

(3) On completion of the assessment of a valuation form, the Chief Valuation Officer may issue a notice of acceptance of valuation pursuant to section 15(5) of the Act by sending the notice of acceptance of valuation to the email address of the person who submitted the valuation form under regulation 4.

(4) Notwithstanding subregulation (3), a taxpayer may obtain a hardcopy of the notice of acceptance of valuation by making a request to the Chief Valuation Officer —

- (a) to collect the notice of acceptance of valuation from the office of the Chief Valuation Officer; or
- (b) to receive the notice of acceptance of valuation by post in Seychelles or any other country by paying such fees as determined by the Chief Valuation Officer.

Deadline to submit applications via email

6. A taxpayer may submit the valuation form to the designated email address or electronic medium any time before the end of the 30th day of November, 2020 (Seychelles time).

Notice of valuation may be sent by email

7. The Chief Valuation Officer may issue a notice of valuation pursuant to section 18 of the Act by sending the notice of valuation to the email address of the person who submitted the valuation form under regulation 4.

Immunity from suit

8. The Chief Valuation Officer is not liable to any action or suit in respect to any act or omission under these regulations.

Duration of this law

9. These regulations shall remain in force until repealed or amended by the Minister, or they shall expire at the end of 31 January, 2021.
