SEYCHELLES INVESTMENT ACT

(Act 31 of 2010)

Seychelles Investment (Economic Activities) Regulations, 2022

In exercise of the powers conferred by section 30 of the Seychelles Investment Act, 2010, the Minister responsible for Investment, makes the following regulations —

Citation

These Regulations may be cited as the Seychelles Investment 1. (Economic Activities) Regulations, 2022.

Interpretation

In these Regulations, unless the context otherwise requires — 2.

> "economic needs test" means a process by which the Seychelles Investment Board carries out an assessment to evaluate applications by non-Seychellois to carry out activities, in which a non-Seychellois may wish to invest, based on a needs test, keeping in view the development of the economic activity in Seychelles, to the extent it may be considered in the interest of the domestic economy and consumers;

> "foreign equity" means an investment in any economic activity made by a non-Seychellois, directly or indirectly in return for beneficial ownership, shareholding and management control;

> "maritime cabotage service" means transportation of passengers or goods between ports located in Seychelles and such transportation originating and terminating in Seychelles provided that it remains within Seychelles territorial waters;

"N.E.C" means not elsewhere classified;

"Non-Seychellois" has the same meaning assigned to it in the Immovable Property (Transfer Restriction) Act, 1963 (Cap 95) and includes an association which is —

- (a) (i) registered under the Associations Act, 2022; or
 - (ii) unincorporated,

of which any of its members is not a citizen of Seychelles;

(b) incorporated or established under the laws of a country or jurisdiction other than Seychelles;

"one cover" means table setting for one person;

"reserved economic activity policy" means the list of activities prepared in accordance with the Reserved Economic Activity Policy in which any investment may be made only by a Seychellois;

Open and restricted economic activities

3.(1) The economic activities listed in the First Schedule to these Regulations are the activities in which investment may be made by a non-Seychellois.

(2) The economic activities listed under column (1) of the Second Schedule to these Regulations are the activities in which a non-Seychellois may invest jointly with a person who is not a non-Seychellois, to the extent of the limit specified in the corresponding entry under column (2) of that Schedule.

(3) Any economic activity not listed in the First Schedule and the Second Schedule to these Regulations, the Reserved Economic Activity Policy or any other investment regulation shall be subjected to the economic needs test.

(4) The operations of any economic activity shall be subjected to the laws of Seychelles.

 - *(iv)* Other services auxiliary of financial intermediation;
 - (v) Loan broking services;
 - (vi) Financial consultancy services;
 - (vii) Foreign exchange services;
 - (viii) Coin and currency packing services;
 - *(ix)* Other services auxiliary to financial intermediation N.E.C.
- (k) provision and transfer of financial information, and financial data processing related software by providers of other financial services;
- (l) Private pension funds.

(1) <u>Hospital services</u> —

Hospital services, including hospital management services.

(2) <u>Other human health services</u> —

- (a) Ambulance services;
- (b) Residential health facilities services other than hospital services;
- (c) Other human health services, including services in the field of morphological or chemical pathology, bacteriological, virology and immunology.

(3) <u>Social services:</u>

- (a) welfare services delivered through residential institutions to children and other clients;
- (b) Other social services with accommodation, such as juvenile correctional homes and rehabilitation services for people addicted to drugs and alcohol but not including medical treatment services.

9. TOURISM AND TRAVEL RELATED SERVICES

Hotels and restaurants including catering services:

- (a) hotels and other lodging services with more than 25 rooms;
- (b) letting services of furnished accommodation with more than 25 rooms, excluding rooming, boarding houses and cabins;
- (c) restaurants with more than 21 covers.

10. RECREATIONAL, CULTURAL AND SPORTING SERVICES

(1) <u>Entertainment services including theatre, live bands and</u> <u>circus services</u> —

- (a) Theatrical producer, singer group, band and orchestra entertainment services;
- (b) Services provided by authors, composers, sculptors, entertainers and other individual artists;
- (c) Circus, amusement park and similar attraction services;
- (d) Ballroom, discotheque and dance instructor services.

(2) <u>News agency services</u> —

- (a) News agency services;
- (b) Printed news supply services;
- (c) Picture supply services;
- (d) News-reporting agency services to radio stations;
- (e) News-reporting agency services to television stations;
- (f) News-coverage reporting agency services to television stations;
- (g) Cinema theatre operation services.

(3) <u>Libraries, archives, museums and other cultural services</u> —

Library services, excluding all services provided by the Seychelles National Library.

11. TRANSPORT SERVICES

- (1) (a) <u>Maritime Transport Services (except cabotage service)</u>
 - (i) Transport (freight and passengers);
 - (ii) Passenger transportation by ferries;

- *(iii)* Other passenger transportation including passenger transportation on high seas and on coastal waters by seagoing vessels, on a scheduled or non-scheduled basis, regardless of the class of service, and including passenger accompanying baggage transportation.
- (b) Freight transportation
 - *(i)* Transportation of frozen or refrigerated goods;
 - (ii) Transportation of bulk liquids and gases;
 - (iii) Transportation of containerized freight;
 - (iv) Transportation of other freight.

(2) <u>Services auxiliary to all modes of transport</u> —

- (a) Cargo-handling services
 - *(i)* Container handling services;
 - (*ii*) Other cargo handling services provided that the services provide for non-containerized freight or for passenger baggage. Included are services of freight terminal facilities, on a fee or contract basis, for all modes of transport, including stevedoring services, that is, the loading, unloading and discharging of vessels' non-containerized freight at Ports.
 - *(iii)* cargo handling services incidental to freight transport, N.E.C. Also included are baggage handling services at airports and at bus, rail or highway vehicle terminals.
- (b) Storage and warehouse services
 - (i) Storage services of frozen or refrigerated goods;
 - (ii) Bulk storage services of liquids or gases;
 - *(iii)* Other storage or warehousing services including storage and warehousing services of other goods, including cotton, grain, wool, tobacco, other farm products, and other household goods;
 - (iv) Freight transport agency services.
