 - "(q) For the purpose of subheading 8706.0010, the chassis shall be for Electric Vehicles (EVs) as described in Part II (k) (iv) of these Regulations."
 - (b) in Part III, chapter 87, by repealing HS Code 8706.0000 and its corresponding entries, and substituting it with the following HS Codes and corresponding entries —
