#### Magistrates' Court (Recovery of Government Debts) (Summary Procedure) (Amendment) Rules, 2024

In exercise of the powers conferred by section 44 (2)(f) of the Courts Act, the Chief Justice makes the following rules -

#### Citation

1. These Rules may be cited as the Magistrates' Court (Recovery of Government Debts) (Summary Procedure) (Amendment) Rules, 2024.

#### Amendment of rule 2

2. Rule 2 of the Magistrates' Court (Recovery of Government Debts) (Summary Procedure) Rules is amended by repealing the definition of the term "the government" and substituting it with the following definition —

" "Government" means the Government of Seychelles, an agency of the Government and any public body that is directly and wholly provided or funded from monies appropriated from the consolidated fund under an Appropriation Act."

#### Amendment of rule 3

**3.** Rule 3 of the Magistrates' Court (Recovery of Government Debts) (Summary Procedure) Rules is amended by deleting the sum "Rs.2000" and substituting it with the sum "SCR50,000".
