LAW COMMISSION ACT, 2022

(Act 16 of 2022)

Laws of Seychelles (Rectification) Notice, 2024

In exercise of the powers conferred by section 28 (3) of the Law Commission Act 2022, the Law Commission hereby makes the following rectification of error in the Revised Edition (2010) of the Laws of Seychelles —

1. In Chapter 103 of the Revised Edition (2010) of Laws of Seychelles relating to the Interpretation and General Provisions Act, —

Section 68 subsection (2) shall be substituted after paragraph (b) of subsection (1) and before paragraph (a) of subsection (2) as rectified by Laws of Seychelles (Rectification) Notice, 2020,

“(2) The power under an Act to make statutory instruments may be exercised,”

2. In consequence of the Laws of Seychelles (Rectification) Notice, 2020, published in Gazette No.21 of 24th February, 2020, Gazette Notice No. 135 of 2020, the Statute Law Revision (Miscellaneous Amendments Act, 2021 (Act 29 of 2021) (which amended section 68(1)(b) of the Interpretation and General Provisions Act) and this Notice, section 68 of the Interpretation and General Provisions Act shall be read as follows —

“Power to make statutory instrument.

[2/11/1982 & Act 29 of 2021]

68.(1) Statutory instruments made under an Act may —

- (a) Constitute offences; and
- (b) Provide, in respect of any such offence, for the imposition by way of penalty of a fine of level 3 on the standard scale or imprisonment for a term not exceeding two years;

(2) The power under an Act to make statutory instruments may be exercised —

- (a) Either in relation to all cases to which the power extends, or in relation to all of those cases subject to specified exceptions or in relation to any specified case or class of case; and
- (b) So as to make, as respects the cases in relation to which it is exercised, —
 - (i) The same provision for all the cases, a different provision for different cases or classes of cases, or different provisions for the same case or classes of cases for different purposes of the Act; or
 - (ii) Any such provision either unconditionally or subject to any specified condition.”
