

1. Introduction

This quarterly report has been prepared in accordance with the Public Financial Management Act, 2016.

2. Basis of Presentation

This report has been prepared using the actual revenue and expenditure of the Consolidated Fund and central Government. The accompanying Statement of Receipts and Payments includes budget for the period January to December 2022 and actuals for quarters 1 to 4 of the year 2022 compared to budget for the same year. The report is broadly prepared in the form of a statement, which categorises revenue and expenses followed by analysis of revenue by the various streams and expenditure by Ministries, Departments, Projects and Agencies as well as by categories. This report gives an insight of expenditure pattern across the central government. The report is designed to provide the required information needs of various stakeholder.


On a daily basis, budget execution processes are carried out by Ministries, Departments and Agencies in compliance with sections 55 - 65 of the Public Financial Management Act 2016.

The summary management report presented below provides an overview of the financial activities of the central Government for the period ending 31st December 2022, against annual budget.

3. Total Revenue


Total Consolidated revenue collected in quarter 4, 2022 was SLE 4,441,513 thousand, of which SLE 2,488,672 thousand is domestic revenue while SLE 1,952,841 thousand is grant from Development Partners. The chart below illustrates monthly revenue pattern for the quarter ending 31st December, 2022.

Further, the chart below summarises the quarterly revenue between domestic and external for consolidated for quarter 4 of 2022.



4. Domestic Revenue

The consolidated domestic revenues for quarter 4 of 2022, consist of Tax on Income, Profits & Capital Gains which contributed SLE 746,048 thousand or 30% of the total domestic revenue, Customs and Excise Income was SLE34,188 thousand or 1%, Goods and Services Tax (GST) amounted to SLE 373,903 thousand or 15%.

Furthermore, Taxes On International Trade & Transport SLE 290,543 thousand which is 12%, TSA Transfers SLE 229,316 or 9% and other taxes and non-tax revenue SLE 766,706 making 31% of domestic revenue.

5. Expenditure Payments



SLE1,327,415 thousand was spent on Non-Salary, Non-Interest Recurrent Expenditure, SLE1,052,260 thousand on Current transfers and to SLE483,537 thousand on Capital Expenditure and Transfers which included interest on external debt. Total expenses above are those of consolidation.

Finance cost comprises of domestic interest which is SLE446,716 thousand and foreign interest amounted to SLE45,253 thousand. The chart below illustrates the composition of expenditure payments for quarter 4, 2022.

RULING ON THE BASIS OF EVIDENCE

In View of the aforementioned findings, and having carefully watched the demeanours of the witnesses of the two parties, it is clear to all and sundry that the witnesses of the Respondent P.C Yambeh Manasary appeared to have little or no knowledge of these two chiefdoms and were not truthful in their testimonies. They purely based their evidences on hearsay which evidences are not permissible according to law. They were also inconsistent and contradicted each other in their testimonies.

In the circumstances therefore, I have no alternative to rule without fear or favour that the complainant Hon. PC. Balasama Marah III of Shengbe Chiefdom was able and has proved his case beyond all reasonable doubt that the disputed land belongs to Shengbe Chiefdom and not to Wara Wara Yagala Chiefdom.

In the interest of peace and stability and the development of Koinadugu Chiefdom as a whole, the people of Wara Wara Yagala desist from further encroaching into the said land belonging to Shengbe Chiefdom as this will not augur well for the sisterly chiefdoms.

I further rule that the land in question which was flagged as a result of this dispute should be utilized by the people of Shengbe as and when they wish without let or hindrance. The flagging be lifted with immediate effect and please let us give peace a chance for the sake of the development of the Two Chiefdoms.
