PRESCRIPTION OF CERTAIN ACTIVITIES AND EXTENSION OF THE ACT THERETO.

(Under sections 3(1)(m) and 6)

(Commencement: 1st July, 1977,

In exercise of the powers conferred on him by the abovementioned Act, the Honourable Deputy Prime Minister is pleased to prescribed the activities specified in the Schedule hereto and to extend all the provisions of the Act to such activities.

SCHEDULE

- 1. The sorting, grading cleaning and packing of fruits and vegetables on any plantation, as the case maybe, where machinery is used for such purposes and where persons are regularly or seasonally employed for such purposes.
- The repair or maintenance of agricultural machinery, vehicles or appliances on any farm or any estate or in any plantation or forest, as the case maybe, where machinery is used for such purposes and persons are regularly or seasonally employed for such purposes.
- The manufacture, repair or maintenance of machinery equipment or vehicles, in or in connection with transport undertaking where persons are regularly or seasonally employed for such purposes.
- 4. The use of or operation of any agricultural machinery, implements, equipment on any farm or estate or any plantation or forest, as the case maybe, where persons are regularly or seasonally employed for such purposes.

THE HLATIKULU EXTENSION NO. 3 TOWN REGULATIONS 1977

(Under Section 12)

(Commencement: 1st. July, 1977)

The Honourable the Minister for Local Administration is hereby pleased to make the following regulations — Citation.

1. The regulations may be cited as the Hlatikulu Extension No. 3 Town Regulations, 1977.

Establishment of Town and alteration of general plan.

2. (1) The following land is proclaimed and established a town --

Farm No. 1240 situate in the Shiselweni District, 9,0619 (nine comma zero six one nine) hectares in extent, held by the Crown under Certificate of Registered Crown Title No. 97 of 1977 dated 6th April, 1977; comprising 30 (thirty) lots numbered 267 — 296, as will more fully appear from General Plan S.G. No. S. 127/75 approved by the Surveyor General on the 27th November, 1975.

- (2) The Surveyor General shall alter the General Plan so as to indicate the name and lot numbers assigned by these regulations to the town and shall endorse the General Plan of the Township of Hlatikulu and General Plan S.G. No. S.127/75 accordingly:
- (3) The Registrar of Deeds shall --
 - (a) make the necessary endorsement on the relevant title deeds; and
 - (b) open the necessary register in connection with the town.

Applicability of Cap. 77.

3. The provisions of sections 5 to 10, inclusive, of the Hlatikulu Township Proclamation and of the regulations made thereunder shall apply to the Town established by these regulations.
