THE ANIMAL DISEASES ACT, 1965

(No. 7 of 1965)

THE STOCK DISEASES (RABIES) (NO. 13) REGULATIONS 1977

(Under Section 3)

(Commencement: 4th. November, 1977)

In exercise of the powers conferred on him by the above-mentioned Act, the Honourable the Minister for Agriculture is pleased to make the following regulations:-

*Citation:*

1. These regulations may be cited as the Stock Diseases (Rabies) (No. 13) Regulations 1977.

*Declaration of Rabies Guard Areas.*

2. The Dipping Tanks and other areas specified in the Schedule hereto are hereby declared to be Rabies Guard Areas.

*Isolation and Confinement of dogs in the Guard Areas.*

3. Every owner of a dog in any of the Guard Areas shall isolate and confine it so as to prevent it from escaping from such guard areas.

*Destruction of dogs in Rabies Guard Areas.*

4. A Government Veterinary Officer may destroy a dog in any of the Rabies Guard Areas which, in his opinion, has not been confined so as to prevent it from escaping from such guard area.

*Offence and Penalty.*

5. Every owner of a dog in any of the guard areas who contravenes or fails to comply with regulation 3 shall be guilty of an offence and liable to a fine of E300 or imprisonment for a period of six months.

THE CROWN LANDS DISPOSAL ACT

(No. 13 of 1911)

THE MANZINI EXTENSION NO. 5 TOWN REGULATIONS, 1977

(Under Section 12)

(Commencement: 14th October 1977)

The Honourable Minister for Local Administration is hereby pleased to make the following regulations:—

*Citation.*

1. The regulations may be cited as the Manzini Extension No. 5 Town Regulations, 1977.

*Establishment of Town and alteration of General Plan.*

2. (a) The following land is hereby proclaimed and established as a town:—

Certain Portion 3 of Farm No. 1139 situate in the District of Manzini, Swaziland, measuring 7,9132 (seven comma nine one three two) hectares, held by the CROWN under Certificate of Registered Title No. 249/1975 dated the 28th day of August 1975, comprising 24 (twenty four) lots numbered 499 — 522, 4 (four) public places numbered 523 — 526 and roads, as will more fully appear from General Plan S.G. No. S.21/74, approved by the Surveyor-General on the 14th June 1974.

(b) The Surveyor-General shall alter the General Plan so as to indicate the name and lot numbers assigned by these regulations to the town and shall endorse the General Plan of the Township of Manzini and General Plan S.G. No. S.21/74 accordingly.

3. The Registrar of Deeds shall:

(a) make the necessary endorsement on the relevant title deeds, and

(b) open the necessary register in connection with the town.
