THE RABIES NOTICE (HHOHHO DISTRICT) STOCK DISEASE
REGULATIONS 1933.

(Under Regulation 16)

(Commencement: 28th May, 1979)

In exercise of the powers conferred on me by the above-mentioned Regulations I hereby make the following Order:-

1. This Order shall come into operation on the 28th May, 1979.
2. All dogs in the dip tank and other areas in the schedule to this Notice shall be vaccinated against Rabies by means of Flury Strain anti-rabies vaccine.
3. All persons living within such listed areas and owning a dog shall present it at the inoculation centre mentioned in the schedule of this Notice for the purpose of being inoculated by the Director of Veterinary Services or his duly authorised agent during the time mentioned in the schedule.

Citation and Commencement.

1. These Regulations may be cited as the Levy on Milk and Dairy Products (Amendment) Regulations, 1979, shall be read as one with the Levy on Milk and Dairy Products Regulations 1978 and shall come into force on the 1st June, 1979.

Amendment of Regulations.

2. The Levy on Milk and Dairy Products Regulations, 1978 are hereby amended —

(a) in Regulation 3 thereof by inserting the following paragraph immediately after paragraph (3) —

“(4) In respect of coloured margarine —

(a) an administrative levy of 3,80 cents per kilogramme;

(b) a special levy of 0.15 cents per kilogramme.”

(b) by inserting the following new Regulation immediately after Regulation 3 —

“3A. The levies imposed by these Regulations shall become due and payable not later than the 15th day of each month in respect of the sales for the preceding month.”
