

(Act No. 9 of 1979)



I ASSENT SOBHUZA II King of Swaziland

15th November, 1979

AN ACT

entitled

An Act to amend the Income Tax (Consolidation) Order, 1975.

(Date of Commencement: 23rd. November, 1979)

ENACTED by the King and the Parliament of Swaziland.

Short title.

1. This Act may be cited as the Income Tax (Consolidation) (Amendment) Act, 1979, and shall be read as one with the Income Tax (Consolidation) Order, 1975, hereinafter referred to as "the Order".

Amendment of section 2

2. Section 2 of the Order is amended by replacing the first paragraph of the definition "provident fund" with the following –

"provident fund" means a fund other than a pension fund, benefit fund or retirement annuity fund, which is approved by the Commissioner in respect of the year of assessment in question.

Amendment of section 7

3.

- Section 7 of the Order is amended
 - (a) immediately before paragraph (a) by replacing the words "paragraphs
 (a) to (k)" with the words "paragraphs (a) to (1)";
 - (b) by replacing paragraph (d) with the following -

"(d) any amount so received or accrued from another person as premium or like consideration paid by such other person for -

(i) the use or occupation or the right of use or occupation of land or buildings; or

(ii) the use or right of use of plant, machinery, equipment or vehicles; or

(iii) the use or right of use of any motion picture film or any film or video tape or disc for use in connection with television or any sound recording or advertising matter connected with such motion picture film, film or video tape or disc; or

(iv) the use or right of use of any patent, design, trade mark, copyright, or any model, pattern, plan, formula, or process or any property or right of a similar nature; or

(v) the imparting of or the undertaking to impart any scientific, technical, industrial, or commercial knowledge or information for use in Swaziland, or the rendering of or the undertaking to render any assistance or service in connection with the application or utilisation of such knowledge or information";

(c) by replacing paragraph (k) with a new paragraph (k) and by inserting immediately thereafter a new paragraph (1), as follows –

"(k) any amount by way of allowance so received or accrued to a public servant or a Member of Parliament but excluding amounts paid or payable to such persons for reimbursive allowances in terms of General Orders or regulations relating to such allowances;

(1) any amount which in terms of this Order is specifically required to be included in the taxpayer's income".

Amendment of section 11

Ł

- 4. Section 11 of the Order is amended
 - (a) in subsection (1) by inserting immediately after paragraph (f) the following new paragraphs –

 $\ensuremath{^{\prime\prime}}(g)$ the use or right of use in Swaziland of, or the grant of permission to use in Swaziland –

(i) any patent, design, trade mark, copyright, model, pattern, plan, formula, or process or any other property or right of a similar nature; or

(ii) any motion picture film, or any film, or video tape or disc for use in connection with television, or any sound recording or advertising matter used or intended to be used in connection with such motion picture film, film or video tape or disc.

wheresoever such thing or matter as is referred to in sub-paragraph (i) or (ii) has been produced or made, or such right of use or permission has been granted or payment for such use, right of use or grant, of permission has been made or is to be made, and whether such payment has been made or is to be made by a person resident in or out of Swaziland;

(h) the imparting of or the undertaking to impart any scientific, technical, industrial or commercial knowledge or information for use in Swaziland, or the rendering of or the undertaking to render, any assistance or service in connection with the application or utilization of such knowledge or information, wheresoever such knowledge or information has been obtained or such knowledge or information has been imparted or is to be imparted or such assistance or service has been rendered or is to be rendered or any such undertaking has been given, and whether payment for such knowledge, information, assistance, service or undertaking has been made or is to be made by a person resident in or out of Swaziland."

(b) by adding immediately after subsection (9) the following new subsection –

"(10) So much of any amount which has been paid by a company to or otherwise made available for the personal use of a shareholder or director of such company from the company's undistributed profits, reserves or other assets by way of loan, and which amount was not repaid to the company within the year such loan or advantage was obtained, shall be deemed to be part of the taxable income of such shareholder or director for that year:

Provided that this subsection shall not apply to a loan paid to or otherwise made available for use by a shareholder or director which in the opinion of the Commissioner, was made for a purpose directly connected with the business of the company".

Amendment of section 12

5. Section 12 of the Order is amended in subsection (1) by deleting paragraph (ii) of the proviso to paragraph (p).

Amendment of section 14

6. Section 14 (1) of the Order is amended –

(a) in paragraph (e) -

(i) by deleting from subparagraphs (i) and (ii) the words "or any other process which in the opinion of the Commissioner is of a similar nature";

(ii) by inserting the following new paragraph immediately after the second proviso thereto -

"For the purpose of this paragraph, the expression "machinery or plant" does not include motor vehicles intended or adapted for use or capable of being used on roads";

(b) in paragraph (1) by replacing (i) of the proviso with the following -

"(i) If the contributions (including any lump sum payments) made by the taxpayer in respect of any employee during any year of assessment to such funds exceed an amount equal to ten per centum of the total remuneration of such employee for such year of assessment and the Commissioner is satisfied that the aggregate of such contributions and the total remuneration accrued during such year of assessment to such employee in respect of his employment by the taxpayer is excessive or unjustifiable in relation to the value of the services rendered by such employee, and having regard to other benefits, if any, derived by him from his employment by the taxpayer only so much of such contributions as appears to the Commissioner to be reasonable, but not less than an amount equal to ten per centum of the approved remuneration of such employee for such year of assessment, shall be allowed to be deducted under this paragraph";

(c) in paragraph (u) by adding the following subparagraph immediately after subparagraph (ii) -

"(iii) by way of contributions, grants or donations to any of his employees to assist such employee in further training in his particular professional field at the University College of Swaziland, or at any other approved University or institution for the purpose of securing a recognised qualification".

Amendment of section 29

7. Section 29 of the Order is amended –

- (a) in paragraph (e) by deleting the word "and" at the end of that paragraph;
- (b) in paragraph (f) by replacing the full-stop at the end of that paragraph with a semi-colon and the word "and"; and

(c) by inserting immediately after paragraph (f) the following new paragraph -

"(g) so much of the annual interest received or accrued from deposits in the Swaziland Development and Savings Bank, if such interest is exempt from normal tax under section 12 (1) (q)".

Addition of new section 69 bis

?

8. The Order is amended by adding the following new section immediately after section 69 -

"Commissioner's annual report

69 bis. The Commissioner shall, not later than six months after the end of each financial year, prepare and submit to the Minister, an annual report setting out information relating to the operation of this Order during that financial year and such other information as the Minister may require".

1. These Regulations may be cited as the Fixation of Liquid Milk Prices (Amendment) Regulations, 1979 and shall be read as one with the Fixation of Liquid Milk Prices Regulations, 1979.

Amendment of Regulation 2

2. Regulation 2 of the Fixation of Liquid Milk Prices Regulations, 1979 is amended by replacing "18 cents" with "21 cents".
