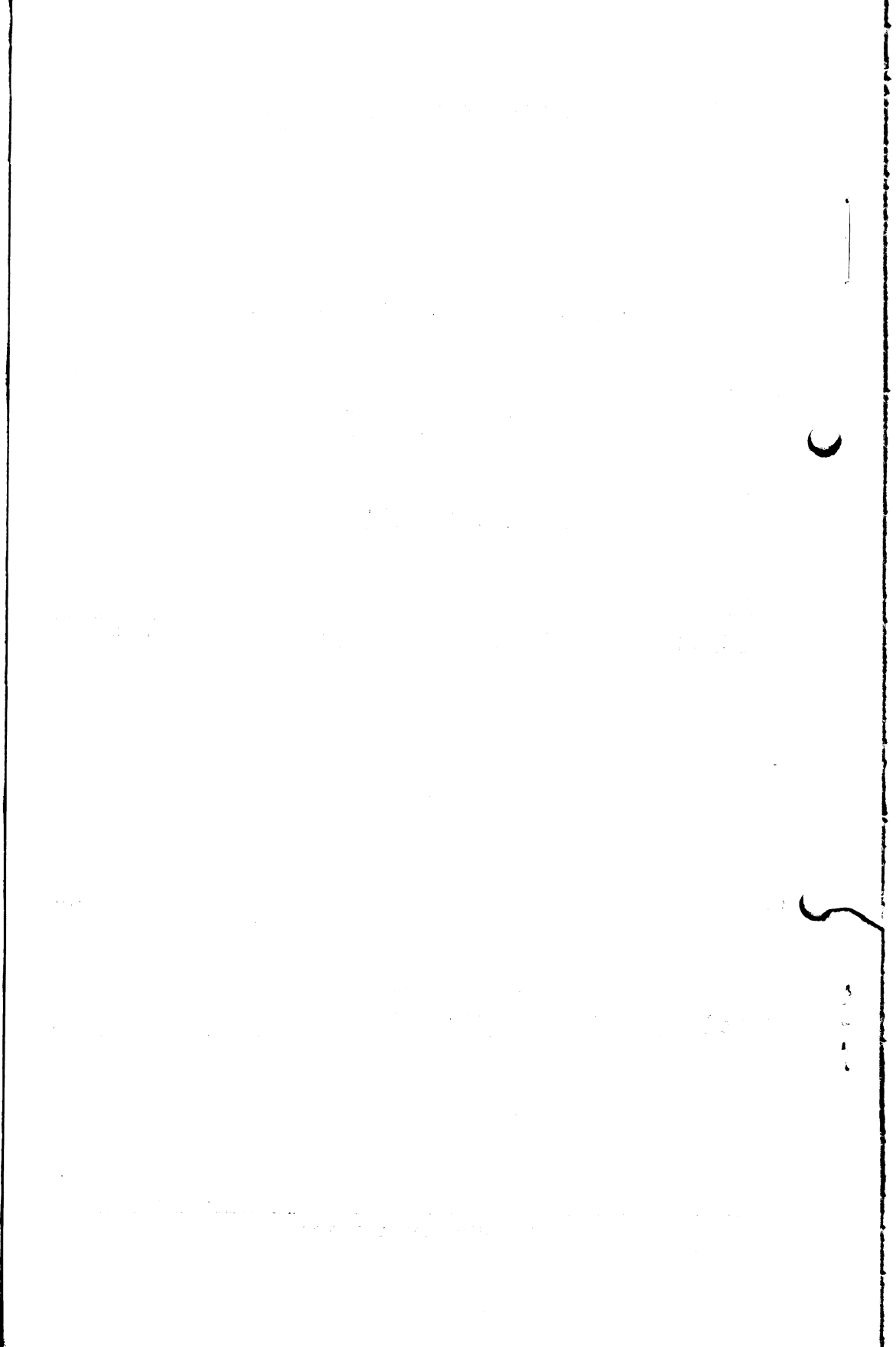

## THE PRICE CONTROL ORDER, 1973

(Order No. 25 of 1973)

THE MAXIMUM WHOLESALE AND RETAIL SELLING  
PRICES OF MATOLA CEMENT NOTICE, 1981

(Under section 5)

In exercise of the powers conferred upon me by section 5 of the Price Control Order, 1973, I hereby issue the following Notice —

*Citation.*

1. This Notice may be cited as the Maximum Wholesale and Retail Selling Prices of Matola Cement Notice, 1981, and shall come into force on the 22nd. June, 1981.

*Maximum prices of Matola Cement.*

2. The maximum wholesale and retail selling prices of Matola Cement shall be as set out in the Schedule hereto.

*Revocation of Legal Notice No. 68 of 1980.*
