## THE DAIRY ACT, 1968

(Act No. 28 of 1968)

## THE PRICES OF COLOURED MARGARINE REGULATIONS, 1984

(Under Section 24)

In exercise of the powers conferred by section 24 of the Dairy Act, 1968 on the recommendations of the Swaziland Dairy Board, the Minister for Agriculture and Co-operatives hereby makes the following Regulations —

*Citation and Commencement.*

1. These Regulations may be cited as the Prices of Coloured Margarine Regulations, 1984 and shall come into force on the 28th September, 1984.

*Maximum Prices of Coloured Margarine.*

2. No person shall sell coloured margarine at prices above the following wholesale and retail prices—

	Wholesale prices per 50 bricks of 250g each	Retail Prices per 250g bricks
All brands of Margarine in bricks	E37,30	E0,83
	Wholesale Prices of 50 tubs of 250g each	Retail Prices 250g tubs
All brands of Margarine in tubs	E41,70	E0,93

3. The Prices of Coloured Margarine Prices Regulations, 1984 are hereby revoked.

LEGAL NOTICE NO. 117 OF 1984

THE DAIRY ACT, 1968

(Act No. 28 of 1968)

THE PRICES OF BUTTER AND CHEESE REGULATIONS 1984

(Under Section 24)

In exercise of the powers conferred by section 24 of the Dairy Act, 1968 and on the recommendation of the Swaziland Dairy Board, the Minister for Agriculture and Co-operatives hereby makes the following Regulations—

*Citation and commencement.*

1. These Regulations may be cited as the Prices of Butter and Cheese Regulations, 1984 and shall come into force on the 28th September, 1984.

*Maximum selling prices of butter.*

2. (1) The Maximum selling price of Grade 1 butter by a producer, processor, manufacturer or importer of butter to a restaurant, hotel, milk shop, dairy or milk purveyor shall be E4,60 per kilogramme.

(2) The maximum selling price of Grade 1 butter to a consumer shall be E5.00 per kilogramme.

*Maximum selling price of cheese.*

3. (1) The maximum selling price of Grade 1 cheese by a producer, processor manufacturer or importer of cheese to a restaurant, hotel, milk shop, dairy or milk purveyor shall be in the case of cheddar cheese E4,84 per kilogramme and in the case of gouda cheese E4,92 per kilogramme.

(2) The maximum selling price of Grade 1 cheese to a consumer shall be E5,20 per kilogramme in the case of cheddar cheese and E5,30 per kilogramme in the case of gouda cheese.

4. The Prices of Butter and Cheese Regulations, 1983 are hereby revoked.
