(Act No. 35 of 1963)

THE COMMISSION OF ENQUIRY INTO ROYAL SWAZI NATIONAL  
AIRWAYS CORPORATION NOTICE, 1986

(Under section 3)

In exercise of the powers conferred by section 3 of the Commissions of Enquiry Act, 1963, I hereby issue the following Notice —

*Citation.*

1. This Notice may be cited as the Commission of Enquiry into the Royal Swazi National Airways Corporation Notice, 1986.

*Appointment of Commission.*

2. (1) There is hereby appointed a Commission to be known as the Commission of Enquiry into the Royal Swazi National Airways Corporation (hereinafter referred to as "the Commission").

(2) The Commission shall consist of the following persons —

*Functions of the Commission.*

3. The Commission shall enquire into and make recommendations of the following matters relating to the Royal Swazi National Airways Corporation —

- The terms and conditions of service of all employees of the Corporation;
- The financial operations of the Corporation since its inception; and
- Any other matters incidental or relevant to the matters set out in paragraphs (a) and (b).

*Venue.*

4. The enquiry shall be held at the Headquarters of the Royal Swazi National Airways Corporation and such other places and at such times as the Commission may determine.

*Quorum.*

5. Four members of the Commission including the Chairman or alternate Chairman shall constitute a quorum for the purpose of any meeting of the Commission.

*Duration of Enquiry.*

6. The Commission shall commence its functions on 6th August, 1986 and submit its final report to the Minister by 31st October, 1986 or on such later date as the Minister may, in writing direct.

*Revocation of Legal Notice No. 58 of 1986.*

7. Legal Notice No. 58 of 1986 is hereby revoked.
