THE MAXIMUM WHOLESALE AND RETAIL SELLING PRICES OF SOFT DRINKS NOTICE, 1988

(Under Section 5)

In exercise of the powers conferred by Section 5 of the Price Control Order, 1973, I hereby issue the following Notice:—

Citation and Commencement.

1. This Notice may be cited as the Maximum Wholesale and Retail Selling Prices of Soft Drinks Notice, 1988 and shall come into force on the 29th July, 1988.

Maximum Prices of Soft Drinks.

2. The maximum wholesale and retail selling prices of soft drinks shall be as set out in the schedules hereto.

Revocation of Legal Notice No. 40 of 1987.

3. The Maximum Wholesale and Retail Selling Prices of Soft Drinks Notice, 1987 is hereby revoked.
