THE AVIATION ACT, 1968

(Act No. 31 of 1968)

THE AVIATION (AMENDMENT) (NO. 2) REGULATIONS, 1990

(Under Section 21)

In exercise of the powers conferred by section 21 of the Aviation Act, 1968 the Minister for Works and Communications hereby makes the following Regulations -

*Citation and commencement.*

1. These Regulations may be cited as the Aviation (Amendment) Regulations, 1990, shall be read as one with the Aviation Regulations, 1969 (hereinafter called "the principal Regulations") and shall come into force on the 1st September, 1990.

*Addition of new regulation 247 bis.*

2. The principal Regulations are amended after regulation 247, by adding the following new regulation -

"247 bis. An application under regulation 247 shall be accompanied by a fee of fifty Emalangeni."

*Amendment of regulation 255 bis.*

3. Regulation 255 bis (2) is amended after the words "shall be" by adding the words "accompanied by a fee of one hundred Emalangeni and".

*Amendment of regulation 258.*

4. Regulation 258 of the principal Regulations is amended -

(a) in subsection (1) by replacing the words "one hundred Emalangeni" with the words "two hundred Emalangeni";

(b) in subsection (2) by replacing the words "forty Emalangeni" with the words "eighty Emalangeni".

*Replacement of regulation 264.*

5. Regulation 264 of the principal Regulations is replaced with the following -

"264 (1). An application for a permit shall contain the information set out in Form No. 8 of Appendix 0 and shall include such other information as the Director may require".

(2) An application under this regulation shall pay a fee of twenty Emalangeni for the issuance of the permit.

*Amendment of Appendix G.*

6. Appendix G of the principal Regulations is amended by adding the following -

"(6) The nature reserve known as MALOLOTTJA NATURE RESERVE. Aircraft may only be flown over this area at a height of less than 2000 feet (600 metres) above ground level with the written permission of the Director."

(7) The nature reserve known as MLAWULA NATURE RESERVE. Aircraft may only be flown over this area at a height of less than 2000 feet (600 metres) above ground level with the written permission of the Director."

*Amendment of Appendix 0.*

7. Appendix 0 of the principal Regulations is amended after Form 7 by adding Form 8 hereto.

*Amendment of Appendix M3.*

8. Appendix M3 of the principal Regulations is amended in paragraph (1) by replacing the words "Five Emalangeni (E5.00)" with the words "Ten Emalangeni (E10.00)".

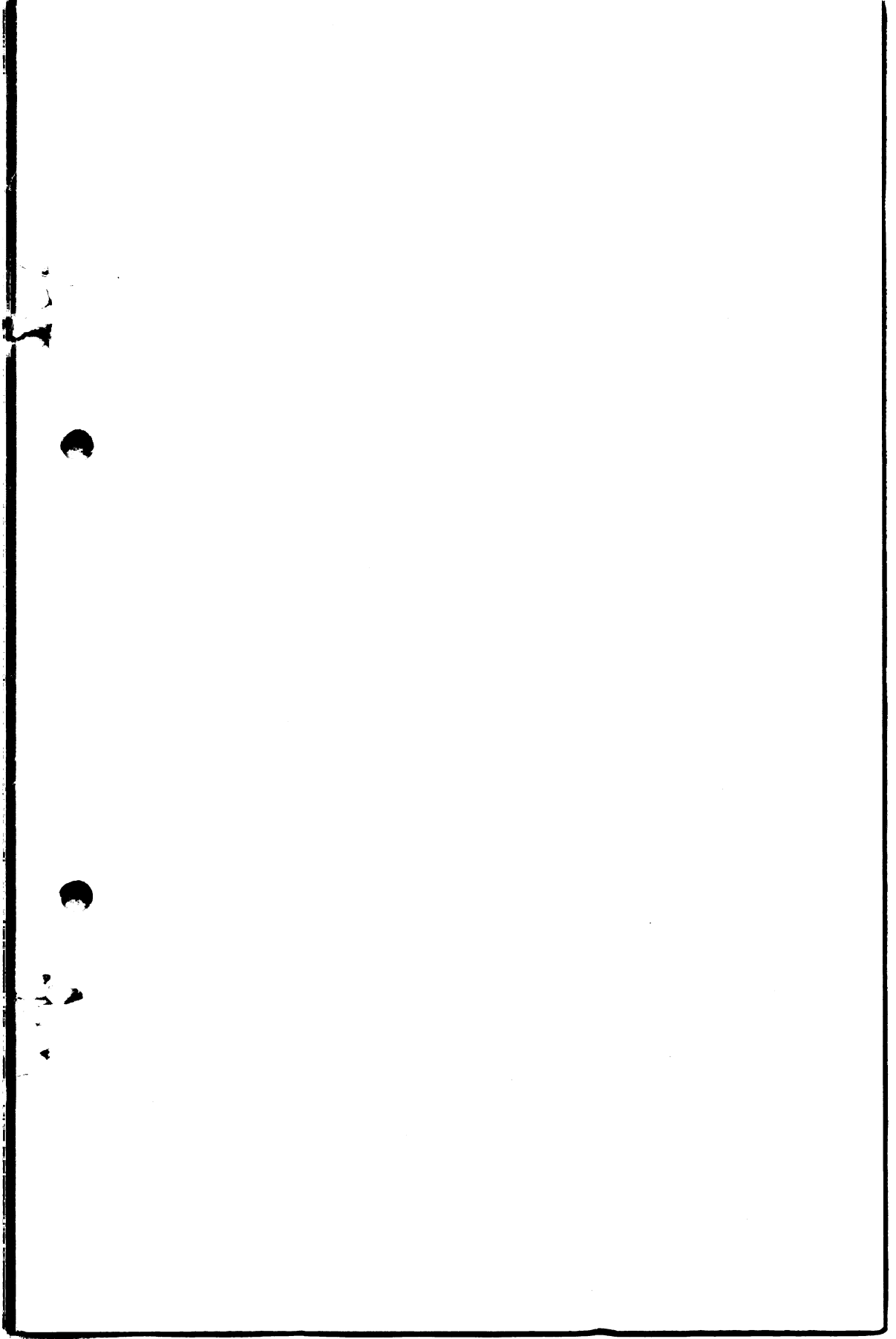
