**THE APPROPRIATION ACT, 1997**

(Act No. 2 of 1997)

**AN ACT**

entitled

**AN ACT to provide for the appropriation of a certain sum of money for the financial year commencing on the 1st. April, 1997 and ending 31st March, 1998.**

**ANACTED by the King and the Parliament of Swaziland.**

*Short title and commencement.*

1. This Act may be cited as the Appropriation Act, 1997 and shall be deemed to have come into force on the 1st. April, 1997.

*Charge to Consolidated Fund.*

2. The Consolidated Fund is charged with the sum of money not exceeding in the aggregate one billion nine hundred and fourteen million and three hundred and fifteen thousand Emalangeni (1,914,315,000) as required for the services of the Government of the Kingdom of Swaziland during the financial year commencing on the 1st. April, 1997 and ending on the 31st March, 1998.

*Application of sum appropriated.*

3. The sum appropriated by section 2 shall be applied to the services set out in the first column of the Schedule and in the respective amounts appearing in the second and third columns in respect of each service.
