In exercise of the powers conferred by Section 28 of the Road Transportation Act, 1963, the Minister for Public Works and Transport makes the following Regulations -

Citation and commencement.

1. These Regulations may be cited as the Maximum Bus and Taxi Fares (Amendment) Regulations, 1997 and shall come into force on 1 August 1997.

Amendment of Legal Notice No. 129 of 1995.

2. The Maximum Bus and Taxi Fares (Amendment) Regulations, 1995 are amended by replacing Schedule A to the Regulations with the following new Schedule A -

 "SCHEDULE A

MAXIMUM BUS FARES

1. The basis for the calculation of maximum fares for the conveyance of passengers by means of a bus shall be as follows:-

(a) a charge for any passenger journey up to 8 kilometres..... E 1.00

(b) for a journey in excess of 8 kilometres, A charge per kilometre of..... E 0.12

2. The fares calculated in terms of paragraph 1(b) shall be rounded up or down to the nearest 5 cents.

3. The fares for journeys of specific distances and for the main bus routes are shown in the following table:

3. The Maximum Bus and Taxi Fares (Amendment) Regulations, 1994, are amended by replacing Schedule B to the Regulations with the following new Schedule B -

"SCHEDULE B

MAXIMUM TAXI FARES

1. The basis for the calculation of maximum fares for the conveyance of passengers by means of a taxi shall be as follows:-

(a) a charge for any passenger journey up to 2 kilometres E 8.00

(b) in addition to the charge referred to in paragraph (a), a charge per kilometre of travel by the passenger(s) in excess of 2 kilometres..... E 1.80

(c) for waiting for a passenger when requested to do so:-

- (i) for a period of less than 5 minutes No Charge
- (ii) for a period of between 5 and 10 minutes E 5.00
- (iii) in addition to the charge referred to in sub-paragraph (ii),
a charge per minute in excess of 10 minutes, of E 1.00
