THE APPOINTMENT OF CROWN COUNSEL ORDER, 2001

LEGAL NOTICE NO. 57 OF 2001

THE INQUEST ACT, 1954
(Act No. 59 of 1954)

SPECIAL APPOINTMENT OF CORONER NOTICE, 2001
(Under section 26)

In exercise of the powers conferred by section 26 of the Inquest Act, 1954, His Excellency, the Honourable Prime Minister issues the following Notice -

Citation and commencement

1. This Notice may be cited as the Special Appointment of Coroner Notice, 2001 and shall be deemed to have come into force on the 17th April, 2001.

Special Appointment of coroner

2. In terms of section 26 of the Inquest Act, 1954 Counsel Selby John Gama, a public officer, is appointed coroner and shall exercise all the powers conferred on a coroner by the Inquest Act, 1954 in respect of the matters, cases or incidents specified under section 3 of this Notice.

Jurisdiction of the coroner

3. The jurisdiction of the Coroner shall extend over all the Regions of Swaziland and the Coroner, so appointed herein, may hold and shall preside over each inquest in respect of the following matters or persons -
