#### Citation and Commencement

1. This Notice may be cited as the Commission of Enquiry to Investigate into the Operations of Swaziland Water Services Corporation Notice, 2005 and shall be deemed to have come into force on the 19th of September 2005.

#### Establishment of the Commission

- 2. (1) There is established a commission of enquiry to be known as the Commission of Enquiry to Investigate into the Operations of the Swaziland Water Services Corporation.
  - (2) The Commission shall consist of the following members:

- (ii) Mr. P. Anderson -
- Member

## Functions of the Commission

- 3. (1) The Commission shall investigate and enquire into the operations of the Swaziland Water Services Corporation in carrying out its mandate, whether or not it has conducted itself in terms of practice, regulations and in terms of the law.
- (2) Without derogating from sub section (1) the Commission shall Investigate and enquire whether there is any impropriate or unlawfulness in:
  - (a) the criteria used when awarding consultancy engagements by the Corporation, were all relevant conditions followed, and if they were, were they adequately followed by all parties concerned;
  - (b) the adherence or non adherence to the purchasing and procurement procedures;
  - (c) the procedure followed in awarding tenders, were all the relevant procedures and all relevant conditions followed, and if they were, were they adequately followed by all concerned parties; and
  - (d) the adherence by the management to sound financial management procedures;
  - (e) the relationship that exist between senior members of the Corporation and its suppliers,

- (3) Whether any supplier of the Corporation bought the Minister for Housing and Urban Development an air ticket to London, and if so, was it procedural or unprocedural.
- (4) The Commission shall determine and make recommendations as to whether there are persons who should be disciplined, surcharged or charged with an offence, any wrong doing or breach of any regulations, rules or practice.
  - (5) The Commission shall make recommendations to the Minister based on its findings.

#### Venue

4. The enquiry shall be held at a place to be determined by the Commissioner.

#### Enquiry in Camera

- 5. (1) The Commission shall be held in camera.
- (2) The Commission shall have all the powers conferred on it by the Commissions of Enquiry Act, 1963.

## Duration of Enquiry

- 6. (1) The duration of the enquiry shall be one (1) month.
- (2) Notwithstanding sub section (1), the Minister may terminate the appointment of the Commission before the period stated in sub section (1) or extend the date in which the Commission is supposed to submit its findings.

## Payment of the Commission

7. The members of the Commission shall be paid such allowances as the Minister may, in consultation with the Minister responsible for Finance determine.

# Functions of the Committee

- 3. (1) The main task of the Committee shall be to identify sources of finance and obtain commitment for a sum of at least E1,000,000,000 (one billion Emalangeni) that can be made available to investors who have proposed bankable projects that will create jobs.
  - (2) In carrying out its main task the Committee shall:
    - (a) investigate and report on the extent to which banks and non-banking financial institutions, including retirement funds, can raise and commit funds for local investment on a private and public / private partnership basis as part of the E1 billion job creation investment;
    - (b) report suggestions and the recommendations made by these financial institutions relevant to the exercise;
    - (c) explore and report on any other possible sources (internal and external) of project financing that can be accessed for local investment;
    - (d) explore and report on the role that government would play to facilitate mobilization and access for viable projects to such finance;

- (e) recommended a sustainable system of raising, coordinating, managing and utilizing such funds;
- (f) propose general guidelines of accessing such finance but investors;
- (g) liaise closely with the Cabinet Sub-Committee on Job Creation summit;
- (h) oversee the work of the Steering Committee;
- report on government finances and financial initiatives intended to facilitate and support local investment;
- make presentations of the findings or update to any forum as directed by the Prime Minister or Cabinet; and
- (k) submit reports on its progress every fortnight and whenever required to the Prime Minister who will in turn report to Cabinet.

#### Term of Office

- 4. (1) The term of office of the Committee continue until the 31st March, 2006.
- (2) The Minister may, by Notice published in the Gazette, extend the term of office of the members of the Committee.

#### Frequency of Meetings

5. The Committee shall meet at least once a week and as often as may be necessary to carry out its functions.

#### Quorum
