In exercise of the powers conferred by Section 3 of the Commissions of Enquiry Act, 1963, the Minister for Enterprise and Employment hereby issues the following Notice.

Citation and Commencement

1. This Notice may be cited as the Appointment of the 2010 FIFA World Cup Technical Committee Notice, 2007 and shall be deemed to have come into force on the 28th June 2006.

Establishment and Composition of the Committee.

2. There is hereby established a Committee to be known as the 2010 FIFA World Cup Technical Committee (hereinafter referred to as "the Committee") which shall be composed of the following persons:

Functions of Committee

3. (1) The main task of the Committee shall be to formulate strategies on how the country can benefit from the 2010 FIFA World Cup and to coordinate, facilitate and market the events of the 2010 FIFA World Cup for the benefit of Government and the Swazi people.

(2) In carrying out its main task the Committee shall:

- (a) explore all economic opportunities in trade, tourism, etc and put in place mechanisms to enhance Swaziland benefits;
- (b) draw up a comprehensive strategic working plan and budget on how best should the country prepare itself to fully benefit from the FIFA 2010 Soccer World Cup event and it shall coordinate all national activities that have a direct or indirect bearing on the 2010 FIFA Soccer World Cup event;
- (c) collaborate with international and national private and public bodies whose activities are related to or are significant for the preparations and implementation of the 2010 FIFA Soccer World Cup event;
- (d) identify and address all elements that could hinder or negatively affect the country from effectively benefiting from the 2010 FIFA Soccer World Cup such as legislation, visas requirements, forex regulations and security restrictions;
- (e) conduct a fact finding mission and a conclusive research on the prospects of the event and establish a working relationship with neighboring states;
- (f) promote and market the country to all potential participators, supporters and beneficiaries of the 2010 FIFA Soccer World Cup event regional and abroad;
- (g) have the right to make public statements on the 2010 project;
- (h) have the power to co-opt additional members (including the private sector) whom it considers very instrumental in ensuring that its mandate is well carried out;
- (i) ensure that by 2008 all facilities required for the 2010 World Cup, event, such as the stadium, are available and meet the requirements expected for such an event;
- (j) submit reports on its progress directly to the 2010 FIFA World Cup Cabinet Sub-Committee every month and whenever called upon to do so by the Cabinet Sub-Committee;
- (k) facilitate and oversee the participation of the national soccer team in the 2010 World Cup event and any other related activities which offer opportunities for the participation of the national team; and
- (l) recruit and supervise the Project Co-ordinator for the 2010 FIFA World Cup event.

Term of Office

4. (1) The term of office of the Committee shall be a period not exceeding three years commencing on the 28th June, 2006.

(2) Notwithstanding sub-section (1), the Minister may terminate the appointment of the Committee before the period stated in sub-section (1) or extend the period of appointment.

Frequency of Meetings

5. The Committee shall meet at least twice a month and, with the approval of the Minister, as often as may be necessary to carry out its functions.

Quorum

6. (1) The Chairperson or Vice-Chairperson and seven (7) and other members, including the Secretary, shall constitute a quorum.

(2) In the absence of the Chairman or Secretary, the Committee may elect one of their Other members to act in those positions.

Allowances

7. The Committee shall be paid such allowances and, where applicable, re-imbursement for traveling expenses as the Minister may, in consultation with the Minister responsible for Finance, determine.
