## THE STOCK DISEASE (AMENDMENT) REGULATION, 2007 (Under Section 3)

In exercise of the powers conferred by Section 3 of the Animal Disease Act, 1965, the Minister for Agriculture hereby makes the following Regulations:

#### Citation

1. These regulations may be cited as the Stock Diseases (Amendment) Regulations No.1 of 2007, shall be read as one with the Animal Diseases Regulations, 1933 and shall come into force on the 25<sup>th</sup> February 2007.
