4. (1) The Task Team shall meet once at least once quarterly at a place and time as the Chairperson may determine.

(2) A special meeting of the Task Team may be convened by the Chairperson within ten days of a written request, as instructed by the responsible.

***Presiding at meetings***

5. (1) The Chairperson shall preside at all meetings of the Task Team where the Chairperson is present and the Deputy Chairperson shall preside in the absence of the Chairperson.

(2) In the absence of the Chairperson and the Deputy Chairperson from a meeting, the members present shall appoint one of their numbers to preside.

***Quorum***

6. A quorum for a meeting of the Task Team is twelve members, provided all stakeholders are represented (Private Sector, Government, and Oil Industry).

***Attendance at meetings by designated members***

7. (1) The Task Team may invite to any of its meetings any person whose advice to the Task Team considers being necessary on any matter to be discussed at the meeting.

(2) A person invited in terms of subsection 7 (1) may participate in the discussion on the matter in connection with which he or she is invited but shall have no right to vote on any matter coming for decision before the meeting.

***Voting***

8. At any meeting of the Task Team, the Chairperson or Deputy Chairperson or other person presiding shall have a deliberative vote, and in the case of an equality of votes shall also have a casting vote.

***Minutes***

9. (1) The Task Team shall cause accurate minutes of the proceedings of the Task Team to be kept in such form as the Task Team may prescribe.

(2) The person presiding at a meeting of the Task Team shall confirm the minutes of a previous meeting and sign such minutes in the presence of other members in attendance of the meeting.

***Resolution without the meeting***

10. The Task Team may make a resolution in writing signed by a majority of the members of the Task Team and such resolution shall be as valid and effectual as if it had been passed at a meeting of the Task Team.

***Disclosure of interest of the members***

11. (1) A member of the Task Team who has a direct or indirect pecuniary interest in a matter being considered or about to be considered by the Task Team shall, as soon as possible after the relevant facts have come to his or her knowledge, disclose the nature of the interest at a meeting of the Task Team.

(2) A disclosure under subsection 11 (1) shall be recorded in the minutes of the meeting of the Task Team and the member shall not, unless the Task Team otherwise determines -

- (a) Be present during any deliberation on the matter by the Task Team; or

- (b) Take part in the consideration and decision of the Task Team on any question relating to such matter.

***Allowances and Reimbursements***

12. The members of the Task Team shall be entitled to sitting allowances and, where applicable, reimbursement for travelling expenses in accordance with the Finance Circular No. 2 of 2005.

***Duration***

13. The Minister may, by Notice published in the Gazette, extend the time of the duration of the Task Team.
