***Declaration of Siteki Market Place***

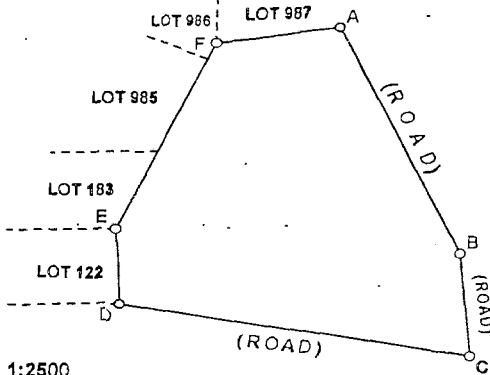
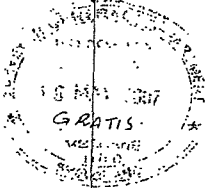
