APPOINTMENT OF A LOCAL AUTHORITY FOR A CONTROLLED
AREA (MHOBODLENI) (AMENDMENT), NOTICE, 2012

In exercise of the powers conferred by Section 2 of the Building Act, 1968, the Minister for Housing and Urban Development issues the following notice-

Citation and Commencement

1. (1) This Notice may be cited as the Appointment of a Local Authority for a Controlled Area (Mhobodleni) (Amendment) Notice, 2012 and shall be read as one with Legal Notices No. 29 of 2007 and No. 135 of 2009.

(2) This Notice shall be deemed to have come into force on 1st November, 2011.

Amendment of Section 2

2. Legal Notice No. 29 of 2007 is amended in Section 2 by deleting the name "Mr Paul Nkambule" and replacing it with the name "Mr Clifford S. Mamba".
