(f) Provide advice to the Minister for Commerce, Industry and Trade on any issue pertaining to the allocation and sale of properties at the Ngwenya Village.

(2) The committee may establish, co-opt or enter into an agency agreement with any person or institution for the proper execution of its functions and mandate.

(3) In the execution of its functions the committee shall have the power to administer oaths and to subpoena any person to give evidence.

(4) The Committee shall have the power to formulate its own procedures for the proper execution of its functions.

Term of office

4. The term of office of the Committee shall be for a period up to 31 December 2014.

Allowances

5. The Committee shall be entitled to sitting allowances and re-imburement for travelling costs at the rate stated in Finance Circular No. 2 of 2005 and as may be provided in relevant subsequent other circulars issued from time to time. Payment of the allowances shall be made from the proceeds of the sale process.

Quorum

6. The chairperson and three members shall constitute a quorum.

Submission of Reports

7. The Committee shall submit a report on its activities to the Minister half-yearly and annually to Cabinet.

Extension of term of appointment

8. The Minister may, by Notice published in the Gazette, extend the period stated in Section 4.

Citation and Commencement

1. This Notice may be cited as the Appointment of the Ngwenya Village Allocations and Sale of Houses and Other Properties Committee Notice, 2012, and shall be deemed to have come into force on the 11th May, 2010.

Establishment and composition of Committee

2. There is hereby established a Committee to be known as the Ngwenya Village Allocations and Sale of Houses and Other Properties Committee (hereinafter referred to as the "Committee"), which shall comprise of the following persons -

Functions of the Committee

3. (1) The Committee shall perform the following functions -
- Receive and scrutinize applications for the allocation of residential Houses and immovable commercial properties at Ngwenya.
 - Decide on the applications for purposes of making offers where appropriate, for sale of houses and Commercial properties at Ngwenya;
 - Establish a process for the resolution of conflicts or contested claims for allocation of houses;
 - Decide on the conditions for the allocation and sale of properties at Ngwenya Village;
 - Prepare and submit a report including financial statements of the sale process to the Minister for Commerce, Industry and Trade; and
